Sub: Continuation of the Scheme for granting Handling Agency <u>License for rendering Shore Handling Services at HDC.</u>

This has reference to this office Trade Circular vide No. MTO/G/104/Pt.X/53 dated 08.01.2019 (copy enclosed) where the extension of validity of the Handling Agency License was extended up to 30.06.2019.

The Competent Authority of KoPT has approved extension of validity of Handling Agency License w.e.f. 01.07.2019 as per the existing Terms & Condition for a period of 3 months or till the issuance of fresh License under the new Regulations whichever is earlier. For undertaking Shore Handling operation of dry bulk cargo, the ceiling rates fixed by TAMP (notified on 26.02.2018) would be applicable. The Handling Agents whose License has been extended will be required to pay royalty to KoPT @ 12.36% of the Ceiling Tariff fixed by TAMP.

Sub: Continuation of the Scheme for granting Handling Agency License for rendering Shore Handling Services at HDC.

This has reference to this office's Trade Circular vide No. MTO/G/115i/Pt.IX/2284A dated 12.07.2018 (copy enclosed).

The Competent Authority of KoPT has approved extension of validity of Handling Agency License w.e.f. 01.01.2019 as per the existing Terms & Condition for a period of 6 months or till the issuance of fresh License under the new Regulations whichever is earlier. For undertaking Shore Handling operation of dry bulk cargo, the ceiling rates fixed by TAMP (notified on 26.02.2018) would be applicable. The Handling Agents whose License has been extended will be required to pay royalty to KoPT @ 12.36% of the Ceiling Tariff fixed by TAMP.
