## NOTICE

There is a forecast of an extreme severe cyclonic storm "AMPHAN" to pass over the coastal areas of West Bengal at around 8 P.M. on 20.05.2020 with high wind speed. In order to protect men, machineries and Port properties from the cyclonic storm, it is hereby advised to all MHC Operators, Berth Operators, Handling agents, Tank operators, Contractors and all other stakeholders to secure their equipment/machineries well before arrival of the storm. All the Importers and Exporters are advised to cover up their cargo with tarpaulin and secure the same with sandbags.

As per present indication, the condition of the weather is likely to deteriorate from 06:00 Hrs. on 20.05.2020 and is expected to remain turbulent till 06:00 Hrs. on 21.05.2020. During this aforesaid period, the following activities must be strictly ensured:

- All cargo operations in the Dock as well as in the Oil Jetties to be kept suspended from 22:00 hrs. on 19.05.2020 till 06:00 hrs. on 21.05.2020.
- The lashing / securing of equipment such as RMQCs, RTYGCs, RSTs, Ship Loaders, Ship Unloaders, Payloaders, Bulldozers, Excavators, Trailers, Dumpers, etc. to be undertaken from 22:00 hrs. on 19.05.2020 and completed by 06:00 Hrs. on 20.05.2020.
- No personnel to be allowed to remain outdoors.
- All the gates of the Dock (excepting Main Gate, CJP Gate and HFTPL Gate) shall be kept closed.
- Entry / Exit of personnel and vehicles will not be allowed to / from the Dock except for emergency purposes.
- · All Permit Offices shall be kept closed.
- The C&F Agents or Transporters must take out their cargo carrying vehicles out of the Dock by 06:00 Hrs. on 20.05.2020.

Note: The above timings are tentative and final timings shall be intimated later on.

Control Rooms shall be set up at Jawahar Tower with telephone nos. 03224-263289 and at Marine Office with telephone nos. 03224-252421. Any untoward incident to be reported immediately at any of the Control Rooms.
