## **Trade Circular**

## Sub: Relaxation in compulsory weighment of dry bulk cargo during delivery

In terms of the Trade Circular No. TO(Sh&CH)/10/3850 dated 18.11.2019, it was informed to all Importers of dry bulk cargo as well as to all associated agencies at HDC that from 01.12.2019 onwards there will be compulsory weighment of vehicles carrying Import Dry Bulk Cargo while taking delivery from Dock, except for direct delivery from the hook point of the vessel and for cargo on account of local Industries located in and around Haldia.

Subsequently, as per the approval of the Appropriate Authority a fresh circular bearing no. TO(Sh&CH)/10/19 dated 02.01.2020 was published wherein cargo on account of local industries namely IVL Dhunseri Petrochemical Industries Ltd., Electrosteel Casting Ltd, Petro Carbon and Chemicals Pvt. Ltd., IRC Agrochemicals Pvt. Ltd. and the Ramco Cement Ltd. and cargo likes fertilizer and cement clinker were kept out of the ambit of compulsory weighment at the time of delivery from dock.

Pursuant to further approval of competent authority, it is hereby intimated that the following clean cargo like Soda Ash, Sand, Salt, Gypsum, Dolomite, Lime Stone, Pyroxenite and similar cargo are exempted from compulsory weighment at the time of delivery from Dock. However, the exemption for weighment, previously granted to black cargo like coal etc. moved by local industries like IVL Dhunseri Petrochemical Industries Ltd., Electrosteel Casting Ltd. is being withdrawn with immediate effect. Henceforth, all such black cargo to be compulsorily weighed before delivery from dock.

Besides the above, there will be compulsory weighment to all other dry bulk cargo which will be guided by the Trade Circular No. TO(Sh&CH)/10/3850 dated 18.11.2019.
