TRADE CIRCULAR

Sub: Continuation of the Scheme for granting rebate for vessel as well as Cargo Related Charges for handling Dry Bulk Cargo at HDC.

This has reference to the Trade Circular no. TO(Sh&CH)/10/1415 dated 12.06.2020 wherein various rebates for vessel as well as cargo related charges for foreign dry bulk cargo, introduced w.e.f. 01.11.2019, was extended upto 30.09.2020 or till implementation of the new SoR, whichever is earlier. Incidentally, the new SoR has been implemented w.e.f. 17.08.2020.

In view of the extraordinary pandemic situation and upon considering the difficulties faced by the Trade, the rebate on Vessel Related Charges and Cargo Related Charges has been approved for extension by the Appropriate Authority of SMP, Kolkata from 17.08.2020 till 31.03.2021, in the manner as shown below :-

- 1. Rebate on vessel related charges on Dry Bulk Vessels:
 - i) Vessels above 50,000 GRT carrying full load and discharging entire cargo at Sandheads or any other Anchorage Point of SMP, Kolkata.
 - (a) 50% rebate on Port Dues as per S.25 of revised SoR.
 - (b) 50% rebate on Towage and Pilotage charge shall be applicable in place of 25% rebate in the rate as specified in S.24.2 of the revised SoR.
 - ii) Vessels upto 50,000 GRT carrying full load and discharging partly at Sandheads and/or any other Anchorage point of SMP, Kolkata and balance cargo in the Impounded Dock of HDC.
 - (a) 50% rebate on Port dues as per S.25 of revised SOR. Both KDS and HDC will realize 25% of Port dues each.
- 2. Rebate on cargo related charges at Haldia Dock Complex :
 - i) 50% rebate on Onboard Charges (as per S.5.1 of revised SoR)
- 3. Rebate on Railway related charges at Haldia Dock Complex :
 - i) 25% rebate on Railway Haulage Charges.

Note: The vessels arriving straight to SMP, Kolkata from load port without lightening at any other port has been considered as fully laden vessel.

All concerned are requested to be guided accordingly.
