## **Trade Circular**

**Sub:** Restricting stowage of cargo into four/five hatches during the period of maintenance dry docking of Floating Cranes.

As per statutory IRS mandate, floating cranes on account of M/s Ripley Offshore Pvt. Ltd. and M/s Sarat Chatterjee & Co. (Visakhapatnam) Pvt. Ltd. shall undergo periodical maintenance. It may be noted that the floating crane on account of M/s Ripley Offshore Pvt. Ltd. shall proceed for dry docking tentatively after 15.04.2022 and thus shall be unavailable for deployment for lighterage operations for a period of 45 days. The exact date from which the floating crane shall be unavailable for cargo operations shall be intimated later.

During the period of non-availability of the floating crane on account of M/s Ripley Offshore Pvt. Ltd., the floating crane on account of M/s Sarat Chatterjee & Co. (Visakhapatnam) Pvt. Ltd. shall be available for deployment for lighterage operations.

The floating crane on account of M/s Sarat Chatterjee & Co. (Visakhapatnam) Pvt. Ltd. shall also proceed for dry docking after re-commissioning of the floating crane of M/s Ripley Offshore Pvt. Ltd.

In perspective of the above, all concerned are hereby requested to plan their vessels in such a manner that the vessels reporting at HDC, SMP Kolkata Anchorage points shall preferably have their cargo stowage restricted to four/five hatches to facilitate lighterage operation through single floating crane during period of non-availability due to dry docking.

This is for favour of information and necessary action please.
