TRADE CIRCULAR

Sub: Maintenance dry docking of Floating Crane Jal Mahal deployed on account of M/s Sarat Chatterjee & Co. (Visakhapatnam) Pvt. Ltd. at HDC, SMPK.

Ref: Trade Circular No. TO(Sh&CH)/10/466 dated 02.04.2022

Reference above, it may please be noted that the Floating Crane Jal Mahal shall be available for cargo operations at deep drafted locations of Sagar Anchorage till midnight of 15th August, 2022. Thereafter, Floating Crane Jal Mahal shall proceed for maintenance dry docking at Kolkata from 16.08.2022 and thus shall be unavailable for deployment for lighterage operations for a period of 30 to 45 days.

During the afore-mentioned period of non-availability of the floating crane Jal Mahal, the floating crane MB-22A on account M/s Ripley Offshore Pvt. Ltd shall be the only floating crane available for deployment and undertaking of lighterage operations.

In perspective of the above, all concerned are hereby requested to plan their vessels in such a manner that the vessels reporting at HDC, SMP Kolkata Anchorage points shall preferably have their cargo stowage restricted to four/five hatches to facilitate lighterage operation through single floating crane during period of non-availability due to dry docking.
