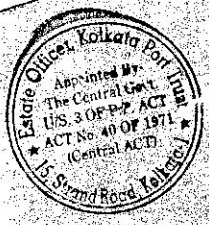
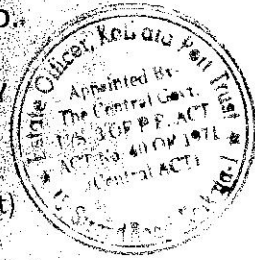

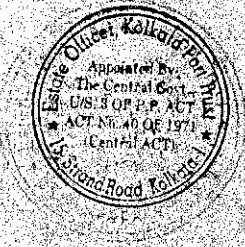
**ORDER UNDER SUB-SECTION (1) OF SECTION 5 OF THE PUBLIC
PREMISES (EVICTION OF UNAUTHORISED OCCUPANTS) ACT, 1971**

WHEREAS I, the undersigned, am satisfied, for the reasons recorded below that Shri Manik and his family members, Quarters No. : 31 & 32 at Block No. : D, at Taratala New Colony Majdoor Lines, P.S. Taratala, Kolkata - 700 088 is in unauthorized occupation of the Public Premises specified in the Schedule below:

REASONS

- i) That you have failed to file reply to the Show Cause Notice u/s 4 of the Act inspite of repeated chances.
- ii) That you have failed to bear any witness or adduce any evidence in support of his occupation as "Authorized Occupation" inspite of opportunities.
- iii) That nothing has been shown in support of your occupation as "authorised occupation".
- iv) That you are occupying the Public Premises without having any authority under law.
- v) That your occupation is unauthorized in all respect and you have failed to make out any case in support of your occupation.

NOW, THEREFORE, in exercise of the powers conferred on me under Sub-Section (1) of Section 5 of the Public Premises (Eviction of Unauthorized Occupants) Act, 1971, I hereby order the said that **Shri Manik and his family members, Quarters No. : 31 & 32 at Block No. : D, at Taratala New Colony Majdoor Lines, P.S. Taratala, Kolkata – 700 088** and all persons who may be in occupation of the said premises or any part thereof to vacate the said premises within 15 days of the date of publication of this order. In the event of refusal or failure to comply with this order **Shri Manik and his family members, Quarters No. : 31 & 32 at Block No. : D, at Taratala New Colony Majdoor Lines, P.S. Taratala, Kolkata – 700 088** and all other persons concerned are liable to be evicted from the said premises, if need be, by the use of such force as may be necessary.



FINAL ORDER



It seen that son of O.P. last appeared on
08.02.2019 and prayed for time to surrender the
subject quarter on or before 22.03.2019 to the
competent authority of KoPT. But O.P. not only
failed to appear before this Forum but also failed
to honour his commitment to surrender the
subject quarter to the officials of KoPT. As such,
I have nothing to disbelieve the statement made
against O.P. by the Port Authority. In fact, I am
left with no other alternative but to issue order of
eviction as prayed for on behalf of the Port
Authority on the following grounds/reasons.

1. That nothing has been shown in support
of O.P's occupation into the public
premises.
2. That no evidence has been laid to
support the possession of O.P. as
"authorized possession/occupation".
3. That mere occupation into the quarters
for a certain period without any authority
for such occupation cannot create any
right over the property in question.

4. That O.P. has failed to hand over clear vacant and unencumbered possession of the subject quarter

ACCORDINGLY, Department is directed to draw up formal order of eviction u/s. 5 of the Act and Rules made thereunder against O.P., giving 15 days time to all to vacate the public premises. I make it clear that all the occupants of the quarters in question whoever may be in occupation are liable to be evicted by this order and KoPT is entitled to claim damages for unauthorized use and occupation of the public premises upto the date of recovery of possession in accordance with law. All concerned are directed to act accordingly.
