Trade Circular

The following Policy decisions have been taken at Kolkata Dock with respect to Nepal Trade:

- 1. All Import, Nepal bound Road containers will be allowed Direct Port Delivery. The DPD policy is amended accordingly. Nepal Containers will not be removed to CFS henceforth except for Hazardous-I cargo.
- 2. All Import, Nepal bound Road containers shall enjoy fifteen (15) days rent free time from the Last Landing Date with effect from 10.08.2019. All Import, Nepal bound Rail containers shall enjoy twenty (20) days rent free time from the Last Landing Date. Demurrage after free time shall start from initial slab applicable as per S. 15.1 of the Scale of Rates (SoR) reproduced below.
 - i) For normal Road borne Load Import Container-

- 3. Copy of the Port generated Tax Invoice / Container Bill will be given to Nepalese Importers along with Shipping Lines, to indicate the actual charges that the Port is taking for their respective consignments.
- 4. Nepal Importers and CHA are allowed to take plot/Shed on license at Kolkata Dock for 11 months at a single rate without escalations against a minimum guaranteed tonnage of 45000 T per 1000 sq.m. Shed No. 28 and 29 of KPD II are to be earmarked for Nepal fertilizers and Food Grains for next 3 months.
- 5. Dedicated Nepal Cell for Processing, redressal of grievance and special assistance to Top Importers of Nepal is operational at Kolkata Dock. Nepal Cell shall track all the containers of Top Importers on day to day basis and monitor the dwell times. The Cell shall coordinate with Lines, CHA, and Importers and analyse the reasons for detention and expedite delivery.
