CIRCULAR

Sub: **Removal of import load containers to CFS from HDC.**

This has reference to earlier Circulars on the subject bearing nos. MTO/G/11/Pt. VII/549 dated 20.02.2013 and MTO/G/11/Pt.VII/754 dated 15.03.2013.

The aforesaid trade circulars, inter-alia, had a clause to review the policy of removal of import load containers to CFS after three months.


KoPT in the meanwhile had received representations from port users to review the said circular and accordingly the same has been reviewed by the appropriate authority of KoPT. It has been decided that the importers will now have their option of taking delivery of their import load containers from HDC directly after observing the required Customs formalities as was being done prior to aforesaid circulars.

Containers carrying scrap materials however will have to be removed to CFS as per the requirement for examination by Customs.

Loading of containers for delivery from hook-point to importers/ MLOs will not be permitted excluding the containers carrying Hazardous-I cargo.

This circular will take immediate effect.

All concerned are advised to be guided accordingly.
