### CIRCULAR

In order to deal with the ongoing congestion of vessels carrying dry bulk cargo, it has been decided that the following modified priority norms for calling vessels at Haldia shall be extended and remain in effect till 31.03.2015.

1. Gearless vessels carrying Coking Coal, Non-Coking Coal, Other types of coal will enjoy priority at par with the Strategic Plan vessels after waiting for 72 hours from the time of readiness / arrival at Sandheads which ever is later for calling at Berth No. 4B / 13 (subject to availability of MHC).
2. Other gearless vessels will be at par with Strategic Plan vessels after waiting for 144 Hrs (6 days) from the time of readiness / arrival at Sandheads which ever is later for calling at Berth No. 4B / 13 (subject to availability of MHC).
3. Geared ships carrying Coking Coal, Non-Coking Coal, Other types of Coal will be at par with Strategic Plan vessels after waiting for 96 Hrs from the time of arrival at Sandheads / readiness which ever is later.

However, geared ships carrying Coking Coal, Non-Coking Coal, Other types of Coal will not supersede any gearless vessel carrying Coking Coal, Non-Coking Coal, Other types of Coal by way of the aforesaid upgradations for calling at berth no 4B and 13 (subject to availability of MHC).

4. Geared vessels carrying other dry bulk cargo after waiting for 192 Hrs from the time of readiness / arrival at sandheads which ever is later will be upgraded at par with vessels under Strategic Plan.

For the aforesaid upgradations to provide higher calling priority necessary priority / ousting priority charges will be applicable as per the existing norms.

### **CIRCULAR**

Tariff Authority for Major Ports vide Notification No. G. No. 349 New Delhi, dated 4th December, 2014 (Published in Part-III Section 4 of the Gazette of India, Extraordinary) has fixed a tariff for the floating pipeline handling facilities for unloading edible oil from vessels berthed at Berth No. 5/5 off & 6/6 off of Haldia Dock Complex.

This Tariff has been fixed as per clause 7.2 of the Tariff guidelines of 2005 issued by TAMP which is a ceiling tariff to be applied commonly at the facility without reference to individual service provider.

It is accordingly, notified to all concerned that the tariff as notified by TAMP vide Notification No. G. No. 349 New Delhi dated 04.12.2014 (Published in Part-III Section 4 of the Gazette of India, Extraordinary) will be applicable to all the users of the Floating Pipeline Facilities for handling liquid cargo at Berth No. 5/5 off & 6/6 off of Haldia Dock Complex. This will come into effect on expiry of 30 days from the date of notification of the order in the Gazette of India and shall remain in force for a period of 3 years.
