## 6. PERFORMANCE HIGHLIGHTS

### A. Cargo Traffic

- During April 2015, Kolkata Port handled 3.842 million tonnes(mt) of traffic (KDS-1.133 mt, HDC- 2.709 mt) against 3.367 mt (KDS-1.119 mt, HDC- 2.248 mt) handled during April 2014, i.e. a commendable rise of 0.475 mt (14.11%) vis-a-vis 1.06% growth registered by Indian Major Ports during the same period.
- **KoPT registered growth during April 2015** vis-a-vis April 2014 in respect of quite a number of commodities i.e. POL (Product), LPG, Vegetable Oil, Other Liquid Cargo, Manganese Ore, Thermal Coal, Coking Coal, Other Coal/Coke, Iron & Steel, Other General Cargo, IVW/IWAI Traffic and Container Tonnage.
- **Growth was registered at KDS during April 2015** in comparison to April 2014 for Vegetable Oil, Manganese Ore, Petroleum Coke, Other Coal/Coke, Iron & Steel, Other General Cargo, IVW Traffic and Container (both Tonnage and TEUs).
- **At HDC, traffic increased in April 2015** vis-à-vis April 2014 primarily for POL (Product), LPG, Vegetable Oil, Other Liquid Cargo, Manganese Ore, Thermal Coal, Coking Coal, Other Coal/Coke and Iron & Steel.

### B. Container Traffic

- Kolkata Port handled 44,627 TEUs in April 2015. KDS handled 38,000 TEUs in Apr'15 against 36,503 TEUs in Apr'14 registering 4.10% growth.

### C. Comparative Performance

- KoPT ranked **Third** in Coking Coal handling in Apr'15 vis-a-vis Apr'14 among Major Ports.

### D. Ship Traffic

- In April 2015, KoPT handled 292 ships - the highest among Indian Major Ports.

### E. Railway Traffic

- **During Apr'15, KoPT handled rail-borne traffic of 2.14 mt** (KDS – 0.37 mt, HDC – 1.77 mt) against 1.96 mt (KDS-0.46 mt, HDC-1.50 mt) in Apr'14 **i.e. a rise of 0.18 mt (9.18%)**.
- At KDS, number of **trains received** and **despatched** in Apr'15 was **104** and **89**, respectively and at HDC, **387 trains** were received and **388 trains** were despatched in Apr'15.
