CIRCULAR

Ref: Circular No. MTO/G/11/Pt.VII/549 dated 20.02.2013

A circular regarding removal of import loaded containers from Haldia Dock Complex premises to off dock CFSs was issued vide No. MTO/G/11/Pt.VII/549 dated February 20, 2013 for information and necessary action of all concerned.


In connection with the said circular the list of importers who have mobilised cargo in containers of volume 1,000 teus or more through Haldia Dock Complex during the Financial Year 2011-12 is furnished as Annexure-I.

Apart from the arrangement notified through the aforesaid circular, it is further notified for information of all concerned that to facilitate efficiency of the container vessels at Haldia Dock Complex, direct delivery of containers (both load & empty) from hook points shall not be allowed henceforth with immediate effect. This was also discussed in the meeting held with the trade in Kolkata on 14.02.2013.

Similarly, it is further notified that containers meant for CFS removal as per aforesaid circular dated 20.02.2013 should preferably be removed from the dock to the concerned CFS within 3 (three) days of landing from the ship.

All the concerned Steamer Agents, Importers, MLOs, Container Handling Agents, C&F Agents, CFSs and other agencies involved in container handling operations at Haldia Dock Complex are hereby advised to ensure strict compliance of the aforesaid system and ensure necessary actions and arrangement accordingly so as to ensure smooth container handling operations at this port.
