- (c) As usual, Sale Gate Pass shall have to bear Customs Delivery Order from Custom House, Kolkata.
- (d) Delivery of cargo shall be allowed only on recovery of all applicable KoPT charges.
- (e) In case during delivery, the weight of lots sold on weight basis exceeds the estimated weight mentioned in the sale catalogue, the buyer/authorised representative shall submit application mentioning the estimated excess quantity through the concerned Shed/Sectional Officer who will confirm availability of the excess cargo under the particular lot No. The buyer will then submit the same along with updated Sale Gate Pass to the Sale Office for payment of excess sale price. Physical delivery of additional cargo shall be allowed only on recovery of sale price on the excess quantity and other charges applicable.
- (f) All papers including Sale Gate Pass, Cart Tickets (duly filled in and signed), weighment certificates along with a certificate as to the completion of delivery clearly mentioning whether any quantity is left or not (in case of cargo sold on weight basis), should be sent back to the Sale Office immediately on completion of delivery.
