The matter is taken up today for final disposal. Factual matrix involved in this matter is required to be put forward in a nutshell in order to link up the chain of events leading to this Proceedings. It is the case of Syama Prasad Mookerjee Port, Kolkata (Erstwhile Kolkata Port Trust/KoPT), hereinafter referred to as SMPK, the applicant herein, that Port property being land measuring about 18.581 sq.m at Nimtolla, on the north side of Jorabagan Cross Road, Kokata, comprised under occupation No. SB-230/A, was allotted to Smt. Jyostna Rani Paul(since deceased) and Arati Rani Kundu, O.P. herein, on monthly lease basis with certain terms and conditions and O.P. violated the fundamental condition of grant of such tenancy by way of not making payment of rental dues, taxes and interest for a prolonged period. It is also submitted by SMPK that O.P. made unauthorized constructions in the public premises in question and also parted with possession of said property without any approval of the SMPK. It is argued on behalf of SMPK that the O.P. has no authority under law to occupy the public premises after expiry of the period as mentioned in the notice to quit dated 25.04.2005 and the O.P. is liable to pay damages for wrongful use and occupation of the Port property upto the date of handing over of vacant possession of the same.

This Forum issued Show Cause notices under Section 4 & 7 of the Act (for adjudication of the prayer for issuance of Order of Eviction, recovery of rental dues, Damages etc.) all dated 31.07.2017(vide Order No.8 dated 07.06.2017).

It is seen from record that the letter sent through registered post containing the Notice/s as aforesaid was returned by the Postal Department undelivered, with the endorsement "deceased". Even the Process Server could not serve the Notice/s upon the O.P. as O.P. was not found in the premises. However, due affixation was made as per the mandate of P.P Act.

As none appeared on behalf of O.P or any other person interested in the property inspite of repeated chances, a publication was made in the classified column of Telegraph' on 21.06.2017 fixing the ultimate date of O P's appearance on 12.07.2017. Thereafter due to superannuation of Erstwhile Estate Officer, the matter was placed before the undersigned on 15.09.2022. Record revealed that as per the direction of the Forum order dated 29.09.2022 was served upon the O.P both by Speed Post and hand delivery and one Joy Gopal Kundu, claiming himself to be the son of Arti Ran Kundu, appeared before the Forum and filed his letter of authorization to contest the instant matter. > representative of O.P has appeared before the Forum and filed several applications through their Ld. Advocate on various dates but no reply to the Show Cause Notice/s was filed by O.P. It is also seen that as per the direction of the Forum opportunity was given to O.P. to liquidate the dues(as per eagerness expressed by O.P from time to time) and O.P through his Ld. Advocate made some sporadic payments from time to time albeit irregularly and inconsistently. Finally the matter was heard on 20.04.2023 when Advocate of O.P filed an application inter-alia praying for the withdrawal of the instant Proceedings without complying the order of payment passed by this Forum, this Forum, finding no reason to keep the matter alive, proceeded to reserve the final order.

I have carefully considered the rival submissions of the parties and materials on record. Admittedly, O.P. was a monthly lessee under the SMPK. Regarding unauthorised construction, it is seen that the O.P. vide its applications as filed on several dates has never submitted that the allegation of unauthorised construction is false. Similarly, O.P. has not denied the allegation of unauthorised parting with possession of the Port Property as well. Moreover, in their communications dated 02.02.2023 and 02.03.2023, praying reduction of rent and other charges on the ground of financial distress, OP has in fact, admitted their dues. Further, the Statement of Accounts produced by a statutory authority like SMPK has definite evidentiary value which cannot be ignored by this Forum. Under such circumstances, I find no reason to grant any relief to the O.P., within the four corner of the P.P. Act, 1971. In my view, the occupation of the O.P. squarely attracts the provision of Sec. 2 (g) of the Act and the same is very much an "unauthorised" occupation in all sense of law. As such, I conclude that the breaches as complained of by SMPK, are very much admitted/established in the facts and circumstances of the case and I hold that the Notice to Quit dated 25.04.2005 as served by SMPK on O.P. is valid, lawful and enforceable in law.

NOW THEREFORE, I consider it is a fit case for allowing SMPK's prayer for eviction against O.P. u/s 5 of the Act for the following grounds/reasons:

- 1. That O.P. has failed to liquidate the rental dues of the Port Authority, for a considerable period, in violation of the contract between the parties.

Likewise, I find that SMPK has made out an arguable claim against O.P., founded with sound reasoning, regarding the damages/compensation to be paid for unauthorised occupation. I make it clear that SMPK is entitled to claim damages against O.P. for unauthorized use and occupation of the public premises right up to the date of recovery of clear, vacant and unencumbered possession of the same in accordance with Law, and as such the liability of O.P. to pay damages extends beyond 31.05.2017 as well, till such time the possession of the premises continues to be under the unauthorised occupation with the O.P.. SMPK is directed to submit a statement comprising details of its calculation of damages after 31.05.2017, indicating there-in, the details of the rate of such charges, and the period of the damages (i.e. till the date of taking over of possession) together with the basis on which such charges are claimed against O.P., for my consideration for the purpose of assessment of such damages as per Rule made under the Act.

I make it clear that in the event of failure on the part of O.P. to comply with this Order, Port Authority is entitled to proceed further for execution of this order in accordance with law. All concerned are directed to act accordingly.
