TRADE CIRCULAR

Sub: Concession for Shipment of Stone Chips, Stone, Stone Aggregates, and Boulders to Bangladesh from KDS.

To facilitate and attract export of Stone Chips, Stone, Stone Aggregates, and Boulders to Bangladesh and increase the cargo volume through Kolkata Dock System, the following rebates on Cargo Related Charges for Stone Chips, Stone, Stone Aggregates, and Boulders exported through the Docks of KDS to Bangladesh has been approved by the Appropriate Authority.

1. Rebate on Wharfage

Rebate on wharfage will be applicable for Stone Chips, Stone, Stone Aggregates, and Boulders exported to Bangladesh from KDS on the basis of volume discount on each of the cargo and will be as per the following table –

Tonnage Handled in 1 year	Rebate on Wharfage
Upto 75,000 MT	Nil
From 75,001 to 1,00,000 MT	10%
Above 1,00,000 MT	15%


The said rebate will be granted in the form of refund of wharfage on submission of documents by exporters in support of throughput achieved. The rebate will be applicable to cargo loaded on vessels/barges inside the docks of KDS.

2. Rebate on Local Haulage charges

Exporters handling more than 1,00,000 MT export cargo for Bangladesh by Rail through KDS will be granted rebate in the form of refund of 50% local haulage charges on submission of documents in support of the volume achieved in 1 year.

The rebates will be given as promotional measure and the scheme will be valid for cargo handled in the period of one (1) year with immediate effect i.e, from 17.03.2022 to 16.03.2023.

Refund application, if any, will be processed after completion of one (1) year i.e, after 16.03.2023.
