Corrigendum

Sub : Tender for out sourcing of Dietary Services to the Indoor Patients of Centenary Hospital, KoPT for Two years .Tender Notice No: MED / PR / ADVT / 284 / 18-20 / 674 Dated 20 / 6 / 2018. MSTC Event NO KoPT/Kolkata Dock System/MED/15/18-19/ET/313.

Following Tender clauses has been amended as follows :-

- (i) Price bid Annex- D , (Top row Column of Item) may be amended as -"No of manpower required by the tenderer subject to the condition that such number would not be more than 14 (fourteen)" against the Existing Entry minimum No. of Man power required should not be more than 14 Nos.
- (ii) Under clause No 9 in Client support point (ii) it has been mentioned "Power and water supply free of cost to the Contractor for the purpose of cooking only." Instead following should be replaced against existing entry
- "Water for cooking will be supplied free of cost. However Power (electrical consumption) will be on chargeable basis. Separate submeter will be provided."
- (iii) Present Kitchen is equipped with One Refrigerator and one No deep freezer for keeping Milk, Breads Green vegetables and Fresh Meet Fish respectively. Deep freezer can be withdrawn / may be provided as per CMO's discretion .
- (iv) In order to ensure uninterrupted supply of foods to the patients during Bandh/ Strike/ Natural calamities , prospective contractor may be offered some kind of accommodation (like barrack/ mess) against **applicable** license fee if they so desire against the existing entry tender Clause 9 Point No. (vi)

- (v) In serial D of Appendix D (Price bid) the cells under semiskilled and unskilled has been merged to enable the contractor to quote uniform % of Service charges.
