Audited Balance Sheets as well as Profit & Loss Accounts for the last three financial years ending 31.03.2019 must have to be submitted. In the event of non submission of Audited Balance Sheets for the financial year ending 31.03.2019, the turn over for that financial year has to be submitted in lieu, duly certified by Chartered Accountant mentioning UDIN.</p> <p>ii) The firms must have either of the following as experience of having successfully completed similar works during last seven years, ending on last day of month, previous to the one in which applications are invited :</p> <p style="padding-left: 40px;">a) Three similar completed works each costing not less than Rs.3,76,163.20.</p> <p style="padding-left: 40px;">Or</p> <p style="padding-left: 40px;">b) Two similar completed works each costing not less than Rs.4,70,204.00.</p> <p style="padding-left: 40px;">Or</p> <p style="padding-left: 40px;">c) One similar completed work costing not less than Rs.7,52,326.40.</p>

<p>Here "similar works" means "Supply, installation & commissioning of electrical installation work at office premises/ residential complex/ hospital building/ factories, etc".</p> <p>Work experience as a subcontractor or supply contractor shall not be considered as requisite qualification. The Tenderer shall have to upload documents (certified copies from work & credential issuing authority), viz. order letter, performance certificates/payment details to establish his credentials.</p>	<p>Here "similar works" means "Supply, installation & commissioning of electrical installation work at office premises/ residential complex/ hospital building/ factories/ institutes ".</p> <p>Works experience as a sub-contractor or supply contractor shall not be considered as requisite qualification. The Tenderer shall have to upload / submit documents (self certified copies), viz., order letter and certificate from the organization where the bidder worked, in respect of satisfactory completion with executed value to establish his credentials.</p>
