One intending bidder stated that the firm, whose turn over below 1.0 crore rupees per year are exempted from audit as per Income Tax Department, Govt of India.  Please confirm that whether self attested Balance Sheet and Profit & Loss Accounts will be accepted or not.	b)Copy of Audited Balance Sheet as well as Profit and Loss Accounts for the last three financial years ending 31.03.2019 must have to be submitted. The Brass Strips are not readily available in the market. At least 86 days more i.e 100 days required for manufacture and supply the material and to complete the entire job.	Para -6 of annexure C should be read as “ <b>Completion Time: The work shall have to be completed within 75 days from the date of placement of the Order Letter or hand over of site to contractor whichever is later. Any disruption/stoppage of work due to operational urgency of KoPT shall not be counted while calculating the completion period. However, such disruption/stoppage of work has to be recorded in the Hindrance Register to be maintained by the contractor to be countersigned by the representative of Executive Engineer(HPS/NSD)”</b>
