PRE-QUALIFICATION CRITERIA FOR BIDDERS: -

Intending bidders must produce documentary evidence of being manufacturers of RUBBER FENDERS/authorized dealers of manufacturers/ accredited agents or stockist of manufacturers. They must also produce documentary evidence of supplying RUBBER FENDERFS against supply contract(s) during the last 7(SEVEN) years ending last day of the month previous to the month in which applications are invited. These supply credentials should also be substantiated by producing any one or more of the following documents. Order copies along with receipted challan copy/ certificate of Execution/ GRN/ Excise Invoice/ Tax Invoice/ Consignment Note, etc. or any other documents as a proof of supply of materials and the experience should be either of the following:

Either (i) Three completed works each costing not less than 40 % of the estimated amount put to tender.

Or (ii) Two completed works each costing not less than 50 % of the estimated amount put to tender.

Or (iii) One completed work costing not less than 80% of the estimated amount put to tender.
