PRE-QUALIFICATION CRITERIA FOR BIDDERS:

The intending bidder must have successfully completed **similar works** (as defined below) during the last 7 (Seven) years ending on the last day of month previous to the one in which applications are invited and the financial values of the contracts cited as experience should be any of the following:

- Either (i) Three completed works each costing not less than 40 % of the estimated amount put to tender.
Or (ii) Two completed works each costing not less than 50 % of the estimated amount put to tender.
Or (iii) One completed work costing not less than 80% of the estimated amount put to tender.

Note: The description of 'Similar Works' may be fixed as:

Construction and/ or repair of embankment / dyke /canal or similar structure.

- a) Construction and/or maintenance and/or repairs and/or up gradation of road/pavement/hardstand/yard or similar structure.
- b) River Regulatory works, like construction of Spurs and/or any type of Bank protection work.

- 2. The Average Annual Financial Turnover of the bidding firm during the last three years, ending on **31-03-2015**, should be at least 30% of the estimated amount put to tender.
- 3. Work experience, as a sub-contractor or supply contractor shall not be considered as the requisite qualification.
