**PRE-QUALIFICATION CRITERIA FOR TENDERERS: -**

1. The intending bidders must have successfully completed **mosquito/insecticide control works** during the last 7 (Seven) years ending the last day of month previous to the one in which applications are invited and minimum value of the completed works should comply with either of the following stipulations as given below :-

Either (i) Three completed works each costing not less than 40 % of the estimated amount put to tender.

Or (ii) Two completed works each costing not less than 50 % of the estimated amount put to tender.

Or (iii) One completed work costing not less than 80% of the estimated amount put to tender.

2. The Average Annual Financial Turnover of the bidding firm during the last three years, ending on **31-03-2016**, should be at least 30% of the estimated amount put to tender.

3. Work experience, as a sub-contractor or supply contractor shall not be considered as the requisite qualification.

4. In addition to the above they must have valid license to stock and use restricted insecticide(s) for commercial pest control operations from agricultural wing of State/Central Govt. of India as per prevailing Rules of Insecticides Acts, 1968. The intending bidders may engage consultant to this effects. The application must accompany said valid license/MOU with the consultant with valid license.
