NOTICE INVITING E-TENDER

E-Tender under two part system (Part I: Techno-Commercial Bid and Part II: Price Bid) are invited on behalf of Haldia Dock Complex (HDC), Kolkata Port Trust (KoPT), from the intending bidders fulfilling following Pre-qualification Criteria for the work of underground laying of 11 kV (Earth) grade, XLPE insulated, HT Power Cable, along with Hume Pipes & G.I. Pipes and other allied work, in connection with shifting of the existing utility lines (i.e. 11 kV overhead line & 11 kV underground cable network) of HDC, KoPT, for the purpose of construction of ROB-cum-Flyover, at Ranichak Crossing, at Haldia.

1.1 Pre-qualification Criteria :

Any firm fulfilling the following criteria, will be considered eligible.

1.1.1 The tenderer must be a Valid Electrical Contractor. In this respect, the tenderer will have to submit Valid Electrical Contractor's License, along with their offer.

1.1.2 The tenderer must possess experience of having successfully executed contracts for similar works (i.e. erection/ execution/ repair/ maintenance works related with Sub-station of voltage grade not less than 11 kV and/ or overhead lines of not less than 11 kV grade and/ or underground laying of cables of not less than 11 kV grade along with other allied work, in different Government / Private organizations / institutions etc.), during the period of last 7 (seven) years, ending on 30.04.2017, as follows :-

i) 3 (Three) similar completed works each costing not less than the amount of INR 18.53 Lakh (Rupees Eighteen Lakh Fifty Three Thousand) only

Or

ii) 2 (Two) similar completed works each costing not less than the amount of INR 23.17 Lakh (Rupees Twenty Three Lakh Seventeen Thousand) only

Or

iii) 1 (One) similar completed work costing not less than the amount of INR 37.06 Lakh (Rupees Thirty Seven Lakh Six Thousand) only.

Copy/ copies of order letter(s) for similar work(s) with documentary evidences in support of execution i.e. Certificate of Completion/ successful execution certificate must be furnished.

1.1.3 Criteria with respect to financial capability :

The Average Annual Financial Turnover of the bidding firm during the last three years, ending on **31st March, 2017**, should be at least **INR 13.90 Lakh (Rupees Thirteen Lakh Ninety Thousand) only.**

Documentary evidence, in support of the above shall have to be furnished in the form of Audited Balance Sheets and Profit & Loss Accounts for the last three financial years, ending on 31.03.2017. The Auditor, in such case, must be a qualified Chartered Accountant. No self-declared document(s) would be accepted for this purpose.

In absence of audited Balance Sheet and Profit & Loss Account, for the last financial year, ending on **31.03.2017**, a certification regarding financial turnover (for the last financial year, ending on 31.03.2017) shall have to be submitted from the **statutory auditor of the company/ firm**. As soon as the audited Balance Sheet and Profit & Loss Account would become available, the same should be submitted immediately.

If due date (scheduled opening date of tender) falls within three months (April to June) of the closing of the latest financial year, the latest financial year may be ignored and financial turnover of the three years, year previous to the latest financial year may be considered.

In case, the bidder is unable to submit audited Balance Sheet and Profit & Loss Account for the last financial year ending **31.03.2017** (in case of tender opening date falling after June), due to non- completion of audit or for any other reason, a certification regarding financial turnover (for the last financial year ending **31.03.2017**) shall have to be submitted from the statutory auditor of the company / firm.

1.1.4 Mode of submission of documents in respect of Pre-qualification Criteria : All documents in support of Pre-qualification Criteria as per Clause No. 1.1 must be **signed by the bidder under their official seal, scanned and uploaded.**

1.2 Submission of other documents :

PROCEDURE OF PAYMENT OF EARNEST MONEY AND BID DOCUMENT FEE OF TENDERS OF HALDIA DOCK COMPLEX ,THROUGH AXIS BANK GATEWAY

1. The Bidders would be able to access the payment gateway from the Vendor log in page of the MSTC ecommerce site (www.mstcecommerce.com→ *e-Procurement* →*Psu / Govt depts*→*Kolkata Port Trust*) under the icon: "**HDC EMD/Tender Fee Payment**". Clicking this icon will take the bidders to the Axis bank gateway.
Alternatively, the Bidders can also access the gateway by from Axis bank easypay website site (<https://easypay.axisbank.co.in>→ Others→Haldia Dock Complex)
2. The Bidder will be required to mention the **Bidder's ID** (The ID used by the Bidder for logging in the MSTC Website) and **Bid Id** (E-tender Number of the Tender against which the Bidders intend to submit Bid) and then Click '**VALIDATE**'.
3. A webpage will populate where the Bidder will be required to select: **Earnest Money** Or **Bid Document Fee**, then indicate his Mobile Number and the CAPTHA displayed in the webpage.
4. Depending on the selection, another webpage will come up.
5. In case of selection of Earnest Money, The bidder will be required to select the option of With or Without Bank Guarantee. In case of Bids, where there is no option to pay through BG, the Bidders should select the option '**Without**'.
In case of any tender, where there is an option to pay a part of EM through Bank Guarantee and the Bidders wants to avail that option, the bidder should select '**With**'.
6. The Bidder will be required to mention their Bank Account Number, IFSC Code of his Bank, and the Name of the Account, insert the Captha mentioned in the web page and then '**SUBMIT**'. In case of Bid Document Fee payment, Bank Account Number would not be required.
An **URN** Number will be generated. Bidders may keep note of this **URN** Number for all future reference.
7. Another webpage will come up and the Bidder will have the option to select payment methods from – (i) Internet Banking and (ii) NEFT/RTGS after agreeing with the terms and conditions by clicking the dialogue box appearing in the webpage.
8. In case of selection of Internet Banking, the bidder will be required to select any Bank of their choice and depending on the selection the bidder will then be guided to the webpage of the respective Bank. 2. OTHER INSTRUCTIONS TO THE TENDERERS

2.1 Language of Tender and Interpretation of the Tender Document and Other Documents :

- 2.1.1** Tender Document means all pages of this book including all pages of General Conditions of Contract of Kolkata Port Trust, May 1993. All pages of subsequent addenda (if applicable) are also part of the Tender Document.
- 2.1.2** The Tender Documents are drawn up in English and filling up of the required documents by the Tenderer should also be only in English and the interpretation(s) shall be in English. All correspondence and documents relating to the tender, exchanged between the Tenderer and HDC, shall be in the English Language only. The interpretation(s) of the accepting authority shall be final and binding on the bidder.
- 2.1.3** Any clarification with regard to interpretation or ambiguity, discovered or pointed out after the uploading of the Tender Document, as to the meaning, conditions, instructions or Annexure contained in the Tender Documents shall be valid when such a clarification is made by the authority issuing NIT, through a written document and such clarification / amendment shall form part and parcel of the Tender Document.
- 2.1.4** The various documents comprising of the full set of Tender Document are complimentary to one another and are to be taken as parts of a whole and mutually explanatory to each other. If stipulation to the various tender conditions are found to be in variance to each other in any respect, one will override other in order of precedence in the descending order as given below :
- (i) Description in "Price Schedule".
 - (ii) Special Conditions of Contract.
 - (iii) General Conditions of Contract of Kolkata Port Trust, May 1993.

2.2 Intending bidders have to bear all the costs or expenses incurred by them in connection with the preparation and submission of their bids or for any other expenses incurred in connection with such bidding.

2.3 The bidder shall quote his price through on-line (through MSTC portal only) as per the Price Schedule in the Price Bid (Part-II), without any condition or deviation.

2.4 E-Tender Document shall neither be issued by post nor sold.

2.5 Tenderers are not permitted to alter/change/delete/modify any clause of the tender document downloaded from the website. If any deviation / discrepancy is found after submission of tender, the submitted offer will be summarily rejected.

2.6 Pre-Bid Techno-Commercial Conference :

2.6.1 Intending bidders and/or their authorized representative(s) are invited to attend the Pre-Bid Techno-Commercial Conference, which will be held on the date stipulated in the 'NOTICE INVITING E-TENDER', at the **office of Plant & Equipment Division, Haldia Dock Complex; Kolkata Port Trust; 1st Floor, Operational Administrative Building; Chiranjibpur, PO: Chiranjibpur, Haldia ; Dist.: Purba Medinipur ; PIN – 721 604 ; West Bengal.**

2.6.2 The purpose of this Pre-Bid Techno-Commercial Conference will be to clarify issues (in connection with this tender) that may be raised at that stage.

2.6.3 Intending bidders may like to visit the worksite at HDC, during working days (**i.e. excluding Sundays, Saturdays and trustees holidays**) **within 10:00 hrs to 16:00 hrs.** before attending the Pre-Bid Techno-Commercial Conference. To visit worksite necessary Gate Pass at free of cost will be issued on the basis of written request of the intending bidders as per the existing procedure of HDC, KoPT. Without taking prior

approval from the appropriate authority of HDC, KoPT, no photograph in any form can be taken by the intending bidders during site visit.

- 2.6.4** Intending bidders are requested to submit their queries, in connection with this tender, in writing, in advance to HDC, KoPT so as to enable HDC, KoPT to prepare clarifications and make Pre-Bid Conference meaningful. Changes, if any, proposed by the bidders, will be discussed and **if felt necessary** HDC, KoPT's response would be communicated, well in advance before the last date of submission of tender.
- 2.6.5** Any modification to the Tender Document, which may become necessary as a result of the Pre-Bid Techno-Commercial Conference or due to any other reason, shall be made through issuance of an Addendum. This Addendum, so issued, would form part of the Tender Document and will remain binding all the bidders and the same should be accepted and submitted by all the bidders along with their Techno-Commercial Bid.
- 2.6.6** The bidders are advised to attend the Pre-Bid Techno-Commercial Conference. However, non-attendance at the Pre-Bid Techno-Commercial Conference will not be a cause for disqualification of a bidder.
- 2.6.7** No further Pre-Bid Techno-Commercial Conference will be arranged for the intending bidder, who fails to attend the aforementioned Pre-Bid Techno-Commercial Conference. The outcome of this Pre-Bid Techno-Commercial Conference will be displayed on the websites, all the participating bidders shall have to act accordingly.

2.7 Earnest Money Deposit (EMD) :

2.7.1 Method of Paying EMD :

As per the methodology stipulated in the 'NOTICE INVITING E-TENDER', the intending tenderer must deposit **Earnest Money, amounting to Rs 92,660.00 (Rupees Ninety Two Thousand Six Hundred Sixty)** only.

Failing to deposit the Earnest Money, as per the above details, shall make the Tender liable for rejection.

2.7.2 Exemption :

As mentioned in the 'NOTICE INVITING E-TENDER', Micro & Small Enterprises (MSEs) registered with NSIC (under single point registration scheme), having valid NSIC Certificate for MSEs along with DIC's (DISTRICT INDUSTRIES CENTRE) Certificate, are exempted from depositing **Bid Document Fee** and **Earnest Money**.

In such case, scanned copies of valid NSIC Certificate for MSEs along with DIC's (DISTRICT INDUSTRIES CENTRE) Certificate have to be uploaded along with the bid.

Micro & Small Enterprises (MSEs) registered with NSIC intends to participate in the tender, for the items they are not registered with NSIC, then they will have to deposit full amount of Bid Document Fee and Earnest Money Deposit as per NIT. Otherwise their offer for those items will not be considered.

2.7.3 Forfeiture of EMD :

Earnest Money may be liable for forfeiture at the option of the Trustees, if the Bidder withdraws his offer after the schedule date of submission of offer and before expiry of the validity period of the offer; and / or, alters / amends any terms and / or condition and / or quoted rate(s), after the schedule date of submission of offer and before expiry of the validity period of the offer (excepting when option to do the same has been specifically granted by the HDC, KoPT in writing) making it unacceptable to HDC, KoPT and / or, in case of successful bidder, fails to carry out the work or to perform / observe any of the conditions of the Contract; and / or, fails to carry out the work or to perform / observe any of the conditions of the Contract. For the purpose of this provision, the validity period shall include any / all extension thereof agreed by the

bidder in writing. The Trustees shall also be at liberty to deduct any of their dues from Earnest Money.

2.7.4 Refund of EMD :

Earnest Money Deposit of unsuccessful bidders shall be refunded or released as the case may be to the unsuccessful Bidders, without any interest, within **7 (Seven) days after opening of Price bid (Part – II)** of the e-Tender document.

Earnest Money Deposit of the successful bidder shall be released / refunded after submission of Security Deposit, without any interest.

2.8 Method of Submission of Tender :

2.8.1 Tenderers submitted bids, without requisite Earnest Money and/ or Bid Document Fee, are liable to be rejected, excepting in case of Micro & Small Enterprises (MSEs) registered with NSIC (under single point registration scheme) having valid DIC's certificate, for the item(s), for which the tender is invited.

2.8.2 For submission of Techno-Commercial Bid (i.e. Part – I), the participating bidder would have to sign / fill (wherever applicable) the documents / Annexure / formats etc. **[as mentioned under Clause No. 1.1 of NOTICE INVITING E-TENDER (i.e. Pre-qualification Criteria) and Clause No. 1.2 of NOTICE INVITING E-TENDER (i.e. Submission of other documents)]** under their official seal, scan and upload in the website of **MSTC Limited (i.e. <http://www.mstcecommerce.com/eprochome/kopt>)**.

The bidder will have to produce the original documents or any additional documents, if sought for by HDC, KoPT.

2.8.3 Price Bid (i.e. Part –II) contains the **Price Schedule**. Price Bid has to be submitted online without any condition or deviation. **The bidders are required to quote the rates of all the items. In case of non-availability of rate of any of the items, the respective offer will be treated as non-responsive and will be rejected.**

2.8.4 Bidders have to submit offers based upon Terms & Conditions of the tender without any deviation. Should it, however, become unavoidable, deviations should be suggested during Pre-Bid Meeting. HDC, KoPT reserves the right to accept or reject the suggested deviations.

2.9 Declaration to be submitted by the Tenderers :

The bidder should give the following declarations under their letter head along with the techno-commercial offer as per **Annexure – VIII** of this Tender Document:

2.9.1 A declaration, so that, the bidder has examined carefully, read, understood and accept all the Terms & Conditions of the instant tender including Price Schedule, Special Conditions of Contract, Scope of Work, General Conditions of Contract, May 1993 of Kolkata Port Trust. The bidder would execute and complete the work required to be performed in accordance with all these Terms & Conditions of the instant tender.

2.9.2 A declaration, that the bidders are required to quote the rates of all the items. In case of non-availability of rate of any of the items, the offer of the bidder will be treated as non-responsive and will be rejected.

2.9.3 A declaration, that there is no deviation from the Terms & Conditions of the instant Tender Document.

2.9.4 A declaration that the bidder has deposited requisite Earnest Money & Bid document fee.

OR

The bidder has submitted documentary evidences for Micro & Small Enterprises (MSES) registered with NSIC (Under single point registration scheme) as per tender conditions.

- 2.9.5 A declaration, that the bidder has not been banned/de-listed/debarred by any Govt./Quasi-Govt./Public Sector Undertaking in India.
- 2.9.6 The authorized signatory of the bidding firm should give a declaration that the bidder/his partner/any director of their concern/ company is not associated with any other firm bidding for the instant work.
- 2.9.7 A declaration, that the bidder has not altered /deleted /added any Terms & Conditions in the tender document.
- 2.9.8 A declaration that, price quoted only in the Price Bid [Part – II], strictly as per **“Price Schedule”, without any extraneous condition.** There is no change in the Format of Un-priced **“Price Schedule”**. Except in the Price Bid the price is not mentioned/disclosed in any other place of tender/offer.

2.10 **Authority in signing the documents for submission of Tender / Offer :**

All documents to be uploaded by the bidder should be signed under official seal by –

- 2.10.1 In case the Tender is submitted by a Proprietorship Firm, the same should be signed either by Proprietor or other person, holding a valid Power of Attorney from the Proprietor, in connection with this Tender. The signature of such Power of Attorney holder should be attested by the Proprietor.
- 2.10.2 In case the Tender is submitted by a Partnership Firm, the same should be signed either by partner, holding valid Power of Attorney from the partners, in connection with this Tender. The signature of such Power of Attorney holder should be attested by the partners.
- 2.10.3 In case the Tender is submitted by a Limited Company, the same should be signed by person holding valid Power of Attorney executed in his favour (in connection with this Tender) and the signature of such Power of Attorney holder should also be attested, in accordance with the constitution of the Limited Company.

2.11 **Validity of Tender :**

The tender shall remain valid for acceptance for a period of 180 days from the actual date of opening of Techno-Commercial Bid. Prior to the expiry of the Tender validity period, HDC, KoPT may ask to extend the period of validity for a specific time. The request and the response, thereto, shall be made in writing. However, in the event of the bidder agreeing to the request, he shall not be permitted to modify his tender (excepting when option to do the same has been specifically granted by the HDC, KoPT, in writing).

2.12 **The bidder to inform himself fully :**

- 2.12.1 This Tender Document (covering all instructions, Special Conditions of Contract and Scope of Work and General Conditions of Contract of Kolkata Port Trust, May, 1993, along with latest amendment etc.) should be read in conjunction with any addendum which may be issued subsequently.
- 2.12.2 The bidder shall be deemed to have examined the Tender Document [covering all instructions, Special Conditions of Contract, Scope of Work and General Conditions of Contract of Kolkata Port Trust, May, 1993, etc.] and visited the worksite and surroundings and to have obtained all necessary information in all the matters whatsoever that might influence while carrying out the work as per the conditions of the tender and to satisfy himself to sufficiency of his tender, etc. The bidder is advised to acquaint himself with the job involved at the site, like means of transport, laws and bye laws in force from Government of West Bengal and Govt. of India and other statutory bodies from time to time. The bidder shall be deemed to have examined and collected all necessary information as to risk, contingencies and other circumstances, which may influence or affect the tender.

- 2.12.3 Failure to comply with the requirement of the Tender submission will be at the bidder's own risk. Tender(s) / Offer(s) of the bidder(s), which are not responsive to the requirement of the Tender Document, will be rejected.
- 2.12.4 Bidder shall bear all costs associated with the preparation and submission of his tender and HDC, KoPT will in no case be responsible or liable for these costs, regardless of the conduct or outcome of the tendering process.
- 2.12.5 Before attending the Pre-Bid Techno-Commercial Conference and/ or submission of tender, on the basis of formal written request, necessary Gate Pass for entering into the Dock area, if required, will be issued to the bidder and/ or their authorized representative(s), **on chargeable basis**. The bidder will be fully responsible for any injury (whether fatal or otherwise) to himself or his representative(s), for any loss or damage to property, or for any other loss, damage, costs and expenses whatsoever caused which but for the granting of such permission would not have arisen. The bidder will be liable to indemnify the Employer against any loss or damage to the property of the Employer or neighbouring property which may be caused due to any act of bidder or his representative(s).

2.13 Amendments :

- 2.13.1 At any time, prior to the last date for submission of tenders, HDC, KoPT reserves the right to amend and modify the Tender Document by issuing Addenda.
- 2.13.2 Any Addendum thus issued shall form part of the Tender Document and shall be communicated to all concerned through the websites and press advertisements, prior to the last date for submission of the tender. Such Addendum so carried out shall form part of the tender and shall be binding upon the bidders.

2.14 Errors in the Tender Document :

- 2.14.1 All documents to be submitted with the Techno-Commercial Bid should be signed, stamped, scanned and uploaded as per Clause No. 1.1 & Clause No. 1.2 of 'NOTICE INVITING E-TENDER'.
- 2.14.2 The bidder shall submit complete tender and the same shall be without alterations, interlineations or erasure effect except those to accord that instructions issued by HDC, KoPT or as may be necessary to correct errors made by the bidders. Person signing the Tender shall, put his signature against all such cancellations, alterations or amendments. **The said Tender Document (in full) is to be scanned & uploaded as part of techno-commercial offer.**
- 2.14.3 **The bidders are required to quote the rates of all the items. In case of non-availability of rate of any of the items, the respective offer will be treated as non-responsive and will be rejected.**

2.15 Acceptance of Tender :

HDC, KoPT shall reserve the right not to accept the lowest tender or any tender and reserve the right to accept the tender in part or full or to cancel the tender as a whole without assigning any reason.

Cost on this account, if any, shall not be reimbursed. Participation in e-tendering process by any bidder or opening of techno-commercial bid of any bidder shall not construe that such bidder is considered automatically qualified.

2.16 Opening of Bids:

- 2.16.1 Only Part -I i.e. Techno-Commercial Bid(s) would be opened online on the date and time as stipulated in the 'NOTICE INVITING E-TENDER'.
- 2.16.2 Part -II i.e. Price Bid(s) of only those bidder(s) who are found techno-commercially qualified, would be opened on a later date, with prior intimation to all concerned.

2.16.3 In case of unscheduled Holiday / Bandh on the date of opening of E-Tender, the same will be opened on the next working day.

2.17 Scrutiny of e-Tenderers :

2.17.1 After opening of the Techno-Commercial Bid, the Tender Document(s) submitted by the bidder(s), shall be carefully examined to ascertain that whether all the bidders have submitted the Earnest Money Deposit, Bid Document Fee and all required documents as mentioned in the Tender Document.

2.17.2 In connection with scrutiny, evaluation and comparison of tenders, HDC, KoPT may ask bidder individually for clarifications. Request for clarification and response thereto shall be communicated in writing. No change in price or substance of the tender shall be sought, offered or permitted nor the bidder be permitted to withdraw the tender before the expiry of the Validity Period of the tenders in the process of clarifications.

2.17.3 HDC, KoPT may seek any other detail(s) / document(s) in subsequent course to ascertain and get confirmed about the competence of the bidder.

2.17.4 The Trustees reserve the right to disqualify a tender in case they are satisfied that any prize, commission, gift or advantage has been given, promised or offered by or on behalf of any bidder, to any officer, employee or representative of the Trustees or to any person on his or their behalf in relation to the acceptance of the tender.

2.17.5 If on scrutiny, **Techno-Commercial Bid** of any bidder is found not acceptable to HDC, KoPT, the **Price Bid** part of such bidder **will not be opened**. "Price Bid" part of other bidder(s) will be opened on a subsequent date as per procedure. Decision of the HDC, KoPT in this regard shall be final and binding on the bidder.

2.17.6 During Techno-Commercial evaluation, i.e. evaluation of Part - I of tender, an offer shall be considered **non-responsive** in case :-

- (i) requisite Earnest Money is not deposited,
- (ii) requisite Bid Document Fee is not paid,
- (iii) valid NSIC Certificate for MSEs along with DIC's (DISTRICT INDUSTRIES CENTRE) Certificate is not submitted in case of exemption from depositing Bid Document Fee and Earnest Money.
- (iv) Any indication of quoted price anywhere in the uploaded documents required for Techno-Commercial offer.
- (v) does not meet the Pre-Qualification Criteria as stipulated in the NIT.
- (vi) The bidder submits conditional offer / impose own terms and conditions / does not accept tender terms and conditions completely.
- (vii) The bidder provides misleading or false information in the statements and documents submitted.
- (viii) Record of unsatisfactory performance during the last seven years, such as abandoning of work or rescinding of contract for which the reasons are attributable to the non-performance of the contractor or inordinate delays in completion or financial bankruptcy etc.

The decision of Haldia Dock Complex, Kolkata Port Trust in this regard shall be final and binding on the Bidder.

2.18 Evaluation Criteria:

2.18.1 Evaluation with respect to Priced Price Schedule.

2.18.1.1 Price to be quoted strictly in accordance with Clause Nos. 2.8.3 and 3.10.

2.18.1.2 The Price Bid will be evaluated only for the bidders, who have qualified in the Techno-Commercial Bid.

2.18.1.3 While evaluating the Price Bid, the unit rates (excluding Service Tax, VAT/ CST, Excise Duty and other statutory taxes, levies & Cesses thereon) quoted by the

bidders for different items as mentioned in the Price Schedule shall be taken into account and the same will be multiplied by the respective quantity against different items and thereafter total summation will be done. The selection of the lowest bidder will be made on the basis of sum total cost.

2.18.1.4 While evaluating the Price Bid, any extraneous condition will not be considered and the tender shall liable for outright rejection, if any extraneous condition is found in the offer of the bidding firm.

2.18.1.5 In case two or more bidders quoting the same Price and their offers become the lowest offer, the respective bidders will be given chance to submit their fresh price bid subject to condition that the fresh price so quoted must be less than the price quoted by the respective bidder earlier.

2.18.1.6 **The bidder, who quoted lowest total cost, shall be considered for award of contract.**

2.18.1.7 **For Micro & Small Enterprises (MSEs) registered with NSIC:**

If illegible for this kind of job, the benefits as per prevailing norms will be extended to MSEs registered with NSIC as per New Public procurement Policy as notified by the Government of India, Ministry of Micro, small & medium enterprises (MSME) in The Gazette of India vide No. 503, dated 26.03.2012.

2.18.1.8 When splitting of tender quantity is not possible purely on technical ground, trustees reserve the right not to negotiate price with MSE if their price is within the band of L1+15% in comparison with L1 price of non-MSE for consideration of award of order for 20% of tender quantity against any item as per new public procurement policy.

2.18.2 While evaluating tenders, regard would be paid to National Defence and Security considerations.

2.19 Award of Contract :

2.19.1 The successful bidder who's bid is accepted by HDC, KoPT (please refer to **Clause No. 2.18**) shall be duly informed in writing, prior to expiration of the tender validity period, that their tender has been accepted. This notification of award of contract will be treated as **Order Letter** and will constitute the formation of the contract. **Within 15 days** of receipt of intimation regarding acceptance of their bid, the successful bidder shall have to **submit Draft Agreement**, in the format as in **Annexure- X** and within a week thereafter the **Contract Agreement** shall be signed between **Kolkata Port Trust** and the **successful bidder**. For this, the successful bidder has to submit, at their own cost, required **Stamp Papers** and **Dummy Papers** and **three sets of documentary transactions** between them and Kolkata Port Trust, till finalization of the contract. This Agreement should be signed by the representative of the successful bidder, authorized through a **Power of Attorney** (specimen signature of the Authorized Representative must be attested) in this regard.

2.19.2 Kolkata Port Trust reserve the right to accept or reject the tender in part or as a whole and do not bind themselves to accept the lowest tender or any tender, without assigning any reason and no damage claim whatsoever will be payable by Kolkata Port Trust in this regard. Mere participation in e-tender by any bidder or opening of techno-commercial bid of any bidder shall not construe that such bidder is considered automatically qualified for award of contract. Such qualification may also include information regarding performance of bidder from any other source.

2.20 Stamp Duty and Other Expenses :

All costs, charges and expenses etc. to be incurred in connection with Contract Agreement / Bank Guarantee(s) etc. including Stamp Duty in connection with contract shall be borne by the successful bidder.

3. SPECIAL CONDITIONS OF CONTRACT

3.1 Definition and Interpretation :

For definitions of different words used in this Tender Document, **KoPT's General Conditions of Contract, May 1993** are to be followed.

3.2 Additions and Alternations :

3.2.1 HDC, KoPT shall have power and authority from time to time, and at all times to make amendments or additions or alterations or changes in the Scope of Work and give such further instructions and directions as may appear necessary and proper to HDC, KoPT for the guidance of the contractor and good and efficient execution of the work.

3.2.2 The contractor shall receive, obey and be bound by the same according to the true intent and meaning thereof as if the same had been mentioned or referred to in the Scope of Work etc.

3.2.3 HDC, KoPT may also vary or alter the levels or positions of any of the work contemplated by approved specification or may order any of the work contemplated thereby to be omitted, with or without substitution of any other work in lieu thereof, or may order any work or any portion of work executed or partially executed, to be removed, changed or altered, if required.

3.2.4 HDC, KoPT may order that other work shall be substituted in lieu thereof and any difference in the cost occasioned by any such diminution or alteration so ordered and directed shall be added to or deducted from the amount specified by the contractor and where the rates are not specified, then a suitable rate backed up by rate analysis shall be submitted by the contractor and agreed upon between the contractor and HDC, KoPT.

In the event of disagreement, HDC, KoPT shall fix such rates or prices as shall in their opinion, be reasonable and proper having regard to the circumstances.

3.3 Access to Site :

The contractor shall have to abide by the rules and regulations of HDC, KoPT, which may be varied time to time, in respect of entry / exit and movement in the premises. Necessary **Gate Pass** for entering into the Dock area will be issued for the personnel, equipment, machineries, materials etc. of the contractor, for execution of the instant work, **on chargeable basis**, as per rules then prevailing, on the basis of written request from the contractor.

Haldia Dock Complex is presently in the process of introducing RFID based Dock Entry Permits and the present system of issuing paper permits will be phased out. With a view to strengthen security of the dock, it has been decided that photocopy of proof of identity has to be submitted for one-time registration of all the individuals seeking man permits. The following documents will be considered as a valid proof of identity.

- Passport (Relevant pages with photo & address)
- Driving License.
- Voter ID Card (EPIC).
- AADHAAR (UID).
- Income Tax PAN Card.

Please note that document substantiating proof of identity is required to be submitted once for each individual. For getting subsequent permits, the sponsoring firms may quote ID number and type of ID of the individual which was submitted initially for registration.

3.4 Contract Document Mutually Explanatory :

3.4.1 The several documents forming the contract are to be taken as mutually explanatory of one another and should anything appear in one, which is not described in the other, no advantage shall be taken of any such omission.

3.4.2 In case, any discrepancies or inconsistencies however appear or should any misunderstandings arise as to the meaning and of the specifications or drawings or as to the dimensions or the quality of the materials or the due and proper execution of the work or as to the measurement or quality and valuation of the work executed under this contract or as extra thereupon, the same shall be explained by the Engineer or his authorized representative.

3.4.3 The explanation of Engineer or his authorized representative shall be final and binding upon the contractor and the contractor shall execute the work according to such explanations, and without extra charge or deductions to/from the prices specified in the Price Schedule and do all such work and things as may be necessary for the proper completion of the work as implied by the specification and drawings, even though such work and things are not specifically shown and described therein.

3.5 Total Completion Time :

The contractor will have to complete the tendered job in all respects and handover the complete installations, after commissioning of the same, **within THREE (03) Months, from the date of placement of order**. Any delay on the part of HDC, KoPT for the job, which is under the Scope of HDC, KoPT and/ or the delay of the statutory authority, if any, will be suitably taken care of.

3.6 Tender Price, Taxes, Duties and other Statutory Levies etc. :

3.6.1 Price to be quoted only in the Price Bid (priced Price Schedule) should strictly as per **"Price Schedule", without any extraneous condition**. There should not be any change in the Format of un-priced **"Price Schedule"**. Except in the Price Bid, the price must not be mentioned / disclosed in any other place of tender/offer.

3.6.2 The bidders are required to quote the rates of all the items. In case of non-availability of rate of any of the items, the respective offer will be treated as non-responsive and will be rejected.

3.6.3 Quoted price as per **"Price Schedule"** should be inclusive of all incidental charges but **exclusive** of Service Tax, VAT/ CST, Excise Duty and other statutory taxes, levies & Cesses thereon. The same will be paid extra on submission of relevant document for availing credit (please refer to **Clause No. 3.8 & 3.9**), if and as applicable.

3.6.4 Except where otherwise specifically provided, the successful bidder shall provide all required things necessary in connection with the contract work, although everything may not be fully specified and although there may be errors and omissions in the specifications.

3.7 Price Variation :

In case of any upward variation in any taxes, duties and other statutory levies etc. and/ or new introduction of any taxes, duties and other statutory levies etc. of Central/ State Government, which will be applicable to this Contract, Trustees will consider reimbursement of payment made against such increase of taxes, duties against documentary evidence of such payment made. In case of any downward revision in any taxes, duties and other statutory levies etc. and/or withdrawal/ abolition of any taxes, duties and other statutory

levies etc. the contractor will give due rebate, as would be effected by such revision or withdrawal/ abolition.

3.8 EXCISE DUTY, SERVICE TAX, VAT/CST, OTHER STATUTORY TAXES, LEVIES & CESSSES:-

- 3.8.1** Service Tax, VAT/ CST, Excise Duty and other statutory taxes, levies & Cesses thereon, for execution of the tendered job, will be paid extra, on submission of relevant document for availing credit, if & as applicable.
- 3.8.2** However, for recovery of any charges by HDC/KoPT from the contractor, Service Tax, as applicable on the amount of liquidated damage as well as other recovery i.e. damage, penalty, land rent, etc. shall be deducted from contractors' bill at applicable rates and the same will not be reimbursed by HDC/KoPT.
- 3.8.3** The bidder should quote landed price including all charges (excluding Service Tax, VAT/ CST, Excise Duty and other statutory taxes, levies & Cesses thereon), including insurance, transportation, packing, forwarding and all other incidentals required for execution of the contract in all respect. Variation (upward / downward) in taxes & duties and statutory levies etc due to change in Govt. Regulations only shall be considered, provided such change has taken place within the completion date of the Contract.
- 3.8.4** HDC/ KoPT do not enjoy any concession regarding Sales Tax and do not provide any 'C' or 'D' Form in this regard. Hence, accordingly the amount of VAT or C.S.T. shall be applicable. The rates of VAT or C.S.T., if applicable & considered in the quoted rate, has to be mentioned.
- 3.8.5** Deduction of Sales / Turnover Tax on works contract, Income Tax shall be made by the Employer from each certificate of payment to the Contractor at the prevailing rates or such other rates as may be specified by the Government from time to time, on the gross amount of the Contractor's bill for payment.

3.9 Goods & Services Tax (GST) :

Any modification (addition/ deletion/ alteration including implementation of GST) in taxes or duties in future by the GOI will be applicable & addressed separately at the material time. Therefore, the detailed tax break-up considered in the quoted price should also be submitted by the bidders along with their price bid in order to assess the impact of future tax levied, if any on the contract price. Any offer without the detailed tax break-up, if becomes the lowest price-bid and is accepted by KoPT with or without any negotiation of price, shall not be entitled for reimbursement of any additional amount due to modification of taxes or duties. Any recovery due on account of any modification in taxes or duties shall be made by KoPT from the amount payable under the contract.

3.10 Payment Terms :

3.10.1 Against Supply:

- i) 70 % (seventy percent) of the supply value against progressive supply of the items at site and submission of unambiguous bills along with custodian certificates and relevant documents, such as inspection reports, challans etc.
- ii) 20 % (twenty percent) of the supply value of the items against progressive installation of the same and submission of unambiguous bills along with installation certificates.

3.10.2 Against Installation:

90 % (ninety percent) towards progressive installation of the items against successful installation of the items and submission of unambiguous bills along with installation certificates.

3.10.3 Against Commissioning:

Balance 10 % (ten percent) towards both supply and installation value against successful testing and commissioning, handing over the commissioned job and submission of unambiguous bills along with job completion certificates.

The above payment against commissioning [i.e. 10 % (ten percent) towards both supply and installation value] would be released after obtaining formal approval/ clearance, if any, from statutory authority/ authorities, if any.

The amount of Service Tax, VAT/ CST, Excise Duty and other statutory taxes, levies & Cesses thereon, will be paid by HDC, KoPT, on production of relevant document for availing credit, if & as applicable.

Payment will be made within 30 (thirty) working days after submission of correct and complete bills along with required documents.

The contractor will be allowed to submit bill(s) only once in a calendar month.

Any claim for interest will not be entertained by HDC, KoPT with respect to any payment or balance which may be in their hands owing to any disputes between themselves and the contractor or with respect to any delay on the part of HDC, KoPT in making payment.

3.11 Taxes, Labour Laws and other Regulations:

3.11.1 The Contractor shall fulfill all legal obligations in respect of the contract. HDC shall accept no liability whatsoever in the matter and also in case of accident, if any.

3.11.2 The Contractor shall be fully and exclusively liable for the payment of any and all taxes now or hereafter imposed, increased or modified and all taxes now in force and hereafter imposed, increased or modified from time to time in respect of the above job and all contributions and taxes for unemployment compensation, insurance and old age pensions and amenities now or hereafter imposed by any law of the Government /local bodies which are imposed with respect to or covered by the wages , salaries or other compensations paid to the persons employed by the Contractor. The Trustees shall have no liability whatsoever concerning the employees of the Contractor. The Contractor shall keep the trustees indemnified against all losses or damage or liability arising out of or imposed in the course of employing the persons or out of his relation with his personnel. The Contractor shall make regular and full payment of wages / salaries and other payments due to his employees and furnish necessary proof whenever required by the Trustees. The Contractor shall be liable to pay any increase of wages / salaries of his personnel during the contractual period.

3.11.3 The Contractor shall be responsible for the compliance with all acts, laws and regulations as applicable with regard to the performance of work including the Minimum Wages Act, Contract Labour (Regulation and Abolition) Act, 1970, Industrial Dispute Act, 1947, Factory Act, 1948, Workmen's Compensation Act, 1923, ESI Act, 1948, Payment of Wages Act, 1936, Bonus Act, Employees Provident Fund and [Misc. Provisions] Act, 1952, Apprentices Act, 1961, Shops & Establishments Act, Dock Worker's (Safety, Health & Welfare), 1986 and such other applicable Central / State Acts or Statutes not herein specifically mentioned but having direct or indirect application in this contract and take such steps as may be deemed necessary in this regard.

3.11.4 If, as a result of the contractors failure, negligence, omission, default or non-observance of any provisions of any law, KoPT is called upon by any authority to pay reimburse or is required to pay or reimburse any amount, KoPT shall be entitled to deduct the same from any moneys due or that become due to the Contractor under this contract or any other contract or otherwise recover from the Contractor any sums, which KoPT is required or called upon to pay or reimburse on behalf of the

Contractor. All registration and statutory inspection fees, in connection with labour engagement, with respect to this contract, shall have to be paid by the Contractor.

3.11.5 The Contractor shall have to comply with the ESI Act applicable to their engaged employees as follows:-

- i) The contractor must have EPF & ESI Code Nos. He shall pay his contribution (i.e. employer's contribution) on account of ESI & EPF w.r.t. the contract labours deployed by him, as per statutory requirement. The contractor shall also deduct the contract labours' contribution (i.e. employees' contribution) on account of ESI & EPF from their wages, as per statutory requirement. The contractor shall then deposit both the aforesaid contributions i.e. the employer's and employees' contributions, with the respective authorities, as statutorily required.
- ii) All intending bidders, at the time of tender, shall disclose all necessary documents as to whether they are covered under the ESI Act or not.
- iii) In case they are covered under the ESI Act, they have to furnish the details of registration, failing which, their tender would be liable to be cancelled.
- iv) In case they are not covered under the ESI Act or is exempted, they would have to furnish necessary documents along with an affidavit affirmed before a 1st Class Judicial Magistrate to that effect.
- v) The said affidavit, as submitted by the bidder, shall be vetted by the Legal Department on case-to-case basis.
- vi) In case they are not covered under the ESI Act, they must additionally indemnify HDC, KoPT against all damages and accident occurring to his personnel in a Non-Judicial Stamp Paper.

3.11.6 The Contractor shall defend, indemnify and hold Trustees harmless from any liability or penalty, which may be imposed by the Central / State Government or local authorities by reason of any regulations or requirements and also from all claims, suits arising out or by reason of the work provided by this contract including any liability that may arise out of any accident whether brought by the employees of the Contractor or by the third parties or by the Central or State Government authority or any sub-division thereof.

3.12 Force Majeure :

In the event of either party being rendered unable by Force Majeure to perform any obligations required to be performed by them under the Contract, the relative obligation of the party affected by such Force Majeure shall upon notification to the other party be suspended for the period during which Force Majeure event lasts. The cost and loss sustained by either party shall be borne by respective parties. The term FORCE MAJEURE as employed herein shall mean acts of God, Earthquake, War, Revolt, Riot, Fire, Floods, Sabotage and Hurricane/Cyclone, Strike excluding that of Contractor's Suppliers or Sub-contractor's Employees.

Upon the occurrence of such case and upon its termination the party alleging that it has been rendered unable as aforesaid, shall notify the other party in writing immediately but not later than 48 (forty eight) hours of the alleged beginning and ending thereof giving full particulars.

3.13 Liquidated Damage:

If any, will be followed under Clause No. 8 of General Conditions of Contract, May, 1993 considering total completion time, as mentioned before.

3.14 In case of any disagreement or dispute between the HDC, KoPT authorities and the contractor arising out of or due to the terms and conditions of contract agreement, HDC, KoPT shall have the discretion for settlement of such disputes by appointing a Sole Arbitrator and the award so made by the Arbitrator shall be final and binding on the both parties. Jurisdiction shall be Kolkata/ Haldia only for any dispute.

3.15 Non-assignability:

No part of the contract or any share of interest therein shall in any manner or degree be transferred or assigned or sublet by the Contractor directly or indirectly to any person, firm or company whatsoever.

3.16 Contract Agreement:

The Contractor shall be required to execute at his own cost and expenses a "Contract Agreement" on a Non-Judicial Stamp paper valued at Rs 50/- or more signed jointly with HDC under official seals. The Contractor will keep indemnify against any loss of property entrusted to their security. They will also defend, indemnify and hold trustees harmless from any liability or penalty which may be imposed by any authorities. Form of such agreement will be available in the office of the Sr. Dy. Manager (P&E).

3.17 Safety:

3.17.1 The Contractor shall have to ensure safety of all their working personnel to the fullest compliance of the provisions of general safety rules / regulations including Dock Workers' (Safety, Health & Welfare) Regulations, 1986, as applicable. The Contractor shall be responsible for the safety of its workmen and employees.

3.17.2 The Contractor shall be solely responsible for consequences arising out of non-compliance or violation of safety rules / Regulation.

3.17.3 The Contractor shall have to provide (at their own expenses) all required Personal Protection Equipments (PPE) & Safety Gears for all personnel & labourers engaged during the work and in case of their failing to do so, KoPT shall provide the same and recover the cost thereof from any amount due, or which may become due to the Contractor or from any amount lying with them or under their control.

3.18 Accidents:

3.18.1 The Contractors shall have to provide medical treatment, as applicable to his staff and labourers, in case of "Accidents on Duty" which will, inter alia, include his obligations under the Workmen's Compensation Act, 1923, including all amendments thereof.

3.18.2 KoPT shall in no manner be liable to the Contractor or any person engaged/ employed by them or any other person, for injuries or death caused as a result of accidents occurred, either within or outside the site of work, under the contract. The Contractor shall be responsible for such contingencies and will make good all claims for compensation, claim by their personnel/ workmen or the families of the sufferer(s), as the case may be, or as per the decision of the appropriate authority or the tribunal or all other involved persons.

3.19 Security Deposit:

The Contractor shall have to submit to Sr. Dy. Manager (P&E) a Performance Bond in the form of Irrevocable Guarantee from any Nationalized Bank/ Scheduled Bank in India as **Security Deposit** within 15 days from the date of placement of order, in the Proforma annexed to KoPT's General Condition of Contract for a sum equivalent to **10 % of the total contract value**, which shall be valid till successful expiry of the Guarantee Period, with a claim period of three months thereafter. In all cases, any dispute regarding the Bank Guarantee will be adjudicated under the jurisdiction of Calcutta High Court.

In case of Bank Guarantee from any Nationalized Bank/ Scheduled Bank in India, outside West Bengal, it shall be routed through any Branch of corresponding Nationalized Bank/ Scheduled Bank in Haldia/ Kolkata and such corresponding Bank shall confirm the same and standby for all the commitments under the Bank Guarantee. In all cases, any dispute regarding Bank Guarantee will be adjudicated under the jurisdiction of Calcutta High Court.

Termination of contract due to failure to submit Security Deposit Bank Guarantee

Failure of the successful tenderer to submit the required **Security Deposit Bank Guarantee** shall constitute sufficient grounds for termination of the contract and **forfeiting the Earnest Money Deposit**.

Revalidation of Security Deposit Bank Guarantee

The contractor is required to revalidate the Security Deposit Bank Guarantee till 3 (three) months after expiry of the guarantee period/ extended guarantee period or contractual obligations, as per provisions of the contract.

Forfeiture of Security Deposit Bank Guarantee

The Security Deposit Bank Guarantee shall be liable to be forfeited at the option of the HDC, KoPT, if the Contractor fails to carry out the work or to perform/ observe any of the conditions of the Contract. HDC, KoPT shall be at liberty to deduct/ recover any of their dues from the Security Deposit Bank Guarantee. All compensation or any other sums of money payable by the Contractor to HDC, KoPT under the terms of Contract may be deducted from or paid by encashment of a sufficient part of the Security Deposit Bank Guarantee or from any sum due or may become due to the Contractor by HDC, KoPT on any account whatsoever and in the event of his Contract Performance Guarantee being reduced by reason of any such deduction or encashment as aforesaid, the Contractor shall within fifteen days thereafter, make good the amount so reduced, in the form of Bank Guarantee in the prescribed format.

Cost of obtaining & keeping the Security Deposit Bank Guarantee valid to be borne by the contractor

The cost of obtaining this or any other Bank Guarantee and/ or the revalidation thereof whenever required has to be borne by the Contractor and it shall be their sole responsibility to arrange for timely revalidation of such Bank Guarantee, failing which and for non-fulfilment of any contractual obligation by the Contractor, the Engineer and/ or HDC, KoPT shall be at liberty to raise claim/ demand under the Security Deposit Bank Guarantee and/ or enforce the same unilaterally. No interest/ charge of whatsoever in nature shall be paid by HDC, KoPT on the amount of Security Deposit Bank Guarantee held by HDC, KoPT, at any stage.

Return of Security Deposit Bank Guarantee

The **Bank Guarantee** submitted by the contractor towards the performance of the contract, will be returned to the contractor after successful completion of the contract (including Guarantee Period and fulfilment of all contractual obligations), to the satisfaction of HDC, KoPT and on making an application thereof, along with **“No Claim Certificate”**.

- 3.20 Completeness of Contract:** Any fittings, accessories or apparatus which may not have been specifically mentioned in the Bill of Quantities, Scope of Work etc. but which are necessary in the equipment of similar installation or for the efficient working after installation shall be deemed to be included in the contract and shall be furnished by the contractor.

- 3.21 The Guarantee** will be covered for a period of 12 months from the date of handing over of the installations to HDC, KoPT. In default, the Trustees will be at liberty to get the repairs done at the risk and cost of the Contractor. However, lamps and fuses will not be covered under this Guarantee Clause.

The job executed at different area/ zone may be taken over by Haldia Dock Complex in phases and in that case, guarantee will be applicable accordingly.

3.22 ELECTRICITY, WATER SUPPLY & USE OF LAND:

- 3.22.1 **WATER, if available** may be provided to the contractor, for execution of the work on **CHARGEABLE BASIS**. The contractor will have to arrange every thing in this regard, at his own risk, cost and arrangement.

- 3.22.2 **ELECTRICITY, if available** may be provided to the contractor, at their office, store, workshop etc., if any, on **CHARGEABLE BASIS, as per the prevailing electricity tariff of HDC**.

ELECTRICITY, if available may be provided to the contractor, for execution of the work at site, in connection with installation & commissioning of different items, on **FREE OF COST BASIS**.

However, the contractor will have to arrange every thing in this regard, at his own risk, cost and arrangement.

- 3.22.3. **USE OF LAND:** The contractor shall be allowed to use a suitable land (open space), which in the opinion of HDC may be absolutely necessary for the proper and efficient execution of work. For this, a token lump sum License Fee of **Rs 10.00 per month or part thereof** will be charged during currency of the contract and extension thereof, if any. On completion of works or termination of the contract, the contractor shall have to clear away all his tools, plants, rubbish and other materials within a fortnight and hand over vacant and peaceful possession of the same to HDC in a tidy and clean condition. The contractor shall be allowed to erect any temporary structures on this land for **office, store, workshop** etc. and make all suitable arrangement for water supply, electricity supply and sanitary arrangements for the same, at their own risk & cost.

- 3.23 Indemnity Bonds** to be submitted separately by the Contractor under KoPT's Proforma through Notary Public, Govt. of West Bengal, before taking out any material from HDC's site/ store for laying/ installing at site etc.

- 3.24** The contractor should arrange by their own, necessary tools, tackles, lifting machineries, scaffolding arrangement, different vehicular transport etc., required for execution of the total work.

- 3.25** For bringing the materials at site, if Way Bill is required, the same will have to be arranged by the contractor, at their own risk, cost and arrangement.

- 3.26 HINDRANCE REGISTER :** The contractor will have to maintain 'Hindrance Register' at site as per the format provided at Annexure- XI.

3.27 INSPECTION & TESTING

- 3.27.01 The Engineer or his Representative shall have, at all reasonable time, access to the contractor's premises or work site or other premises (if a part of the work is being manufactured there) and shall have the power at all reasonable time to **inspect, examine & test the materials & workmanship** of the work during its manufacture.

- 3.27.02 The Engineer or his authorised representative, on giving seven days notice in writing to the contractor, setting out any ground of objections, in respect of the work, shall be at liberty to

reject all or any materials or workmanship in the subject of any of the said grounds of objection, which are not in accordance with the contract.

- 3.27.3 In case of sub- letting to other contractors or manufacturers or suppliers by the contractor, the Engineer will reserve the right as follows:
- i) that inspection and / or testing will be carried at the sub- contractor's works or
 - ii) that inspection will be carried out at site or
 - iii) that inspection will be waived subject to the contractor furnishing a certificate of compliance with specification by a competent authority recognized by national/ international institutes.
- 3.27.4 In all cases where the tests are required, whether at the premises of the contractor or any sub-contractor or elsewhere, the contractor, except where otherwise specified, shall provide free of charges such labour, materials, electricity, fuel, water, stores, apparatus and instruments as may reasonably be demanded, to carry out sufficiently such tests and shall at all times facilitate the Engineer or his representatives and the Third Party Inspection Agency, to accomplish such testing.
- 3.27.5 The cost of all tests and/ or analysis effected at the contractor's or sub- contractor's works and on the site shall be borne by the contractor. The cost of independent test and/ or analysis, which the Engineer or his authorised representative may cause to be made and which prove satisfactory shall be borne by the contractor and also the contractor will be called upon to pay all expenses incurred by the employer in respect of any work found to be defective or of inferior quality, adulterated or otherwise unacceptable.
- 3.27.6 On **completion of fabrication** of all items at the contractor's premises and also when installation/ final adjustments at site are completed in accordance with the contract, the contractor shall give a 7 days notice to the Engineer in writing (informing the date on which they will be ready to make the tests), before carrying out such tests, in accordance with and in the manner prescribed in the specifications.
- 3.27.7 If any portion of work fails under the tests to fulfil the contract conditions, tests of the faulty portion shall, if required by the Engineer or by the contractor, be repeated within reasonable time upon the same terms and conditions.
- 3.27.8 If such Tests on completion can not be carried out successfully by the contractor within one month after the time fixed by the contractor and if in opinion of the Engineer the tests are being unduly delayed, the Engineer may, in writing, call upon the contractor, with seven days notice to make such tests, failing which the Engineer may proceed to make such tests himself, at the contractor's risk and expense. In the above eventuality, the employer shall nevertheless have the right of using the installations at the contractor's risk until the 'tests on completion' are successfully carried out.
- 3.27.9 Notwithstanding the fact that the materials or part of equipment or the whole equipment has passed the inspection, the contractor is not relieved from his obligations to conform to the quality, workmanship, guaranteeing the performance etc., as per the contract.
- 3.27.10 Insulation Resistance, Earth Continuity and Earth Resistance Tests, as applicable, prior to commissioning will have to be carried out for electrical installations.
- 3.27.11 Before any electrical system is put to use, the contractor shall carry out all the tests as per Indian Electricity Rules, 1956, with latest amendments if any, for electrical installations.

3.28 **Other Terms and Conditions :**

Notwithstanding anything contained herein, the contract will generally be guided by the **General Conditions of Contract (GCC) of Kolkata Port Trust**, duly approved by the Board of Trustees in May, 1993, as well as the Major Port Trust Act, 1963, and subsequent amendments thereof, if any, unless otherwise specified.

4 SCOPE OF WORK AND TECHNICAL SPECIFICATION**SCOPE OF WORK**

Construction of a ROB-cum-Flyover, at Ranichak, Haldia, by National Highway Authority of India (NHAI), is under progress. For the purpose of construction of the said ROB-cum-Flyover at Ranichak, Haldia, existing utilities of HDC (i.e. 11 kV overhead line & 11 kV underground cable network) would have to be shifted.

Presently, 11 kV overhead line & 11 kV underground cable network of HDC exist at the proposed location for construction of the ROB-cum-Flyover. These 11 kV network are connected in between (i) Intake Sub-station at Chiranjibpur and 3rd Oil Jetty Sub-station, for feeding power supply (Dock supply) to 3rd Oil Jetty & its adjacent area including Jawahar Tower, CISF Barrack, Central Garage etc. and (ii) Intake Sub-station at Chiranjibpur and Sub-station No. 3, at KoPT Township, at Haldia Township, for feeding power supply (Residential supply) to Haldia Township area. These 11 kV overhead line & 11 kV underground cable network, which exist at the proposed location for construction of the ROB-cum-Flyover, would be defunct.

For the purpose of maintaining power supply at 3rd Oil Jetty & its adjacent area (Dock supply) and at Haldia Township area (Residential supply), new 11 kV (Earth) grade XLPE insulated HT cable along with Hume Pipes & G.I. Pipes would have to be laid underground, at the service corridor, along with other allied work like termination of the said new cables with our existing cable network & overhead line network, at both ends.

Required cable, Hume Pipes & G.I. Pipes would be handed over to the contractor, by HDC, for the purpose of laying/ installation at site. The contractor would have to collect the said materials from the stores of HDC, situated inside Dock area of HDC, on submission of Indemnity Bond(s).

For the purpose of termination of the said new cables with our existing cable network & overhead line network, at both ends, for construction of 4 Pole (Rail) structure with supports, required rails (old & used) would be supplied to the contractor by HDC.

On completion of the job, the contractor would have to return back excess quantity of the said Cables, Hume Pipes, G.I. Pipes & Rails (old & used) to HDC, with proper acknowledgement, which would not be required to be laid/ installed at site. The contractor would also have to deposit the empty cable drums, at the stores of HDC, with proper acknowledgement.

No project surplus material (excepting the items which would be issued to the contractor by HDC, as mentioned above) will be taken over by HDC/ KoPT after completion of the work.

Contractor's Engineers/ Supervisors responsible for execution of the work at site shall have valid Electrical Supervisory License.

Quantity of different materials/ items mentioned in the **Bill of Quantity – Un-priced** of the Tender document is indicative only. There may be variation depending upon site conditions.

Indemnity Bonds are to be submitted separately by the Contractor under KoPT's Proforma, through Notary Public, Govt. of West Bengal, before taking out any material from HDC's site/ store, for fixing/ laying/ installation at site. The contractor should arrange to collect the material, from HDC's site/ store, at his own risk, cost & arrangement.

The contractor will have to submit the cable route diagram with details of quantity and locations of the Hume Pipes and G.I. Pipes to be used, position of the straight through cable joints etc. to the Sr. Dy. Manager (P&E), HDC, in triplicate, **for necessary approval**.

For preparation of cable route diagram, plan drawings of the area of work will be provided by HDC, to the contractor, within 7 (seven) days, from the date of placement of order.

QAP/ Inspection Plan for different items should be submitted by the contractor, within 7 (seven) days, from the date of placement of order, for necessary approval by Sr. Dy. Manager (P&E), HDC.

Bar Chart of the total work should also have to be submitted by the contractor, within 7 (seven) days, from the date of placement of order.

The contractor shall have to submit **As Built Drawings** in triplicate, which shall indicate the cable route so laid with reference to permanent installations en route, clearly marking position of the cable there at, sizes of the cables, locations of straight through joints, locations (with respective length) of Hume Pipes, GI Pipes & culverts/ tunnels/ trenches and other details, as found necessary.

Site Inspection :

It is requested to inspect the site of work and thoroughly familiarize with the nature of work, site conditions, access to the site and location before submission of the offer. It is also requested to contact with the concerned official(s) at the office of Plant & Equipment Division, Haldia Dock Complex, at Operational Administrative Building of HDC at Chiranjibpur, for collecting further information about the site, before submission of the offer.

GENERAL REQUIREMENTS:

1. **All materials** required for the entire work should be as per latest **Indian Standard (IS)**, issued by **Bureau of Indian Standard**, if not specified otherwise in this tender document.
2. The entire job should be executed in accordance with the requirements of following **Acts and Rules**, including latest amendments :-
 - a) Indian Electricity Rules – 1956
 - b) Electricity Laws (Amendment) Ordinance, 1997
 - c) Central Electricity Authority Rules, 1977
 - d) Central Electricity Authority Regulations, 1979
 - e) Indian Electricity Act, 2003.

The supply, installation and commissioning of all items required for this work should be complied with the above **Acts & Rules** and relevant **Code of Practice** of the **Bureau of Indian Standard**, including **National Electrical Code**, if not specified otherwise.

3. Relevant aspects of following **Rules/ Code of Practices** should also be followed and complied with :
 - i) Indian Factories Act.
 - ii) Dock Workers (Safety, Health & Welfare) Act 1987.
 - iii) The Workmen's Compensation Act, 1923.
 - iv) The Minimum Wages Act, 1948.
 - v) The Contract Labour (Regulation & Abolition) Act, 1970.
 - vi) Other local regulations.
4. Laying of cables, cable end termination and straight through joints with the cables are to be executed by a Cable Jointer (having valid Electrical Workman's Permit, authorised for 11,000 Volts grade Cable laying and jointing, by the competent authority), under continuous supervision of the Contractor's Engineers/ Supervisors, holding certificate of competency.
5. Programme for **Road Crossing, Railway Track Line Crossing** wherever required (for Casing Pipe laying etc.), shall have to be coordinated through the authorized representative of the Sr. Dy. Manager (P&E) in advance, for having due clearance of

blockage of Road/ Rail. Such clearance will be given within 7 (seven) days from the date of receipt of request from the contractor.

In case of **Road Crossing**, 50 % of the road width should be kept open for vehicular traffic movement. All roads so cut for the work, should be made good immediately after the purpose of road cutting is fulfilled.

6. During execution of the work, if any damage takes place in the property of HDC, the same will have to be mended good by the contractor, at their risk, cost and arrangement. Otherwise, the same will be repaired/ replaced by HDC, either departmentally or through outside agency and the cost of repairing/ replacement will be recovered from the contractor, with departmental charges.
7. The lengths of Reinforced Concrete Pipes, Galvanised Mild Steel Tubes, length of cable run through existing duct/ trench/ tunnel/ laid pipe/ installed cable tray inside the existing tunnel etc., as given in the Bill of Quantities are indicative only. The contractor shall have to ascertain the exact quantity and execute the work accordingly.
8. The contractor should have valid **Electrical Contractor's Licence** and supervisors having **Supervisory Certificate of Competency of relevant part**, for carrying out such type of job.
9. The Contractor should arrange, at their own risk & cost, **all necessary tools, tackles, lifting machineries, different vehicular transport** etc., required for execution of the total work.
10. **Danger Notice** Plates (designed as per IS: 255) for the 11,000 Volts installations shall have to be affixed by the contractor, permanently, in a conspicuous position, as applicable, in accordance with **Indian Electricity Rules, 1956**.
11. For the purpose of application (by HDC, KoPT) for obtaining necessary approval/ clearance from the Regional Inspectorial Organization, Central Electricity Authority / Statutory Authority, the contractor would have to submit/ deposit required documents, drawings, test certificates/ reports etc. to HDC, KoPT. The contractor along with the required documents, drawings, test certificates/ reports etc. would also have to be present during inspection by the Regional Inspectorial Organization, Central Electricity Authority / Statutory Authority.

The contractor should clearly understand that though the application would be made by HDC, KoPT to the Regional Inspectorial Organization, Central Electricity Authority / Statutory Authority, for obtaining necessary approval/ clearance from them, it is the responsibility of the contractor concerned to obtain the approval/ clearance from the Regional Inspectorial Organization, Central Electricity Authority / Statutory Authority against the work executed by the contractor.

TECHNICAL SPECIFICATIONS

WORK NOT SPECIFIED:

The workmanship of works not fully specified herein shall have to be carried out as per relevant Standard Specifications and in absence thereof shall be as per the best standard practice as approved by the Engineer of Kolkata Port Trust.

CABLING WORK:

CABLE JOINTING KITS:

Good quality Polyurethane type/ Heat Shrinkable type straight through Cable Jointing Kits, suitable for XLPE insulated 11 KV (Earth) grade HT cables, as detailed against BoQ Item Sl. No. 1 (a) are to be used.

SPECIFICATION OF MISCELLANIOUS MATERIALS REQUIRED FOR CABLING SYSTEM

i) CABLE LUGS AND SOCKETS :

Cable termination shall have to be done with Aluminium/ tinned copper Crimping type Solderless Lugs/ Sockets.

ii) **CABLE IDENTIFICATION** :

PVC Cable Tags of suitable sizes will have to be provided.

iii) **BI- METALIC WASHER** :

Where Copper to Aluminium connections are to be made, Bimetallic washers shall be used.

iv) **BRICKS** :

Crushing strength, efflorescence shall conform to class designation 10 (as per IS 1077, 1986) and as per the specification, given below:

- i) The brick shall have clear ringing sound.
- ii) The average size of the bricks shall be in the range of 250 mm (± 4 mm) x 125 mm (± 2 mm) x 75 mm (± 2 mm).

CABLE LAYING (General Guideline) :

Cable Net Work shall include Power Cables, which shall be laid in buried trenches/ cable trays/ through G.I. Pipes & Hume Pipes, rising main etc. whichever is applicable.

Cable routing shall be checked in the field to avoid interference with structures, heat sources, drains, piping etc. as far as possible and minor adjustments shall be done to suit the field conditions, wherever deemed necessary without any extra cost.

The HT cables while laying will have to be separated from existing HT, LT, Telecommunication, OFC Cables by adequate spacing or running through independent pipes, trenches or cable trays, as applicable.

All cable routes shall be carefully measured and cables cut to the required lengths leaving sufficient lengths for the final connections of the cables to the terminal of the equipments. The various cable lengths cut-off from the cable reels shall be carefully selected to prevent undue wastage of cables. The quantity indicated in the Bill of Quantity is only approximate. The Contractor shall ascertain the exact requirement of cable for a particular feeder by measuring at site and avoiding interference with structure, foundation, pipelines or any other works as far as possible. Before starting Cable Laying, Cable Drum Schedule shall be prepared by contractor and get that approved by Sr. Dy. Manager (P&E) or his authorized representative to minimize/avoid straight through joints. The actual number of straight through joints required shall be worked out by the contractor. Cable as far as possible shall be laid in complete, uncut lengths from one termination to other.

Cable shall be neatly arranged in the trenches/ trays/ pipes in such a manner so that criss-crossing is avoided and final take- off to the equipment/switch gears is facilitated.

Arrangement of cables within the trenches/ trays/ pipes shall be the responsibility of the contractor.

All cables will be identified close to their termination points by cable nos. Cable numbers will be punched on Aluminium strip/ PVC Strip {2mm. thick (approx.)} securely fastened to the cable and wrapped around it. Alternatively Cable Tags shall be circular in construction to which cable number can be conveniently punched.

Each underground cable shall be provided with Identification Tags (made of PVC) securely fastened at every 30 Mtrs. distance if the continuous length is more than 50 Mtrs. of its underground length. At least one tag at each end before the cable enters the ground will have to be provided. In unpaved areas, Cable Trenches shall be identified (by means of cable markers). These shall be placed at location of changes in the direction of cables and at intervals of not more than 30 Mtrs. and at Cable Joint Locations.

Removal of concrete covers for purposes of cable laying and reinstalling them in their proper positions after the cables are laid shall be done by the contractor at no extra cost.

Cable shall be handled carefully during installation to prevent mechanical injury to the cables. During laying of cables, Cable Drum Lifting Jacks, sufficient numbers of Cable Rollers and other materials etc. as necessary must be used to avoid any mechanical injury to the cables.

Directly buried cable shall be laid underground in Cable Trenches duly excavated by the contractor as shown in the enclosed Drawing No.: SK- 334. The width of the trench shall vary depending upon the number of cables and diameter of each cable.

Width of the Cable Trench should be such that all cables should be correctly spaced and arranged. The cables shall be laid in trenches as shown in the enclosed sketch. Before cables are placed, the bottom of the trench shall be leveled and filled with a layer of silver sand as shown in the Drawing No.: SK- 334. This sand shall be leveled and the cables shall be laid over it. Bricks to be placed at both sides of the cable. Then the cable inside the brick walls to be covered with sand up to the height of walls and sand shall be pressed lightly.

A protective covering of Bricks shall be placed on top of protective Bricks placed at both sides of Cable. The remainder of the trench shall then be back filled with soil rammed and leveled.

After laying of the cables in the trench and before placement of protective covering by brick, every cable shall be given an insulation test in presence of site engineer/ authorized representative of Sr. Dy. Manager (P&E). Also after back filling the trench with soil, rammed and leveled, insulation test of the cable shall be carried out in presence of Site Engineer/Authorized representative of Sr. Dy. Manager (P&E).

All wall openings/Pipe Sleeves shall be effectively sealed after installation of cables to avoid seepage of water inside buildings/lined trench.

At road/drain/pavements crossing, suitable sizes of G.I. Pipes are to be used.

After the cables are installed and all testing is complete, the conduit/pipe sleeve ends shall be plugged with a suitable weatherproof plastic compound/ PUTTI, for sealing purpose. The cost of the same shall be deemed to have been included in the installation of cable laying through pipe sleeves/conduits and no separate payment shall be made.

When cables pass through foundation walls, or other underground structures, if necessary, ducts or opening shall have to be provided by the contractor. However, shall it become necessary to cut holes in the existing foundations or structures, the contractor shall determine their locations and obtain approval from Sr. Dy. Manager (P&E) or his authorized representative before cutting is done. Cutting, if necessary and mending good of any cut portion should be done by contractor without any extra cost.

At Road Crossing and other places where cables enter pipe sleeves, adequate bed of sand shall be given so that the cables do not stack and get damaged by pipe ends. Drum number of each cable from which it is taken shall be recorded against the cable number in the cable schedule.

All G.I. Pipes shall be laid as per site requirements. The open ends of the pipes shall be suitably plugged after they are laid in final position.

Laying of the cable will be as per the enclosed Drawing No. SK- 334.

The contractor will have to submit the detailed cable route diagram, with detailing of the Hume Pipes & G.I. Pipes used, position of the straight through cable joints etc. for checking at our end and subsequent approval of the same.

As built drawing (in triplicate) of the above cable route will have to be submitted after completion of the above work.

MEASUREMENT: Cable length should be measured jointly prior to giving clearance for earth back filling etc. Distance between Socket of one end and Socket of other end of the laid cable to be considered for payment against both supply & laying of cable.

SCOPE OF WORK FOR STRAIGHT THROUGH CABLE JOINTING :

Additional length (Loop) of 5 mtrs. (approx.) cable should be kept at each end of the cables near the straight through cable joints.

It is required to measure the insulation resistances of the cables before and after straight through cable jointing.

This scope includes supply of all required materials including complete straight through cable jointing kits, with ferrules and all other accessories.

LAYING OF REINFORCED CONCRETE PIPE AND GALVANIZED MILD STEEL TUBES

Laying of Reinforced Concrete Pipe and Galvanized Mild Steel Tubes should be done wherever necessary, such as at Road Crossing, Railway Crossing, Drains, Culverts or any similar concrete structure etc. The scope includes cutting of road, Railway Crossing, Excavating of Trenches, etc. including mending good work. The depth of laying of the pipes should have to be matched with the underground cable trench, as far as possible and practicable.

Making jointing between collars and pipes, with cement mortar (1 cement: 2 medium sand) and cutting the Reinforced Concrete Pipe to the required length, if necessary, to be done by the contractor at their own cost and arrangement.

Cutting of Galvanized Pipe to required length and threading, bending, jointing by Socket as required, supply and fixing of support clamps/ brackets should be under the scope of contractor.

Re-filling of the trench after laying the reinforced concrete pipes and galvanized mild steel tubes are also to be done by the contractor.

Rates are to be quoted accordingly.

The Contractor shall not be responsible for the correctness of the design or specification of the Temporary and Permanent works formulated by the Engineer; but the Contractor shall be fully responsible for the correct implementation thereof, as also for any design and specification prepared/proposed/used by the Contractor. - 4.9** Whenever required by the Engineer or his representative, the Contractor shall submit to him the details of his (a) programme for execution of the work, (b) proposed procedure and methods of work, (c) proposed deployment of plant, equipment, labour, materials and temporary works. The submission to and/or any approval by the Engineer or his Representative to any such programme or particulars shall not relieve the Contractor of any of his obligations under the contract.
- If for any reason the contractor be unable to adhere to his earlier programme, he shall submit his revised programme for completion of work within the stipulated time whenever asked to do so.
- 4.10** Necessary and adequate supervision shall be provided by the Contractor during execution of the works and as long thereafter as the Engineer or his representative shall consider necessary during the maintenance period. - 8.0 DELAY / EXTENSION OF COMPLETION TIME / LIQUIDATED DAMAGE / TERMINATION OF CONTRACT**
- 8.1** Should the quantum of extra or additional work of any kind or delayed availability of the Trustees' materials to be supplied as per contract or exceptionally adverse climatic conditions and natural phenomenon or strikes, lock-outs, civil commotion or other special circumstances of any kind beyond the control of the Contractor, cause delay in completing the work, the contractor shall apply to the Engineer in writing for suitable extension of completion time within 7 days from the date of occurrence of the reason and the Engineer shall thereupon consider the stated reasons in the manner deemed necessary and shall either reject the application or determine and allow in writing the extension period as he would deem proper for completion of the work, with or without the imposition of "Liquidated Damage" Clause (No.8.3 hereof) on the Contractor and his decision shall be binding on the Contractor. If an extension of completion time is granted by the Engineer, the Clause No.8.3 of the Liquidated damage shall apply from its date of expiry, if the work be not completed within the extended time, unless stated otherwise in the decision communicated by the Engineer, as aforesaid. **Extension of completion time**
- 8.2** (a) If the Contractor fails to complete the work within the stipulated dates or such extension thereof as communicated by the Engineer in writing, the Contractor shall pay as compensation (Liquidated Damage) to the Trustees and not as a penalty, ½% (half percent) of the total value of work (contract price) as mentioned in the letter of acceptance of the tender/offer, for every week or part thereof the work remains unfinished. Provided always that the amount of such compensation shall not exceed 10% of the said value of work. **'Liquidated Damage' and other compensation due to Trustees**

(b) Without prejudice to any of their legal rights, the Trustees shall have the power to recover the said amount of compensation/damage in Sub-clause (a) of this clause, from any money due or likely to become due to the Contractor. The payment or deduction of such compensation/damage shall not relieve the Contractor from his obligation to complete the work or from any of his other obligations/liabilities under the contract and in case of the Contractor's failure and at the absolute discretion of the Engineer, the work may be ordered to be completed by some other agency at the risk and expense of the Contractor, after a minimum three days notice in writing has been given to the Contractor by the Engineer or his Representative.

- 8.3** Without being liable for any compensation to the Contractor, the Trustees may, in their absolute discretion, terminate the contract and enter upon the site and works and expel the Contractor there from after giving him a minimum 3 days' notice in writing, due to occurrence of any of the following reasons and decision of the Trustees in this respect, as communicated by the Engineer shall be final and conclusive :
- Default of the Contractors remedies & powers/Termination of Contract.**
- (i) The Contractor has abandoned the contract.
 - (ii) In the opinion of the Engineer, either the progress of work is not satisfactory or the work is not likely to be completed within the agreed period on account of Contractor's lapses.
 - (iii) The Contractor has failed to commence the works or has without any lawful excuse under these conditions, has kept the work suspended for at least 15 days despite receiving the Engineer's or his Representative's written notice to proceed with the work.
 - (iv) The Contractor has failed to remove materials from site or to dismantle or demolish and replace work for 7 days after receiving from the Engineer or his representative the written notice stating that the said materials or work were condemned and rejected by him under these conditions.

- (v) The Contractor is not executing the works in accordance with the contract or is persistently or flagrantly neglecting to carry out his obligations under the contract.
- (vi) Any bribe, commission, gift or advantage is given, promised or offered by or on behalf of the contractor to any officer, servant or representative of the Trustees or to any person on his or their behalf in relation to the obtaining or to the execution of the contract.
- (vii) The Contractor is adjudged insolvent or enters into composition with his creditors or being a company goes into liquidation either compulsory or voluntary.

8.3.1 Upon receipt of the letter of termination of work, which may be issued by the Engineer on behalf of the Trustees, the Contractor shall hand over all the Trustees' tools, plant and materials issued to him at the place to be ascertained from the Engineer, within 7 days of receipt of such letter.

8.3.2 In all such cases of Termination of work, the Trustees shall have the power to complete the work through any other agency at the Contractor's risk and expense and the Contractor shall be debited any sum or sums that may be expended in completing the work beyond the amount that would have been due to the Contractor, had he duly completed the whole of the work in accordance with the contract.

8.3.3 Upon termination of contract, the Contractor shall be entitled to receipt payment of only 90% of the value of work actually done or materials actually supplied by him and subject to recoveries as per contract, provided the work done and materials conform to specifications at the time of taking over by the Trustees. The payment for work shall be based on measurements of actual work done and priced at approved contract rates or other rates, as decided by the Engineer. The payment for materials supplied shall be at the rates as decided by the Engineer, which shall in no case be more than market rates prevailing at the time of taking over by the Trustees. The Engineer's decision in all such case shall be final, binding and conclusive.

8.3.4 The Trustees shall have the power to retain all moneys due to the Contractor until the work is completed by other agency and the Contractor's liabilities to the Trustees are known in all respect.

- 9.0 MAINTENANCE AND REFUND OF SECURITY DEPOSIT**
- 9.1** On completion of execution of the work the Contractor shall maintain the same for a period, as may be specified in the form of a Special Condition of the Contract, from the date mentioned in the Initial Completion Certificate in Form G.C.1. Any defect/fault, which may appear in the work during aforesaid maintenance period, arising, in the sole opinion of the Engineer or his representative, from materials or workmanship not in accordance with the contract or the instruction of the Engineer or his representative, shall, upon the written notice of the Engineer or his representative, be amended and made good by the Contractor at his own cost within seven days of the date of such notice, to the satisfaction of the Engineer or his representative, failing which the Engineer or his representative shall have the defects amended and made good through other agency at the Contractor's risk and cost and all expenses, consequent thereon or incidental thereto, shall be recoverable from the Contractor in any manner deemed suitable by the Engineer.
- 9.2** The Contract shall not be considered completed and the work shall not be treated as finally accepted by the Trustees, until a Final Completion Certificate in Form G.C.2 annexed hereto shall have been signed and issued by the Engineer to the contractor after all obligations under the Contract including that in the maintenance period, if any, have been fulfilled by the Contractor. Previous entry on the works or taking possession, working or using thereof by the Trustees shall not relieve the Contractor of his obligations under the contract for full and final completion of the work.
- 9.3** On completion of the contract in the manner aforesaid, the Contractor may apply for the refund of his Security Deposit by submitting to the Engineer (i) The Treasury Receipts granted for the amount of Security held by the Trustees, and (ii) his "No further claim" Certificate in Form G.C.3 annexed hereto (in original), where upon the Engineer shall issue Certificate in Form G.C.2 and within two months of the Engineer's recommendation, the Trustees shall refund the balance due against the Security Deposit to the Contractor, after making deduction therefrom in respect of any sum due to the Trustees from the Contractor.

- 10.0 INTERPRETATION OF CONTRACT DOCUMENTS, DISPUTES AND ARBITRATION**
- 10.1** In all disputes, matters, claims, demands or questions arising out of or connected with the interpretation of the Contract including the meaning of Specifications, drawings, designs and instructions or as to the quality of workmanship or as to the materials used in the work or the execution of the work whether during the progress of the works or after the completion and whether before or after the determination, abandonment or breach of the contract the decision of the Engineer shall be final and binding on all parties to the contract and shall forthwith be given effect to by the Contractor. **Engineer's decision**
- 10.2** If, the Contractor be dissatisfied with any such decision of the Engineer, he shall within 15 days after receiving notice of such decision require that the matter shall be referred to Chairman, who shall thereupon consider and give a decision. **Chairman's award.**
- 10.3** If, however, the Contractor be still dissatisfied with the decision of the Chairman, he shall, within 15 days after receiving notice of such decision require that within 60 days from his written notice, the Chairman shall refer the matter to an Arbitrator of the panel of Arbitrators to be maintained by the Trustees for the purpose and any such reference shall be deemed to be a submission to arbitration within the meaning of Indian Arbitration Act, 1940 or any statutory modification thereof. **Arbitration.**
- 10.3.1.** If the Arbitrator so appointed is unable or unwilling to act or resigns his appointment or vacates his office due to any reason whatsoever, another person from panel shall be appointed as Sole Arbitrator and he shall proceed from the stage at which it was left by his predecessor.
- 10.3.2** The Arbitrator shall be deemed to have entered on reference on the date he issues notice to both the parties fixing the date of first hearing.
- 10.3.3** The time limit within which the Arbitrator shall submit his award shall normally be 4 months as provided in Indian Arbitration Act, 1940 or any amendment thereof. The Arbitrator may, if found necessary, enlarge the time for making and publishing the award, with the consent of the parties.

- 10.3.4** The venue of the arbitration shall be either Calcutta or Haldia as may be fixed by the Arbitrator in his sole discretion. Upon every or any such reference the cost of any incidental to the reference and award respectively shall be in the discretion of the Arbitrator who may determine, the amount thereof or by whom and to whom and in what manner the same shall be borne and paid.
- 10.3.5** The Award of the Arbitrator shall be final and binding on all parties subject to the provisions of the Indian Arbitration Act 1940 or any amendment thereof. The Arbitrator shall give a separate award in respect of each item of disputes and respective claim referred to him by each party and give reason for the award.
- 10.3.6** The Arbitrator shall consider the claims of all the parties to the contract – within only the parameters of scope and conditions of the contract in question.
- 10.3.7** Save as otherwise provided in the contract the provisions of the Arbitration Act, 1940 and rules made thereunder, for the time being in force, shall apply to the arbitration proceedings under this Clause.
- 10.4** The Contractor shall not suspend or delay the work and proceed with the work with due diligence in accordance with Engineer's decision. The Engineer also shall not withhold any payment, which, according to him, is due or payable to the Contractor, on the ground that certain disputes have cropped up and are likely to be referred to arbitration.
- 10.5** Provided always as follows:
- [a]** Nothing of the provisions in paragraphs 10.3 to 10.3.7 hereinabove would apply in the cases of contracts, where tendered amount appearing in the letter of acceptance of the tender / offer is less than Rs.40,00,000/-.
 - [b]** The Contractor shall have to raise disputes or differences of any kind whatsoever in relation to the execution of the work to the Engineer within 30 days from the date of occurrence of the cause of dispute and before the preparation of the final bill, giving detailed justifications, in the context of contract conditions.

- [c] Contractor's dispute, if any, arising only during the maintenance period, if any, stipulated in the contract, must be submitted to the Engineer, with detailed justifications in the context of contract Conditions, before the issuance of final completion certificate in Form G.C, 2.**

No dispute or difference on any matters whatsoever, pertaining to the Contract can be raised by the contractor after submission of certificate in Form G.C. 3 by him.

- [d] Contractor's claim / dispute raised beyond the time limits prescribed in sub-clauses 10.5[b] and 10.5 [c] hereinabove, shall not be entertained by the Engineer and / or by any Arbitrator subsequently.**
- [e] The Chairman / Trustees shall have the right to alter the panel of Arbitrators, vide Clause 10.3 hereinabove, on their sole discretion, by adding the names of new Arbitrators and / or by deleting the names of existing Arbitrators, without making any reference to the Contractor.**
