NOTICE INVITING E-TENDER

E-Tender under two part system (Part I: Techno-Commercial Bid and Part II: Price Bid) are invited on behalf of Haldia Dock Complex (HDC), Kolkata Port Trust (KoPT), from the reliable, bonafide & experienced agency having following Pre-qualification Criteria for Hiring of one Diesel Electric/Diesel Hydraulic Locomotive of 1350 HP/1400 HP or above on wet Lease basis for a period of 24 months.

1.1 <u>Pre-qualification Criteria</u> :

Any Firm fulfilling the following criteria will be considered eligible.

1.1.1 <u>Criteria with respect to experience</u> :

The bidder's experience of having completed similar work during last <u>7 years</u> up to March 2017, i.e. from 01.04.2010 to 30.03.2017 which should be in the following manner:-

- a) Three similar completed works each costing not less than the amount equal to <u>Rs 1,46,40,000.00</u> (Rupees One crore forty six lakh forty thousand) only.
- b) Two similar completed work each costing not less than the amount equal to <u>Rs 1,83,00,000.00</u> (Rupees One crore eighty three lakh) only

Documents viz. order letter(s) and successful completion certificate(s) along with the format for 'Experience Details of the Bidder', as per **Annexure – X**, duly filled in, are to be submitted [duly signed and stamped by the bidder] in support of experience of the bidder.

Similar work means successful execution of the direct contract for

- 1) Supply including operation & maintenance of <u>Diesel Electric/Diesel Hydraulic Locomotive</u>, turbo charged, DC-DC /AC-AC /AC-DC transmission or equivalent should be owned/leased by the firm.
- 2) The age of Locomotive should not be more than 05(five) years as on the last date of submission of the tender.
- 3) The firm should have minimum **two years** experience in the field of Locomotive hiring to any large thermal Power Utilities, Public Sector, Govt. Sector, or any large/reputed industries.
- 4) The firm should have knowledge about Railway traffic and Locomotive related operation & maintenance work.
- 5) Certificate from employer to be furnished.

Note: In case any composite work order is submitted as credential then the exact executed work order value corresponding to the specified nature of job / similar job as defined above will be considered for evaluation and the same needs to be clearly mentioned & should be supported by documentary evidence corresponding to the value as defined under 1.1.1 (a), 1.1.1(b) & 1.1.1(c) as the case may be, otherwise the credential will not be considered.

Completed work: Completed work means the executed/completed portion of work order/ AMC/RC, even if the work has not been completed in totality subject to furnishing proof of executed value of the work in the form of certified copies of RA bills or certificate from the organization (Where the bidder has worked) to this effect that the job to this extent has been done by the bidder satisfactorily.

Experience as sub-contractor shall not be considered.

1.1.2 Criteria with respect to financial capability

Average Annual Financial Turnover of **Rs 1,09,80,000.00 (Rupees One crore nine lakh eighty thousand)** only during the last three financial years ending **31.03.2017**.



Copies of audited Annual Accounts including the **Balance Sheet** and **Profit and Loss Statement** for the last 3 financial years ended on **31.03.2017** are to be submitted [duly signed and stamped by the bidder] in support of financial capability of the bidder. The auditor, in all such cases, must be a qualified Chartered Accountant.

15.	The bidders must upload all the documents required as per terms of NIT. Any other document uploaded which is not required as per the terms of the NIT shall not be considered.
16	The bid will be evaluated based on the filled-in technical & commercial formats.
17.	The documents uploaded by bidder(s) will be scrutinized. In case any of the information furnished by the bidder is found to be false during scrutiny, EMD of defaulting bidder(s) will be forfeited. Punitive action including suspension and banning of business can also be taken against defaulting bidders.
18.	Necessary addendum/ corrigendum (if any) of tender would only be hosted in the e-tendering portal of MSTC Ltd.
19.	Micro & Small Enterprises (MSEs) registered with NSIC (under single point registration scheme), having valid NSIC Certificate for MSEs along with DIC's (DISTRICT INDUSTRIES CENTRE) Certificate, are exempted from depositing Bid Document Fee and Earnest Money.
20.	Micro & Small Enterprises (MSEs) registered with NSIC under Single Point Registration Scheme (SPRS) are eligible to get the benefits under new Public Procurement policies for MSEs as notified by Govt. of India, Ministry of Micro, Small & Medium Enterprises (MSME) vide Gazette Notification, dated 26.03.2012.
	When splitting of tender quantity is not possible purely on technical ground, Trustees reserve the right not to negotiate price with MSE if their price is within the band of L1+15% in comparison with L1 price of non-MSE for consideration of award of order for 20% of tender quantity against any item as per new public procurement policy.
21.	If Micro & Small Enterprises (MSEs) registered with NSIC intends to participate in the tender, for the items they are not registered with NSIC, then they will have to deposit cost of Tender Document, full amount of Earnest Money as per NIT. Otherwise their offer for those items will not be considered.
22.	Copy of valid NSIC Certificate for MSEs along with DIC's (DISTRICT INDUSTRIES CENTRE) Certificate has to be furnished along with the bid.



2. OTHER INSTRUCTIONS TO THE TENDERERS

2.1 Language of Tender and Interpretation of the Tender Document and Other Documents :

2.1.1 Tender Document means all pages of this book, all pages of General Conditions of Contract of Kolkata Port Trust, May 1993. All pages of subsequent addenda (if applicable) are also part of the Tender Document.

If any amendment / revision / correction / modification is done, which is already provided with the tender or with any subsequent addendum (if applicable), in such case the amended / revised / corrected / modified will supersede the concerned previous clause/sub clause of Tender document.

- **2.1.2** The Tender Documents are drawn up in English and filling up of the required documents by the Tenderer should also be only in English and the interpretation(s) shall be in English. All correspondence and documents relating to the tender, exchanged between the Tenderer and HDC, shall be in the English Language only. The interpretation(s) of the accepting authority shall be final and binding on the bidder.
- **2.1.3** Any clarification with regard to interpretation or ambiguity, discovered or pointed out after the uploading of the Tender Document, as to the meaning, conditions, instructions or Annexure contained in the Tender Documents shall be valid when such a clarification is made by the authority issuing NIT, through a written document and such clarification / amendment shall form part and parcel of the Tender Document.
- **2.1.4** The various documents comprising of the full set of Tender Document are complimentary to one another and are to be taken as parts of a whole and mutually explanatory to each other. If stipulation to the various tender conditions are found to be in variance to each other in any respect, one will override other in order of precedence in the descending order as given below :
 - (i) Description in "Price Schedule".
 - (ii) Special Conditions of Contract.
 - (iii) General Conditions of Contract of Kolkata Port Trust, May 1993.
- **2.2** Intending bidders have to bear all the costs or expenses incurred by them in connection with the preparation and submission of their bids or for any other expenses incurred in connection with such bidding.
- **2.3** The bidder shall quote his price through on-line (through MSTC portal only) as per the Price Schedule in the Price Bid (Part-II), without any condition or deviation.
- **2.4** E-Tender Document shall neither be issued by post nor sold.
- **2.5** Tenderers are not permitted to alter/change/delete/modify any clause of the tender document down loaded from the website. If any deviation / discrepancy is found after submission of tender, the submitted offer will be summarily rejected.

2.6 Pre-Bid Techno-Commercial Conference :

- 2.6.1 Intending bidders and/or their authorized representative(s) are invited to attend the Pre-Bid Techno-Commercial Conference, which will be held on the date stipulated in the 'NOTICE INVITING E-TENDER', at the Office of Plant & Equipment Division, Haldia Dock Complex; Kolkata Port Trust; Operational Administrative Building(1st Floor); Chiranjibpur, PO: Haldia ; Dist.: Purba Medinipur ; PIN 721 604 ; West Bengal.
- **2.6.2** The purpose of this Pre-Bid Techno-Commercial Conference will be to clarify issues (in connection with this tender) that may be raised at that stage.



2.6.3 Intending bidders are advised to visit the worksite of HDC-KoPT during working days (i.e. excluding Saturdays, Sundays and trustees holidays) within 10:00 hrs to 16:00 hrs. to asses the quantum of work before attending the Pre-Bid Techno-Commercial Conference. To visit worksite necessary Gate Pass on chargeable basis will be issued on the basis of written request of the intending bidders as per the existing procedure of HDC-KoPT. Without taking prior approval from the appropriate authority of HDC-KoPT, no photograph in any form can be taken by the intending bidders during site visit.

- 2.6.4 Intending bidders are requested to submit their queries, in connection with this tender, in writing, in advance to HDC-KoPT so as to enable HDC-KoPT to prepare clarifications and make Pre-Bid Conference meaningful. Changes, if any, proposed by the bidders, will be discussed and **if felt necessary** HDC-KoPT's response would be communicated, well in advance before the last date of submission of tender.
- **2.6.5** Any modification to the Tender Document, which may become necessary as a result of the Pre-Bid Techno-Commercial Conference or due to any other reason, shall be made through issuance of an Addendum. This Addendum, so issued, would form part of the Tender Document and will remain binding all the bidders and the same should be accepted and submitted by all the bidders along with their Techno-Commercial Bid.
- **2.6.6** The bidders are advised to attend the Pre-Bid Techno-Commercial Conference. However, nonattendance at the Pre-Bid Techno-Commercial Conference will not be a cause for disqualification of a bidder.
- **2.6.7** No further Pre-Bid Techno-Commercial Conference will be arranged for the intending bidder, who fails to attend the aforementioned Pre-Bid Techno-Commercial Conference. The outcome of this Pre-Bid Techno-Commercial Conference will be displayed on the websites; all the participating bidders shall have to act accordingly.

2.7 <u>Earnest Money Deposit (EMD)</u> :

2.7.1 Method of Paying EMD :

As per methodology stipulated in the 'NOTICE INVITING E-TENDER', the intending tenderer must deposit <u>Earnest Money amounting to Rs</u> 7, 32,000.00 (Rupees Seven Lakh thirty two thousand) only.

Failing to deposit the Earnest Money, as per the above details, shall make the Tender liable for rejection.

2.7.2 Forfeiture of EMD :

Earnest Money may be liable for forfeiture at the option of the Trustees, if the Bidder withdraws his offer after the schedule date of submission of offer and before expiry of the validity period of the offer; and / or, alters / amends any terms and / or condition and / or quoted rate(s), after the schedule date of submission of offer and before expiry of the validity period of the offer (excepting when option to do the same has been specifically granted by the HDC, KoPT in writing) making it unacceptable to HDC-KoPT and / or, in case of successful bidder, fails to carry out the work or to perform / observe any of the conditions of the Contract; and / or, fails to carry out the work or to perform / observe any of the conditions of the Contract. For the purpose of this provision, the validity period shall include any / all extension thereof agreed by the bidder in writing. The Trustees shall also be at liberty to deduct any of their dues from Earnest Money.

2.7.3 <u>Refund of EMD</u> :

Earnest Money Deposit of unsuccessful bidders shall be released / refunded as per normal procedure of HDC-KoPT on award of contract to the successful bidder.

The Earnest Money of accepted tender/offer shall be retained by the Trustees as part of the Security Deposit, for which a separate Treasury Receipt shall be issued to the Contractor after cancellation of the previous Receipt of Earnest Money.

No interest shall be payable on the account of EMD in any case.



2.7.4 Exemption :

Micro & Small Enterprises (MSEs) registered with NSIC (under single point registration scheme), having valid NSIC Certificate for MSEs along with DIC's (DISTRICT INDUSTRIES CENTRE) Certificate, are exempted from depositing Bid Document Fee and Earnest Money.

In such case, scanned copies of valid NSIC Certificate for MSEs along with DIC's (DISTRICT INDUSTRIES CENTRE) Certificate have to be uploaded along with the bid.

Micro & Small Enterprises (MSEs) registered with NSIC intends to participate in the tender, for the items they are not registered with NSIC, then they will have to deposit full amount of Bid Document Fee and Earnest Money Deposit as per NIT. Otherwise their offer for those items will not be considered.

2.8 <u>Method of Submission of Tender</u> :

Tenderers submitted bids, without requisite Earnest Money and/or Bid Document Fee, are liable to be rejected, excepting in case of Micro & Small Enterprises (MSEs) registered with NSIC (under single point registration scheme) having valid DIC's certificate, for the item(s), for which the tender is invited. The procedure of payment of Earnest Money and Bid Document fee of tenders of Haldia Dock Complex shown in Annexure- XVI

2.8.1 THROUGH AXIS BANK GATEWAY(Details, mentioned in the Annexure-XVI)

2.8.2 For submission of Techno-Commercial Bid (i.e. Part – I), the participating bidder would have to sign / fill (wherever applicable) the documents / Annexure / formats etc. **[as mentioned under** Clause No. 1.1 of NOTICE INVITING E-TENDER (i.e. Pre-gualification Criteria) and Clause No. 1.2 of NOTICE INVITING E-TENDER (i.e. Submission of other documents)] under their official seal. scan and upload in the website of MSTC Limited (i.e.http://www.mstcecommerce.com/eprochome/kopt).

The bidder will have to produce the original documents or any additional documents, if sought for by HDC-KoPT.

- **2.8.3 Price Bid (i.e. Part –II)** contains the **Price Schedule**. Price Bid has to be submitted online without any condition or deviation.
- **2.8.4** Bidders have to submit offers based upon Terms & Conditions of the tender without any deviation. Should it, however, become unavoidable, deviations should be suggested during Pre-Bid Meeting. HDC-KoPT reserves the right to accept or reject the suggested deviations.

2.9 Declaration to be submitted by the Tenderers :

The bidder should give the following declarations under their letter head along with the technocommercial offer as per **Annexure – IX** of this Tender Document:

- **2.9.1** A declaration, so that, the bidder has examined carefully, read, understood and accept all the Terms & Conditions of the instant tender including Price Schedule, Special Conditions of Contract, Scope of Work, General Conditions of Contract, May 1993 of Kolkata Port Trust, drawings and all subsequent addenda (as applicable). The bidder would execute and complete the work required to be performed in accordance with all these Terms & Conditions of the instant tender.
- **2.9.2** A declaration, that there is no deviation from the Terms & Conditions of the instant Tender Document.
- **2.9.3** A declaration that the bidder has deposited requisite Earnest Money & Bid document fee.

OR

The bidder has submitted documentary evidences for Micro & Small Enterprises (MSES) registered with NSIC (Under single point registration scheme) as per tender condition.



2.9.4 A declaration, that the bidder or their associates have not been banned/delisted/debarred by any Govt./Quasi-Govt./Public Sector Undertaking in India.

- **2.9.5** The authorized signatory of the bidding firm should give a declaration that the bidder/his partner/any director of their concern/ company is not associated with any other firm bidding for the instant work.
- **2.9.6** A declaration, that the bidder has not altered /deleted /added any Terms & Conditions in the tender document.
- 2.9.7 A declaration that, price quoted only in the Price Bid [Part II], strictly as per "Price Schedule", without any extraneous condition. There is no change in the Format of Un-priced "Price Schedule". Except in the Price Bid the price is not mentioned / disclosed in any other place of tender / offer.

2.10 Joint Ventures/Consortium and other forms of Association

No joint ventures/consortium and other forms of Association will be allowed

2.11 Security Deposit:

- **2.11.1** The successful tenderer(s) shall have to submit security deposit amount@10% of the annual evaluated value of the tender as accepted by Kolkata Port Trust.
- 2.11.2 The Earnest Money deposited by the successful tenderer will be returned after submission of SD within a month from the date of commencement of the contract.
- 2.11.3 The Security Deposit shall be held by the HDC-KoPT as security for the performance of the contractor's obligation under the contract. The Security Money shall be refunded after successful completion of the contract subject to recovery of damage and / or loss incurred, if any, by HDC due to default on the part of the contractor.
- 2.11.4 The Security Deposit shall remain valid for 6 months from the date of expiry of contract. The Security Deposit will be released within 180 days after successful completion of the contract. KoPT shall encash the Security Deposit in the event the contractor has defaulted by more than 60 days on expiry of the mobilisation period to commence operation at the order of authorised officer after handing over the order to him or when any amount is to be recovered from the Contractor as penalty or deduction and the contractor fails to remit such amount within 30 days after due notice given in this regard.

The Sr.Dy. Manager (P&E) shall have the right to ask for the extension of the above Bank Guarantee till such time the Contractual obligations are fulfilled and the Contractor will be duty bound to extend the same as asked by Sr.Dy. Manager (P&E).

2.12 Authority in signing the documents for submission of Tender / Offer: [Save and Except Clause No. 2.10]:

All documents to be uploaded by the bidder should be signed under official seal by -

- **2.12.1** In case the Tender is submitted by a Proprietorship Firm, the same should be signed either by Proprietor or other person, holding a valid Power of Attorney from the Proprietor, in connection with this Tender. The signature of such Power of Attorney holder should be attested by the Proprietor.
- **2.12.2** In case the Tender is submitted by a Partnership Firm, the same should be signed either by partner, holding valid Power of Attorney from the partners, in connection with this Tender. The signature of such Power of Attorney holder should be attested by the partners.
- **2.12.3** In case the Tender is submitted by a Limited Company, the same should be signed by person holding valid Power of Attorney executed in his favour (in connection with this Tender) and the signature of such Power of Attorney holder should also be attested, in accordance with the constitution of the Limited Company.



2.13 Validity of Tender :

The tender shall remain valid for acceptance for a period of **180 days** from the actual date of opening of Techno-Commercial Bid. Prior to the expiry of the Tender validity period, HDC- KoPT may ask to extend the period of validity for a specific time. The request and the response, thereto, shall be made in writing. However, in the event of the bidder agreeing to the request, he shall not be permitted to modify his tender (excepting when option to do the same has been specifically granted by the HDC-KoPT, in writing).

2.14 The bidder to inform himself fully :

- **2.14.1** This Tender Document (covering all instructions, Special Conditions of Contract and Scope of Work and General Conditions of Contract of Kolkata Port Trust, May, 1993, drawings etc.) should be read in conjunction with any addendum which may be issued subsequently.
- 2.14.2 The bidder shall be deemed to have examined the Tender Document [covering all instructions, Special Conditions of Contract, Scope of Work and General Conditions of Contract of Kolkata Port Trust, May, 1993, drawing etc.] and visited the worksite and surroundings and to have obtained all necessary information in all the matters whatsoever that might influence while carrying out the work as per the conditions of the tender and to satisfy himself to sufficiency of his tender, etc. The bidder is advised to acquaint himself with the job involved at the site, like availability of labour, means of transport, communication facilities, laws and bye laws in force from Government of West Bengal and Govt. of India and other statutory bodies from time to time. The bidder shall be deemed to have examined and collected all necessary information as to risk, contingencies and other circumstances, which may influence or affect the tender.

Failure to comply with the requirement of the Tender submission will be at the bidder's own risk. Pursuant to **Clause No. 2.19**, Tender(s) / Offer(s) of the bidder(s), which are not responsive to the requirement of the Tender Document, will be rejected.

- 2.14.3 Bidder shall bear all costs associated with the preparation and submission of his tender and HDC-KoPT will in no case be responsible or liable for these costs, regardless of the conduct or outcome of the tendering process.
- 2.14.4 Before attending the Pre-Bid Techno-Commercial Conference and/or submission of tender, on the basis of formal written request, necessary Gate Pass for entering into the Dock area will be issued to the bidder and / or their authorized representative(s) at chargeable basis, to visit the worksite only for the purpose of inspection and to assess the quantum of work. The bidder will be fully responsible for any injury (whether fatal or otherwise) to himself or his representative(s), for any loss or damage to property, or for any other loss, damage, costs and expenses whatsoever caused which but for the granting of such permission would not have arisen. The bidder will be liable to indemnify the Employer against any loss or damage to the property of the Employer or neighbouring property which may be caused due to any act of bidder or his representative(s). Before visiting the worksite, the bidders are advised to contact with the Section-in-charge of Loco Shed official at Loco Shed of P&E Division. The bidder must have to comply with Clause No. 4.42 regarding prohibition of photography inside the Dock area.

2.15 Amendments:

- 2.15.1 At any time, prior to the last date for submission of tenders, HDC-KoPT reserves the right to amend and modify the Tender Document by issuing Addenda.
- 2.15.2 Any Addendum thus issued shall form part of the Tender Document and shall be communicated to all concerned through the websites and press advertisements, prior to the last date for submission of the tender. Such Addendum so carried out shall form part of the tender and shall be binding upon the bidders.

2.16 Errors in the Tender Document:

- 2.16.1 All documents to be submitted with the Techno-Commercial Bid should be signed, stamped scanned and uploaded as per Clause No. 1.1 & Clause No. 1.2 of 'NOTICE INVITING E-TENDER'.
- 2.16.2 The bidder shall submit complete tender and the same shall be without alterations, interlineations or



erasure effect except those to accord that instructions issued by HDC-KoPT or as may be necessary to correct errors made by the bidders. Person signing the Tender shall, put his signature against all such cancellations, alterations or amendments.

2.17 Acceptance of Tender:

The Trustees do not bind themselves to accept the lowest tender or any tender and reserve the right to accept the tender in part or full or to cancel the tender as a whole without assigning any reason.

Cost on this account, if any, shall not be reimbursed. Participation in e-tendering process by any bidder or opening of techno-commercial bid of any bidder shall not construe that such bidder is considered automatically qualified.

2.18 Opening of Bids:

- 2.18.1 Only Part -I i.e. Techno-Commercial Bid(s) would be opened online on the date and time as stipulated in the 'NOTICE INVITING E-TENDER'.
- 2.18.2 Part -II i.e. Price Bid(s) of only those bidder(s) who are found techno-commercially qualified, would be opened, with prior intimation to all concerned.
- 2.18.3 In case of unscheduled Holiday / Bandh on the date of opening of E-Tender, the same will be opened on the next working day.

2.19 Scrutiny of e-Tenderers:

- 2.19.1 After opening of the Techno-Commercial Bid, the Tender Document(s) submitted by the bidder(s), shall be carefully examined to ascertain that whether all the bidders have submitted the Earnest Money Deposit, Bid Document Fee and all required documents as mentioned in the Tender Document.
- 2.19.2 In connection with scrutiny, evaluation and comparison of tenders, HDC-KoPT may ask bidder individually for clarifications. Request for clarification and response thereto shall be communicated in writing. No change in price or substance of the tender shall be sought, offered or permitted nor the bidder be permitted to withdraw the tender before the expiry of the Validity Period of the tenders in the process of clarifications.
- 2.19.3 HDC-KoPT may seek any other detail(s) / document(s) in subsequent course to ascertain and get confirmed about the competence of the bidder.
- 2.19.4 The Trustees reserve the right to disqualify a tender in case they are satisfied that any prize, commission, gift or advantage has been given, promised or offered by or on behalf of any bidder, to any officer, employee or representative of the Trustees or to any person on his or their behalf in relation to the acceptance of the tender.
- 2.19.5 If on scrutiny, **Techno-Commercial Bid** of any bidder is found not acceptable to HDC-KoPT, the **Price Bid** part of such bidder **will not be opened**. "Price Bid" part of other bidder(s) will be opened on a subsequent date as per procedure. Decision of the HDC-KoPT in this regard shall be final and binding on the bidder.
- 2.19.6 During Techno-Commercial evaluation, i.e. evaluation of Part I of tender, an offer shall be considered **non-responsive** in case :-
- a. Requisite Earnest Money is not deposited
- b. Requisite Bid Document Fee is not paid.
- c. Valid NSIC Certificate for MSEs along with DIC's (DISTRICT INDUSTRIES CENTRE)
- d. Certificate is not submitted, in case of exemption from depositing Bid Document Fee and Earnest Money.
- e. Any indication of quoted price anywhere in the document(s) uploaded by the bidder.

2.20 Evaluation Criteria:

- 2.20.1 Evaluation with respect to Priced Price Schedule.
- 2.20.1.1 Price to be quoted strictly in accordance with Clause Nos. 2.8.3 and 4.37. The Price Bid will be



evaluated only for the bidders, who have qualified in the Techno-Commercial Bid. While evaluating the Price Bid, the bidder, who quoted lowest price, shall be considered for award of contract.

2.20.1.3 While evaluating the Price Bid, any extraneous condition will not be considered and the tender shall liable for outright rejection, if any extraneous condition is found in the offer of the bidding firm.

In case two or more bidders quoting the same Price and their offers become the lowest offer, the respective bidders will be given chance to submit their fresh price bid subject to condition that the fresh price so quoted must be less than the price quoted by the respective bidder earlier.

2.20.1.4 For evaluation purpose: Total evaluated cost = a+(b x c x d)

a = Daily hire charge quoted (in Rs)

b = HSD (in Ltrs) consumption by Locomotive per hour (as declared in price schedule subject to maximum of 20.26 ltrs. per hour)

- **c** = No. of hours run by Locomotive per day (i.e.15 hours)
- **d** = Cost (in Rs) of HSD per litre

Lowest tenderer (L-1) would be determined based on the lowest evaluated cost in totality as stated above.

- **2.20.1.5** Price of HSD to be considered at the ruling rate of HSD of IOCL at Haldia, Purba Medinipur, India, PIN: 721604 on the date of Final submission date of Bid.
- **2.20.1.6** Nos hours run of locomotive per day (i.e. 03 shifts) is to be considered 15 hours.
- **2.20.1.7** While evaluating tenders, regard would be paid to National Defence and Security Considerations.

2.21 Award of Contract:

- 2.21.1 The successful bidder who's bid is accepted by HDC- KoPT (please refer to Clause No. 2.20) shall be duly informed in writing, prior to expiration of the tender validity period, that their tender has been accepted. This notification of award of contract will be treated as Order Letter and will constitute the formation of the contract. Within 15 days of receipt of intimation regarding acceptance of their bid, the successful bidder shall have to submit Draft Agreement, in the format as in Annexure XIV and within a week thereafter the Contract Agreement shall be signed between Kolkata Port Trust and the successful bidder. For this, the successful bidder will submit, at their own cost, required Stamp Papers and Dummy Papers and three sets of documentary transactions between them and Kolkata Port Trust, till finalization of the contract. This Agreement should be signed by the representative of the successful bidder, authorized through a Power of Attorney [specimen signature of the Authorized Representative must be attested] in this regard.
- 2.21.2 Kolkata Port Trust reserve the right to accept or reject the tender in part or as a whole and do not bind themselves to accept the lowest tender or any tender, without assigning any reason and no damage claim whatsoever will be payable by Kolkata Port Trust in this regard. Mere participation in e-tender by any bidder or opening of techno-commercial bid of any bidder shall not construe that such bidder is considered automatically qualified for award of contract. Such qualification may also include information regarding performance of bidder from any other source.

2.22 Stamp Duty and Other Expenses:

All costs, charges and expenses etc. to be incurred in connection with Contract Agreement / Bank Guarantee(s) etc. including Stamp Duty in connection with contract shall be borne by the successful bidder.



3. SCOPE OF WORK AND SYSTEM DESCRIPTION

3.1 Scope of work:

Supply of Diesel Electric/Diesel Hydraulic Locomotive of 1350 HP/1400 HP or above including operation & maintenance by deploying trained manpower as detailed in the tender document having knowledge of Railway Rules and regulation on operation & maintenance, general understanding of permanent way and railway signaling system for carrying out the existing work being done for shunting, marshalling, hauling, decoupling, recoupling, empty collection, placement, withdrawl, train formation etc. The intending bidder needs to acquaint himself for the work being performed presently. The site of works is located within the area of Haldia Dock Complex. The contractor should make his workmen conversant with the existing system of work being followed in Haldia Dock Complex Railway System. The sequence of work shall have to be suitably programmed by the contractor in consultation with the Officer on duty at Railway Control or his authorized representative under Traffic department without hampering other normal operational activities.

- Round the clock manning of Diesel Loco Driver along with other personnel for operation of Locomotive as per scope of work as defined above at point no.3.1.
- Operation of Locomotive in HDC Railway System as per direction of Officer on duty at Railway Control and Yards or his representative under Traffic Department on the basis of Joint Procedure Order / verbal intimation.
- Placement of wagons over Wagon tippler shall be done as per site requirement.
- Formation of empty rakes and taking the rake to empty line as well as re-marshalling as and when needed by HDC- KoPT.

3.2 System Description

HDC-KoPT is connected with Durgachak station of South Eastern Railway. The Railway System is spread over an area of approximate 65 hectares with 115 Kilometers of track length and 11.5 Kilometers of route length having 15 nos. of railway sidings within the Dock Zone and 9 sidings outside the Dock Zone is catering to bulk, break bulk and containerized cargo. HDC Railway is working as Terminal agent of SE Railway as per the working agreement.

HDC Railway, apart from meeting the aggregation and evacuation requirement of Port bound cargo is also catering to the demand of port based industries.

At present, on an average, 12 out bound rakes and 12 in bound rakes are required to be handled daily at various sidings and the number of in bound and out bound rakes are likely to increase substantially in the near future due to increased volume of rail borne cargo expected to be handled at this port.

Handling of rail borne traffic involves not only placement and withdrawal of rake but also attachment and detachment of sick/reject wagons, weighment of the rake and formation of outward rakes within the free time to avoid detention.

HDC is primarily a dry bulk and liquid cargo handling Port and the Port is well connected to the various industries in the hinterland through railway network. Due to smooth evacuation / aggregation of cargo through rail movement, more and more users are attracted towards Haldia and thus it is felt that the strengthening of the railway operation at Haldia is absolute necessity.



- **3.3 Detail of Locomotive:** Diesel Electric/Diesel Hydraulic Locomotive of 1350 HP/1400 HP or above, Turbo charged DC-DC / AC-AC / AC-DC transmission or equivalent capable of hauling full load of BOXN / BOBRN rake of Indian Railways. Details of Locomotive to be mentioned in Annexure-XVIII
- **3.3.1** The Locomotive on hire will be the property of the Firm but remain in the premises of HDC- KoPT-Haldia on round the clock basis including Sunday & holidays for full period of contract agreed upon.
- **3.3.2** Availability of Locomotive: Refer the clause no. 4.17 under heading **Guaranteed Availability.**
- **3.3.3** The firm will nominate one person to coordinate with Port Railway Control (shift in charge)/ Traffic department of HDC- KoPT to log the availability / ineffectiveness of Locomotive in every shift.
- **3.3.4** Except High Speed Diesel oil (Fuel Oil) all other spare parts / items / assemblies including lubricants / greases & engine oil etc. required to be replaced on the Locomotive during maintenance will be provided by the successful bidder free of cost. HSD will be provided by HDC- KoPT.
- **3.3.5** Diesel Engine HP: Certificate from OEM or Authorized Service provider of OEM regarding Diesel Engine HP need to be submitted along with the bid. The certificate should not be older than six months from the date of submission of bid.
- **3.3.6** HDC-KoPT reserves the right to send the Diesel Engine, installed on the Locomotive, to either OEM or Authorized Service provider of OEM of Diesel Engine to check the BHP /HP. In case the Diesel Engine does not fulfil the requisite BHP /HP, the said Diesel Engine is required to be replaced by a suitable one. Hiring charges will not be applicable during the said period of uninstallation of Diesel Engine from the Locomotive & installation of Diesel Engine on the Locomotive. All expenses will be on contractors account.
- **3.3.7** Calibration of Locomotive fuel tank gauge by Legal Metrology, Govt. of West Bengal or any competent agency as approved by HDC-KoPT, once in a year, to be arranged by the successful bidder at their own cost and arrangement. Valid calibration certificate to be displayed on Locomotive and copies to be submitted to T.O (Rlys) Division & P&E Division.
- **3.3.8** Route permission & first time placement of Locomotive in HDC- KoPT site will be entirely arranged by the successful bidder with all cost and incidentals.
- **3.3.9** Age of Locomotive should not be more than 05(Five) years as on the last date of submission of the tender.
- **3.3.10** The Locomotive should have completed IOH at the end of 4 years and should not be due for POH during the tenure of hire.
- **3.3.11** Although the contractor is entitled to 72 hours shutdown, in totality, as free time during a month for preventive/ breakdown maintenance of locomotive but not more than 48 hrs shut down would be given at a stretch. No unused free time in a month would be carried forward to the next month.
- **3.3.12 Breakdown Maintenance:** Detention time will start from the time of breakdown of Locomotive and till the time of deployment of Locomotive for commercial operation by TO (Rlys) Division under Traffic Department. Deployment time for this purpose to be counted from the time, when TO(Rly.), HDC intimates the party for commencement of work.



4.0 SPECIAL CONDITIONS OF CONTRACT

4.1 Definition and Interpretation:

For definitions of different words used in this Tender Document, **KoPT's General Conditions of Contract, May 1993** are to be followed.

- 4.1.1 In the event of the Contractor contravening this condition, HDC-KoPT shall be entitled to terminate the contract forthwith and award a fresh contract to some other parties at risk and cost of the Contractor, who shall be liable for any loss or damage, which HDC-KoPT may sustain in consequence to arising out of such replacement of the Contractor.
- 4.1.2 The contractor shall not assign his right and interest in these presents nor assume a fresh partner or partners, dissolve, the partnership existing between him in reference to this contract without the written permission of HDC-KoPT.
- 4.1.3 No participating bidder shall be allowed to act as a subcontractor of the successful bidder.

4.2 Patent Rights:

- 4.2.1 The contractor shall fully indemnify HDC-KoPT against any action, claim or demand, costs or expenses arising from or incurred by reason of any infringement or alleged infringements of letters, patents, design, trademark or name, copyright or other protected rights in respect of any machine, plant, work, materials or things, system or methods of using, fixing working or arrangement used for fixed or supplied by the contractor in India, or elsewhere.
- 4.2.2 All payments, or otherwise shall be deemed to be included by the contractor in the prices named in the tender and shall be paid by him to whom they may be payable.
- 4.2.3 In the event of any claim being made or action brought against HDC-KoPT in respect of any such matter as aforesaid, the contractor shall be immediately notified thereof and he shall with the assistance, if he so requires of HDC-KoPT but at the sole expense of the contractor conduct all negotiations for the settlement of the same or any litigation that may arise there from provided that the conduct of such negotiations or litigations shall be conditional upon the contractor giving to HDC-KoPT such security as shall from time to time by reasonably required by HDC-KoPT to recover the ascertained or agreed amount as the case may be of any compensation, damages, expenses and cost, which might be payable by the Trustees in respect of or as a result of any such negotiation or litigation.

4.3 Power Supply, water & Use of Land:

4.3.1 For execution of work, electricity will be supplied on chargeable basis. The contractor will provide cables; switch gears etc. to receive electricity from HDC's nearest electric supply source. For use of electricity, all supply and safety regulations including Indian Electricity Rules to be abide by the contractor. For any other purposes electricity will be provided on chargeable basis as per applicable electricity tariff of HDC-KoPT which may vary time to time.

For the purpose of setting up a site office to carry out the activities in connection with the contract, land as available, may be allotted to the firm by HDC-KoPT in the nearby area of the Loco shed for which the firm will submit written application chargeable basis on applicable rate. It is emphasized that the construction of such site office, if required, shall in no way hinder any other operation in side the dock or elsewhere.

If the contractor does not handover the land allotted to him and/or does not remove the temporary structure erected on the said land within a fortnight, then the contractor will have to pay compensation to HDC equivalent to three times the applicable licence fee from the plot concerned as per schedule rent of KoPT's land and building at Haldia.

4.3.2 If required, the contractor shall be allowed to use a suitable land to erect any temporary



structures on this land for office, store, workshop etc, which may be absolutely necessary for the proper and efficient execution of works, on chargeable basis on applicable rate.

If the contractor does not handover the land allotted to him and/or does not remove the temporary structure erected on the said land within a fortnight, then the contractor will have to pay compensation to HDC equivalent to three times the applicable licence fee from the plot concerned as per schedule rent of KoPT's land and building at Haldia.

4.4 Fresh water: Fresh Water for use of the staff members as well as for requirement of the Locomotive will be provided on chargeable basis by HDC-KoPT. The Contractor will have to take the delivery of fresh water for Locomotive from specified points. Necessary arrangement like flow meter, pipe & pipe fittings etc.to be arranged by the contractor.

4.5 Infra- structure facilities at loco shed available at HDC-KoPT & Charges:

- a) The existing Loco shed has pits with 2 level platforms.
- b) Loco shed having one Pendant control EOT Crane (10T Main hoist & 2T Aux. hoist).
- c) 02 sets of Loco lifting jack having capacity 36 MT & 25 MT.

The firm may utilize the existing pits during Breakdown / shutdown maintenance work of Locomotive, subject to prior intimation to on duty Officer of HDC-KoPT in writing by the firm. As per availability of repairing facilities, the same would be offered to the party (i.e. when not required by HDC, KoPT at its own purpose) on chargeable basis. Minimum Shed utilization charge at the rate of Rs.3000.00 per shift day of 08 hours (08.00AM to 05.00PM) will be levied on the contractor plus overhead cost @ 19.25% plus Service Tax as applicable.

4.6 Access to Site:

The contractor shall have to abide by the rules and regulations of HDC-KoPT, which may be varied time to time, in respect of entry / exit and movement in the premises. Necessary **Gate Pass** for entering into the Dock area will be issued for the personnel, equipment, machineries, materials etc. of the contractor for execution of the instant work at chargeable basis as per rules then prevailing, on the basis of written request from the contractor. The contractor will be fully responsible for any injury (whether fatal or otherwise) to himself or his representative(s), for any loss or damage of property, or for any other loss, damage, costs and expenses whatsoever caused which but for the granting of such permission would not have arisen. The Contractor will be liable to indemnify HDC-KoPT against any loss or damage to the property of HDC-KoPT or neighbouring property, which may be caused due to any act of the contractor or his representative(s).

4.7 Contract Document Mutually Explanatory:

- 4.7.1 The several documents forming the contract are to be taken as mutually explanatory of one another and should anything appear in one, which is not described in the other, no advantage shall be taken of any such omission.
- 4.7.2 In case, any discrepancies or inconsistencies however appear or should any misunder- standings arise as to the meaning and of the specifications or drawings or as to the dimensions or the quality of the materials or the due and proper execution of the work or as to the measurement or quality and valuation of the work executed under this contract or as extra thereupon, the same shall be explained by the Engineer or his authorized representative.
- 4.7.3 The explanation of Engineer or his authorized representative shall be final and binding upon the contractor and the contractor shall execute the work according to such explanations, and without extra charge or deductions to/from the prices specified in the Price Schedule and do all such work and things as may be necessary for the proper completion of the work as implied by the specification and drawings, even though such work and things are not specifically shown and



described therein.

4.8 Existing Services:

- 4.8.1 Drains, pipes, cables, overhead wires and similar services whether above or below the ground which may be encountered in the course of the work shall be saved and kept harmless from injury and/or loss or damages by the contractor at their own costs and expenses so that they continue to be in full and uninterrupted use to HDC-KoPT.
- 4.8.2 The contractor shall not store any materials or otherwise occupy any part of the site in a manner likely to hinder the operation of such services. The contractor shall at his own costs and expenses and without any delay repair and make good, to the satisfaction of the employer, any injury and/or loss or damage caused by the contractor to the same.

4.9 Labour:

- 4.9.1 The contractor shall make their own arrangements for the engagement of all labour for doing the work at site or in respect of or in connection with the execution of work as also for the transport, housing/residential accommodation, medical treatment, feeding/canteen facility and payment thereof. Therefore HDC-KoPT will have no obligation for the labours engaged by the contractor. Since time is the essence of this contract, adequate strength of labour force has to be deployed, so as to supply including operation and maintenance of locomotive under HDC-KoPT as stipulated in the tender.
- 4.9.2 In the event of any outbreak of illness or an epidemic nature, the contractor shall comply with and carry out such regulations, orders and requirements as may be made by the Government, or the local medical or sanitary authorities for the purpose of dealing with and overcoming the same.
- 4.9.3 Contractor shall at all times take all reasonable precautions to prevent any unlawful, riotous or disorderly conduct by or amongst his employees and for the preservation of peace and protection of persons and property in the neighbourhood of the works against the same.
- 4.9.4 Contractor shall at all times during the continuance of the contract comply fully with all Acts, Rules, Regulations and Byelaws then prevailing including all statutory amendments and reenactment by the State or Central Government and other Local Authorities and any other enactments and acts that may be passed in future either by the State or the Central Government or Local Authority, including Indian Workmen's Compensation Act, Labour Laws and Equal Remuneration Act, 1976, Factories Act, Minimum Wages Act, The Contract Labour (Regulation & Abolition) Act, 1970; Employees' Provident Fund & Miscellaneous Provision Act, 1952; Employees' State Insurance Act, 1948; Dock Workers, (Safety, Health and Welfare) Act, 1986 etc.
- 4.9.5 If as a result of contractor's failure, negligence, omission, default or non-observance of any provisions of any law, HDC-KoPT is called upon by any authority to pay or reimburse or required to pay or reimburse any amount, HDC-KoPT shall be entitled to deduct the same from any moneys due or that become due to the contractor under this contract or any other contract or other wise recover from the contractor any sum, which HDC-KoPT is required or called upon to pay or reimburse on behalf of the contractor. All registration and statutory inspection fees in respect of his work pursuant to the contract shall be paid by the contractor.
- 4.9.6 The contractor shall pay the labourer engaged by him for this instant work not less than a fair wage, under the Minimum Wages Act for corresponding workforce working in Haldia, West Bengal, India.

4.10 Labour Licence:

Before commencement of the work at site (within Dock area), the Contractor shall have to apply for **Labour Licence (if applicable)** for the maximum number of workers proposed to be deployed for operation & maintenance of Locomotive. Necessary certificate shall be issued by the concerned Sr. Dy. Manager (RIy.) under Traffic Department against a request from the contractor. Photocopy of the application shall have to be furnished to the concerned Sr. Dy.



Manager (Rly) under Traffic Department.

4.11 Report of Accident:

The contractor shall, **inform immediately without delay** of the occurrence of any accident, at or near the site or in connection with the execution of the work under the contract, report the accident to the concerned Sr. Dy. Manager (Rly.) or his authorized representative(s) and shall make every arrangement to render all possible assistance to the victim(s) of such accident. The contractor shall also report such accident to the competent authority whenever such a report is required by law. For any accident occurred within the entire operational area covered under the contract, the contractor shall ensure prompt investigation into the matter through recording of statement of the personnel witnessing the accident. The report containing the findings along with the statements so recorded will then be forwarded by the contractor to the concerned Sr. Dy. Manager (Rly.) or his authorized representative(s) at the earliest. At the first instance, an 'Accident Report' shall be prepared (in triplicate) by the concerned Supervisor / Engineer on duty engaged by the Contractor and a copy of the same to be forwarded immediately to the Engineer. Upon getting the first information Report of Accident, a joint Committee, consisting of representatives of I&CF Division, TO(Rly) Division & P&E Division of HDC-KoPT and a member of management cadre of contractor will be formed to investigate the accident.

4.12 Employees' Provident Fund (EPF):

All intending bidders shall have to submit proof of registration of their establishment under the provision of **Employees' Provident Fund & Miscellaneous Provisional Act** and recent **Challan**, if applicable. If this is not applicable, documentary evidence to establish non-applicability of the same to be submitted along with the Techno-Commercial Bid.

Please refer to Clause No. 1.2.2 in this regard.

As per the provision of the Act, the contractor is liable for remittance of monthly subscription contribution with respect to **Employees' Provident Fund (EPF)** for the workers engaged by them, wherever applicable.

4.13 Employees' State Insurance (ESI):

All intending bidders shall have to submit necessary documents along with their techno-commercial offer as to whether they are covered under ESI Act or not. If they are covered under the said Act, proof of registration of their establishment under the provision of **Employees' State Insurance Act** and recent **Challan** are to be submitted.

If they are not covered under ESI Act or exempted, necessary documents along with an **affidavit** affirmed before a First Class Judicial Magistrate to that effect are to be submitted. Such affidavit(s) will be examined by KoPT and the bidder(s) must abide the observation/ recommendation in this regard.

Please refer to Clause No. 1.2.3 in this regard.

If the contractor is not under ESI Act, then the contractor must additionally indemnify HDC-KoPT against all damage and accident occurring to his/their labour.

If the contractor is covered under ESI Act, as per the provision of the Act the contractor is liable for remittance of monthly subscription contribution with respect to **Employees' State Insurance (ESI)** for the workers engaged by them.

4.14 Safety Gears, etc.:

During the execution of contract, the contractor shall have to ensure safety of all their working personnel to the fullest compliance of the provisions of general safety rules/ regulations including Dock Workers, (Safety, Health and Welfare) Act, 1986 along with associated Rules &



Regulations.

The Contractor shall be solely responsible for consequences arising out of non-compliance or violation of safety rules / regulation.

The contractor shall at his own expenses and arrangement provide all required **Personal Protective Equipments (PPE)** and **Safety Gears** for all personnel and labours engaged during the execution of contract.

4.15 Plant and Equipment:

- 4.15.1 During execution of contract, the contractor shall be responsible for supply, use and maintenance of all the equipments, tools-tackles, lifting appliances, different vehicular transport etc. and the contractor shall ensure that those are suitable for the work and are maintained in such a manner, to ensure their efficient working. The contractor must have to comply with Dock Workers, (Safety, Health and Welfare) Act, 1986 along with associated Rules and Regulations and other safety rules (as applicable) in this regard.
- 4.15.2 To execute the contract, the contractor shall at their own costs and expenses provide all labour, plant, haulage, transportation of plant and equipment, all materials, stores, etc. required for efficiently carrying out and completing the work to the satisfaction of Engineer.

4.16 Operation/Business of HDC-KoPT must not be hampered:

- 4.16.1 During the continuance of the contract, the contractor has to execute the work such a manner, so that, any business/work of HDC-KoPT in the vicinity of worksite must not be hampered in any way.
- 4.16.2 The work shall be carried out in such a manner so as to enable the other contractors, if any, or the departmental employees to work, without any difficulty / hindrance etc.

4.17 Guaranteed Availability:

- 4.17.1 The Contractor will have to stand guarantee for the Locomotive's availability for 90% hours of respective month (Month starts from 00:01 of 1st day and ends at 24:00 hours of last day of calendar month), in fully operational condition. In case the availability of the Locomotive falls below the said minimum guaranteed level, no daily hire charge shall be paid for the 'DEFICIT PERIOD' i.e. Non availability of Locomotive for work as per Scope of Work and in addition to the same, penalty as per clause 4.22 will be applicable.
- 4.17.2 The firm shall maintain 90% availability of the Locomotives by adjusting schedule time during lean period of work. There will be no alternative locomotive or standby for the period of maintenance. However, substitute equivalent locomotive is required to be provided during long schedule maintenance or any major breakdown.
- 4.17.3 Locomotive becoming ineffective as a result of accident/ derailment on any account will continue to be shown in availability if reason for the same is attributable to HDC-KoPT.It is clarified that the ineffective 10% margin does not cater for accidents/derailments which occur as a result of system failure attributable to HDC-KoPT not locomotive maintenance failure.
- 4.17.4 If the hired Locomotive gets involved in any sort of accident / derailment taking toll of life or materials or both or creating dislocation owing to inadvertent operations or loss of alertness, the firm shall have to submit a detailed report the accident enumerating its cause to HDC-KoPT. HDC in turn shall verify the above submission, if necessary by forming a committee in which one representative of the Firm will be there. In case of Driver / Locomotive being responsible for such accident as may be opined by the committee as aforesaid.
- 4.17.5 The following detentions will not be arrtibutable to the contractor

4.18 General Inspection: Inspection and Load testing of the Locomotive will be carried out jointly by the representative of the firm and representative of HDC-KoPT at site. Locomotive should be capable to haul minimum 4000 MT on straight & level track,failing which the loco will be rejected.A Test run for a period of 24 hours of the offered Locomotive will be conducted at site in presence of representatives of the contractor & HDC-KoPT.

4.19 Operation Mode & Charges:

4.19.1 The Locomotive shall be ready for operation for 24 hours.

4.19.2 On Standby Mode:

The Locomotive shall be deemed to be on standby if the Locomotive is made available to the authorized officer fully ready and fit for operation with sufficient crew & fuel on board whereby the officer can order the Loco Driver to commence operation at 15 minutes notice.

4.20 Accrual of Charges:

The contractual charges are inclusive of all the expenses connected to the operation of the Locomotive including supply of manning and materials for the same. The charges shall accrue to the contractor at the rates quoted by him and accepted by HDC-KoPT.

4.21 Daily Hire Charge: Daily Hire Charge shall be paid for the day the Locomotive is in operation/standby mode as described in clauses 4.19.1 and 4.19.2 above.

4.22 Penalty:

- a) HDC, KoPT will not pay any of the scheduled rates for the days the operation of the Locomotive, is suspended for the reason attributable to the contractor. Further a sum equivalent to 50% of the 'Daily Hire Charge' under Bill of Quantities will be imposed as penalty for each day or part thereof during the DEFICIT PERIOD. However, Engineer of the contract may waive of the penalty if he is satisfied that the reason of the default were beyond the control of contractor.
- b) If the hired loco gets involved in any sort of accident / derailment taking toll of life or material or both or creating dislocation owing to inadvertent operations or loss of alertness, the site -in -charge of the firm shall have to submit a detailed report of the accident enumerating its cause to HDC-KoPT. HDC-KoPT in turn shall verify the above submission, if necessary by forming a committee in which one representative of the firm will be there. In case of driver/Locomotive the committee as aforesaid may opine being responsible for such accident as, the penalty will be at actuals and the same to be deducted from the party's monthly RA bill or any others sum payable.
- c) In case the offered Locomotive is not available for operation for a period of more than 7(seven) days, then a substitute Locomotive with similar/ better specification (including age of the locomotive) shall be provided as a replacement by the Contractor at no extra charge within 15 days from the time and date the offered Locomotive is inoperative / broken down. However, supply of fuel to the replacement Locomotive will be restricted only up to the limit permissible for the locomotive originally offered on hire failing which risk purchase clause, stated in enclosed GCC may be invoked.
- d) If the Contractor fails to deliver the offered/ substituted Locomotive as per specification given in the tender within 30 days from the date of the issuance of Letter of Intent, liquidated damages at the rate of Rs.50, 000/- per day will be levied on the Contractor from the 31st day onward, and if the Locomotive is not delivered for operation within 45 days from the date of issuance of Letter of Intent,



the Contract shall be liable to be terminated and Security Deposit forfeited.

4.23 Duration of the contract: This contract will come into effect from the date of signing of agreement and will remain valid for two years from the date of supply and acceptance of the loco.

- **4.24** The Locomotive will normally ply at manoeuvring speed but, may have to be increased or decreased as per operational requirement.
- **4.25** The Locomotive shall be under the operational command of Sr.Dy.Manager (Rly), HDC or his authorised representatives.
- **4.26** All transportation costs towards men and material will be the responsibility of the contractor.
- **4.27** Fuel supply: The contractor, at their cost, will print sufficient number of log books and log abstracts as per HDC-KoPT's approved format. The contractor has to maintain a daily log book for the Locomotive. All particulars of the Locomotive including movement of the Locomotive (From-To), engine's important parameters, daily running hours, Fuel (HSD) position in Fuel tank of Locomotive: Opening Balance (OB) at the beginning of shift & Closing Balance (CB) at the end of shift, fuel oil consumed / received etc. to be logged daily and to be signed by the In-Charge of the Locomotive and countersigned by authorized representative of TO(Rly)Division under Traffic Department of HDC-KoPT. A monthly log abstract to be prepared mentioning all the above stated important parameters duly signed by the In-Charge and same to be submitted with the monthly bill without which no payment will be released. The daily logbook to be retained on Locomotive / office and same to be produced on demand. In view, HDC is an ISO 9001:2008 organization; the Locomotive will be required to follow ISO 9001: 2008 guidelines.
- **4.28 Energy conservation:** The Contractor shall undertake strict measures for 'Energy Conservation' at all times. HSD will be issued by Loco Section of P&E Division under Engineering Department, HDC-KoPT upon generation of indent by the contractor and countersigned by Sr.Dy.Manager (Rly) or his authorized representative under Traffic Operations (Rlys.) Division. The Fuel would be dispensed during the period from 08:00 Hrs -17:00 Hrs on all days. The indent with date should specify quantity of fuel required (in Itrs), last date of receipt of HSD with quantity of fuel (in Ltrs), current stock of fuel (in Itrs) in Loco Fuel Tank, name & designation of indenting official of contractor, name & designation of countersigning official of TO(Rly) Division under Traffic Department. The fuel(HSD) consumption per operating hour of Locomotive should be 20.26 Ltrs. or the consumption of fuel established during test run of Locomotive (Clause no. 4.18 under 'General Inspection') or rate of consumption declared in price bid whichever is lower to be considered as consumption of fuel of the Locomotive throughout the tenure of contract. In case of consumption of fuel more than the consumption as stated above during the pendancy of the contract, Contractor will be responsible for such additional consumption and the cost of extra fuel plus 19.25% overhead (alongwith Service Tax, if applicable) will be recovered from their monthly RA bill.
- **4.29** Responsibility of operating the Locomotive including manning, lubricants, provisions and stores and all other supplies and services required to perform the designated duties wholly rests on the contractor and the costs of the same shall have to be taken in to account while quoting the rates.
- **4.30 Mobilization Period:** On placement of Letter of Intent, the Locomotive is to be made available at Haldia and commence operation within 30 days.

4.31 Insurance:

The Locomotive, men & materials must have comprehensive insurance including persons deployed shall be insured by the contractor at his own cost during the entire contract period. Documentary evidence should be provided before commencement of work. HDC-KoPT, under no circumstances, shall be responsible for any damage to the Locomotive or for any accident to the personnel engaged by the Contractor during the operation of the locomotive or otherwise. The insurance should cover



Damage/ Death of Port property / Persons.

4.32 Terms of Payment:

100% Payment shall be made against monthly RA bill through RTGS mode within thirty days from the date of submission of relevant clear bills accompanied by locomotive log abstract clearly depicting availability of Locomotive(in Hrs)during the month duly certified by Sr.Dy.Manager (Rly) or his authorized representative under Traffic Department of HDC-KoPT. Payment will be made only through ECS for which the Contractor must furnish the relevant bank details immediately after signing the contract. Payment for Hire Charges will be made once in a month by HDC-KoPT.

4.33 Tender Price, Taxes, Duties and other Statutory Levies etc.:

- 4.33.1 Price to be quoted ONLINE only in the Price Bid (priced Price Schedule) should strictly as per "Price Schedule", without any extraneous condition. There should not be any change in the Format of un-priced "Price Schedule". Except in the Price Bid, the price must not be mentioned / disclosed in any other place of tender/offer.
- 4.33.2 Tender price shall be inclusive of all charges other than the CENVAT component (i.e. Service Tax). All other incidental charges for the execution of the contract should be included.
- 4.33.3 Work Contract Tax, wherever applicable should be included in the quoted price.
- 4.33.4 Except where otherwise expressly provided, the contractor shall provide all materials, labour, plant and equipment and things necessary in connection with the contract work although everything may not be fully specified and although there may be errors and omissions in the specifications.

4.34 Goods & Service Tax (GST):

Any modification (addition /deletion /alteration including implementation of GST) in taxes or duties in future by the Govt. of India after due date of submission of this tender will be addressed separately at the material time. Therefore the detailed tax break-up considered in the quoted price should also be submitted by the bidders along with their price bid in order to assess the impact of future tax levied subsequently, if any on the contract price. Any offer without the detailed tax break-up, if becomes the lowest price—bid and is accepted by KoPT with or without any negotiation of price, shall not be entitled for reimbursement of any additional amount due to subsequent modification of taxes or duties. GST will be paid at actuals.

4.35 Price Variation:

- 4.34.1 The prices other than statutory taxes, duties and levies, as applicable shall be firm and fixed till completion of the contract.
- 4.34.2 In case of any upward variation in any taxes, duties and other statutory levies etc. and/or new introduction of any taxes, duties and other statutory levies etc. of Central/State Government, which will be applicable to this Contract, Trustees will consider reimbursement of payment made against such increase of taxes, duties against documentary evidence of such payment made. In case of any downward revision in any taxes, duties and other statutory levies etc. and/or withdrawal/ abolition of any taxes, duties and other statutory levies etc. the contractor will give due rebate, as would be effected by such revision or withdrawal/ abolition.

4.36 Extra Claim:

No claim for any detention / idle charges for labours, materials, equipments and machines organized by the contractor in connection with the work under the contract shall be payable by HDC-KoPT to the contractor under any circumstances whatsoever.

4.37 Service Tax:



Service Tax, if applicable for execution of work, will be paid extra on submission of CENVAT – able document.

Service Tax will be applicable on the amount of Penalty as well as on other recovery i.e. damage, penalty, land rate, electricity charges etc. as applicable, from the contractor Service Tax will be paid at actuals.

4.38 Extended Stay Compensation:

Extended Stay Compensation for delay in execution of the contract will not be paid.

4.39 Storage of material:

The safe storage of material shall be the responsibility of the contractor. Any kind of damage (including due to atmospheric condition), theft, pilferage etc. shall be on contractors account.

4.40 Removal of Materials on Completion:

The contractor shall, on completion of the works or as and when directed by the Employer, remove all plant, equipment, tools, materials, temporary constructions, etc. which may have accumulated during the execution of the work at their own cost and arrangement, other than those permanently used into the works, at employer's site.

During execution of work any type of scrap generated out of HDC-KoPT's property inside the HDC-KoPT's premises is to be returned to HDC-KoPT.

4.41 Keeping the Site Clean:

The contractor shall maintain the site such a manner so that, pollution may not be caused due to stacking of any scrap/surplus materials, rubbish and offensive materials etc. and hindrance in movement of man/equipment may not be happened due to stacking of such type of materials.

4.42 Photography inside the Dock Zone is prohibited:

Without taking any written permission from the appropriate authority of HDC-KoPT any kind of photography whether **still or video/movie** inside the **Dock Zone** is prohibited.

In compliance to the above, the contractor must ensure that, any photograph of the work or any part thereof or plant employed by the contractor shall not be taken either by the contractor or by any of the sub-contractor(s) employed by the contractor, without the approval of HDC- KoPT and no such photograph shall be published or otherwise circulated in any manner without the approval of HDC-KoPT. The contractor will be held responsible in case of violation of this clause.

4.43 Advertisement:

Without the written permission of HDC-KoPT the contractor shall not advertise in news paper and/or in electronic media and/or shall not display on any hoarding, fencing, building etc. in connection with this contract.

4.44 Income Tax Deduction:

Income Tax, if any, as per the relevant provision of the Income Tax Act shall be deducted at source from any payment payable to the contractor.

4.45 No Interest on account of Delayed Payments:

Any claim for interest will not be entertained by HDC-KoPT with respect to any payment or balance which may be in their hands owing to any disputes between HDC-KoPT and the contractor or with respect to any delay on the part of HDC-KoPT in making payment.

4.46 Force Majeure:



In the event of either party being rendered unable by Force Majeure to perform any obligations required to be performed by them under the Contract, the relative obligation of the party affected by such Force Majeure shall upon notification to the other party be suspended for the period during which Force Majeure event lasts. The cost and loss sustained by either party shall be borne by respective parties. The term FORCE MAJEURE as employed herein shall mean acts of God, Earthquake, War, Revolt, Riot, Fire, Floods, Sabotage and Hurricane/Cyclone, Strike excluding that of Contractor's Suppliers or Sub-contractor's Employees.

Upon the occurrence of such case and upon its termination the party alleging that it has been rendered unable as aforesaid, shall notify the other party in writing immediately but not later than 48 (forty eight) hours of the alleged beginning and ending thereof giving full particulars and satisfactory evidence in support of its claim.

4.47 Indemnity:

- 4.47.1 Notwithstanding that all reasonable and proper precautions may have been taken by the contractor at all times during the progress of the work, the contractor shall nevertheless be wholly responsible for all damages, whether to the works themselves or to any other property of HDC or to the lives, persons, property of others during the progress of the work.
- 4.47.2 In case any damage occurs to the existing structure due to the contractor's operation, the same shall be made good by the contractor at his own risk and cost. The areas, which are likely to be unsafe for use, shall be barricaded and all necessary precautionary measures, like displaying notices, shall be taken by the contractor, during commissioning and testing of equipment at site.
- 4.47.3 The contractor has to submit the **Indemnity bond as per Format, enclosed in the General** Conditions of Contract of Kolkata Port Trust, May 1993

4.48 Workmen's Compensation:

The contractor shall indemnify HDC in the event of HDC being held liable to pay compensation for injury to any contractor's servants or workmen under the Indian Workmen's Compensation Act, 1923, as amended from time to time, and shall take out an insurance policy covering all risks under the Act and shall keep the same renewed, from time to time as necessary, for the duration of the contract and produce the same before completion of work to the General Manager (Engg.).

4.49 HDC-KoPT's Lien:

HDC-KoPT shall have a lien on and over all or any money that may become due and payable to the contractor under this contract or any other contract or from any amount lying with them or under their control and in respect of any debt or sum that may become due and payable by HDC- KoPT to the contractor, either alone or jointly with another or other and either under this contract or under any other contracts or transaction of any nature whatsoever HDC-KoPT and the contractor.

4.50 Employer's Entitlement to Terminate:

- 4.50.1 The Engineer's of the Contract shall be entitled to terminate the Contract, at the Engineer's of the Contract convenience, at any time after giving 56 days prior notice to the Contractor, with a copy to the Engineer's of the Contract Representative, and returning the performance security.
- 4.50.2 In the event of such termination, the Contractor shall:
 - a) cease all further work, except for such work as may be necessary and instructed by the Employer's Representative for the purpose of making safe or protecting those parts of the Works already executed and any work required to leave the site in a clean and safe condition.
 - b) hand over all Construction Documents, Plant and Materials for which the Contractor



has received payment.

- c) hand over those other parts of the Works executed by the Contractor up to the date of termination and
- d) remove all Contractor's Equipment, which is on the Site and repatriate all his staff and labour from the site.

Any such termination shall be without prejudice to any other right of the Contractor under the Contract.

- 4.50.3 In the event of such termination, the Engineer's of the Contract Representative shall determine the value of the work done and:
 - a) The amounts payable for any work carried out for which a price is stated in the Contract;
 - b) the Cost of Plant and Materials ordered for the Works which have been delivered to the Contractor, or of which the Contractor is liable to accept delivery; such Plant and Materials shall become the property of (and be at the risk of) the Engineer's of the Contract when paid for by the Engineer's of the Contract and the Contractor shall place the same all the Engineer's of the Contract disposal;
 - c) any other Cost or liability, which in the circumstances was reasonably incurred by the Contractor in the expectation of completing the Works;
 - d) the reasonable Cost of removal of Temporary Works and Contractor's Equipment from the site and the return of such items to the Contractor's works (or to any other destination at no greater cost) and
 - e) the reasonable cost of repatriation of the Contractor's staff and labour employed wholly in connection with the Works at the date of such termination;
 - f) return of HDC's plant, equipment, crane(s), machineries tools and tackles etc. which are deployed for the execution of work in good running condition and make payment accordingly.

4.51 Settlement of Disputes:

If a dispute of any kind whatsoever arises between the Engineer's of the Contract and the Contractor in connection with or arising out of the contract or the execution of the works, the same shall be dealt as per relevant provisions of the General Conditions of Contract and THE ARBITRATION AND CONCILIATION (AMENDMENT) ACT, 2015 and any statutory amendment thereof.

4.52 Outbreak of War:

If during the continuance of the contract, there shall be an outbreak of war (whether war is declared or not) in any part of the world which, whether financially or otherwise materially affects the execution of the works, the contractor shall ,unless and until the contract is terminated under the provision in this clause contained use his best endeavours to complete the execution of the works provided always that either the Employer or the Contractor shall be entitled at any time after such outbreak of war to terminate this Contract by giving notice in writing to the other and upon such notice being given this contract shall terminate but without prejudice to the rights of either party in respect of any antecedent breach.

4.53 Applicability of Laws on the Contract:

The contract shall be governed by all relevant Indian Acts as applicable only within the jurisdiction of the Honourable Calcutta High Court, India, including the following Acts.

- i) The Indian Contract Act, 1872.
- ii) The Major Port Trust Act, 1963.
- iii) The Workmen's Compensation Act, 1923.
- iv) The Minimum Wages Act, 1948.



- v) The Contract Labour (Regulation & Abolition) Act, 1970.
- vi) Dock Workers (Safety, Health & Welfare) Act 1987.
- vii) The Indian Arbitration Act (1940) (in the case of definite Arbitration Agreement only).
- viii) Indian Arbitration and Conciliation Act, 1996
- ix) Indian Electricity Rules, 1956 with latest amendments.
- x) Other Acts/Rules/Regulations which may applicable to the contract during execution of the same.
- **4.54 Locomotive driver Profiles:** Contractor should submit the profiles of Locomotive Driver as per Format, Annexure- XVIII. The Training Certificates along with the Health Certificates of the Locomotive Drivers to be produced along with the Techno- commercial Bid.

4.55 Other Terms and Conditions:

Notwithstanding anything contained herein, the contract will generally be guided by the **General Conditions of Contract (GCC)** of **Kolkata Port Trust**, duly approved by the Board of Trustees in May, 1993, as well as the Major Port Trust Act, 1963, and subsequent amendments thereof, if any, unless otherwise specified.

DEFINITIONS

1. **DEFINITIONS**

- 1.0 In the contract, as here in after defined, the following words and expressions shall have the meaning herein assigned to them, except where the context otherwise required.
- 1.1 "Employer" or "Board" or "Trustees" means of the Board Employer of Trustees for the Port of Calcutta, a body corporate under Section 3 of the Major Port Trusts Act, 1963, including their successors, representatives and assigns.
- 1.2 "Chairman" means the Chairman of the Board and Chairman includes the person appointed to act in his place under Sections 14 and 14A of the Major Port Trusts Act, 1963.
- 1.3 "Contractor" means the person or persons, Firm or Contractor Company whose tender/offer has been accepted by the Trustees and includes the Contractor's representatives, heirs, successor and assigns, if any, permitted by the Board/Chairman.
- 1.4 "Engineer" means the Board's official who has invited Engineer the tender on its behalf and includes the Chief Engineer, the Chief Mechanical Engineer, the Senior Executive Engineer, the Chief Hydraulic Engineer, the Deputy Chief Engineer, the Deputy Chief Mechanical Engineer, the Senior Resident Engineer, the Manager (Infrastructure & Civic Facilities), the Manager (Plant & Equipment), the Deputy Manager (Infrastructure & Civic Facilities) and the Deputy Manager (Plant & Equipment) or other official as may be appointed from time to time by the Employer, with written notification to the Contractor, to act as Engineer for the purpose of the Contract, in place of the "Engineer" so designated.
- 1.5 "Engineer's Representative" means any subordinate or Engineer's Assistant to the Engineer or any other official appointed Representative from time to time by the Engineer to perform the duties set forth in Clauses 2.4 to 2.6 hereof.
- 1.6 "Work" means the work to be executed in accordance Works with the Contract and includes authorised "Extra Works" and 'Excess Works" and "Temporary Works".

- 1.7 "Temporary Works" means all temporary works of every Temporary works kind required in or about the execution, completion or maintenance of the works and includes (without thereby limiting the foregoing definitions) all temporary erections, scaffolding, ladders, timbering, soaking vats, site offices, cement and other godowns, platforms and bins for stacking building materials, gantries, temporary tracks and roads, temporary culverts and mixing platforms.
- 1.8 "Extra Works" means those works required by the Extra works and Engineer for completion of the Contract which were not specifically and separately included in the schedule of items of the works i.e. (Bill of Quantities) of the tender. "Excess Works" means the required quantities of work in excess of the provision made against any item of the bill of Quantities.
- 1.9 "Specifications" means the relevant and appropriate Specification Bureau of Indian Standard's specifications (latest revisions) for materials and workmanship unless stated otherwise in the Tender.

"Drawings" means the drawings referred to in the Tender Drawings and specification and any modification of such
1.10 drawings approved in writing by the Engineer and such other drawings as may from time to time be furnished or approved in writing by the Engineer.

- 1.11 "Contract" means and includes the General and Contract Special Conditions of Contract, Specifications, Drawings, priced Bill of Quantities, the Tender / Offer, the letter of acceptance of the Tender/Offer, the Contract Agreement, if separately entered into and the Schedule of Rates and Price, if any, adopted by the Trustees at their discretion.
- 1.12 "Constructional Plant" means all appliances or things of Constructional whatsoever nature required in or about the execution, Plant completion or maintenance of the works or temporary works and includes (without thereby limiting the foregoing definition) all machinery and tools but does not include materials or other things intended to form or forming part of the permanent works.
- 1.13 "Site" means the land, and other places, on, under, in or Site through which the works are to be executed or carried out and any other Lands or places provided by the Trustees for the purpose of the Contract.

- 1.14 "Contract Price" means the sum named in the letter of Contract Price acceptance of the Tender/Offer of the Contractor, subject to such additions thereto and deductions therefrom as may be made by the Engineer under the provisions here in after contained.
- 1.15 "Month" means English Calendar Month. Month
- 1.16 "Excepted Risks" are riot in so far as it is uninsurable, Excepted Risks war, invasion, act of foreign enemies, hostilities (whether war be declared or not), Civil War, rebellion, revolution, insurrection or military or usurped power or use or occupation by the Trustees of any portion of the works in respect of which a certificate of completion has been issued (all of which are herein collectively referred to as the excepted risks).
- 1.17 Word importing the singular only, also includes the plural Singular/Plural and vice-versa where the context so requires.
- 1.18 The heading and marginal notes in these General Headings/ Conditions of Contract shall not be deemed to be part Marginal Notes. thereof or be taken into consideration in the interpretation or construction thereof or of the contract.
- 1.19 Unless otherwise stipulated the word "Cost" shall be Cost deemed to include overhead costs of the Contractor, whether on or off the site.
- 2.0 DUTIES & POWERS OF ENGINEER & ENGINEER'S RESENTATIVE.
- 2.1 The Contractor shall execute, compete and maintain Engineer's the works in terms of the contract to the entire Authority satisfaction of the Engineer and shall comply with the Engineer's direction on any matter whatsoever.
- 2.2 The Contractor shall take instructions from the Engineer Authority of and subject to limitation of Clause 2.5 hereof, from the Engineer's Engineer's Representative. Representative
- 2.3 The Engineer shall have full power and authority : Engineer's Power(a) to supply to the contractor from time to time during
 - the progress of the works such further drawings and instructions as shall be necessary for the purpose of proper and adequate execution and maintenance of the works and the contractor shall carry out and be bound by the same.

- (b) to alter or modify the specification of any material and workmanship and to inspect the work at any time.
- (c) to order for any variation, alteration and modification of the work and for extra works.
- (d) to issue certificates as per contract.
- (e) to settle the claims & disputes of the Contractor and Trustees, as the first referee.
- (f) to grant extension of completion time.
- 2.4 The Engineer's Representative shall :
 - (i) watch and supervise the works.

- (ii) test and examine any material to be used or workmanship employed in connection with the work.
- (iii) have power to disapprove any material and workmanship not in accordance with the contract and the contractor shall comply with his direction in this regard.
- (iv) take measurements of work done by the contractor for the purpose of payment or otherwise.
- (v) order demolition of defectively done work for its reconstruction all by the Contractor at his own expense.
- (vi) have powers to issue alteration order not implying modification of design extension and of completion time of the work and,
- have such other powers and authorities vested in (vii) the Engineer, which have been delegated to him in writing by the Engineer under intimation to the Contractor.
- 2.5 Provided always that the Engineer's Representative shall Limitation have no power : Engineer's **Representative's**
 - (a) to order any work involving delay or any extra payment by the Trustees,
 - (b) to make variation of or in the works: and
 - (c) to relieve the Contractor of any of his duties or obligations under the Contract.

- 2.6 Provided also as follows :
 - (a) Failure of Engineer's Representative to disapprove any work or materials shall not prejudice the power of the Engineer thereafter to disapprove such work or materials and to order the pulling down, removal, breaking-up thereof and re-constructing at the contractor's cost and the contractor shall have no claim to compensation for the loss sustained by him.
 - (b) If the contractor shall be dissatisfied by reason of any decision of the Engineer's Representative, he shall be entitled to refer the matter to the Engineer who shall thereupon confirm, reverse or vary such decision.
 - (c) Any written instructions or written approval given by the Engineer's Representative to the contractor, within the terms of delegation of power and authority vested in the Engineer to his Representative in writing, shall bind the contractor and the Trustees as though it had been given by the Engineer, who may from time to time make such delegation.

- 3.6 If stipulated in the contract as a Special Condition, the Bank Guarantee contractor shall have to submit to the Engineer a in lieu of Cash performance Bond in the form of an irrevocable S.D. in certain guarantee from Calcutta/Haldia Branch, as the case cases may be, of any Nationalised Bank of India in the proforma annexed hereto and for the sum and period as mentioned in the letter of acceptance of the Tender/Offer, within 15 days from the date of such letter, failing which the Contract shall be liable to be terminated and the earnest money shall be liable to forfeiture; all at the discretion of the Engineer. The cost of obtaining this or any other Bank Guarantee and/or the revalidation thereof, wherever required, has to be borne by the Contractor and it shall be his sole responsibility to arrange for timely revalidation of such Bank Guarantee, failing which and for non-fulfilment of any contractual obligation by the Contractor, the Engineer and/or the Trustees shall be at liberty to raise claim against the Guarantee and/or enforce the same unilaterally.
- 4.0 THE CONTRACT & GENERAL OBLIGATIONS OF CONTRACTOR
- 4.1 (a) The contract documents shall be drawn-up in English English language. langua

language to be used

- (b) The contract shall be governed by all relevant Indian Applicability of Acts as applicable only within the jurisdiction of the laws on the High Court at Calcutta, India, including the following contract Acts :
- 1. The Indian Contract Act, 1872.
- 2. The Major Port Trusts Act, 1963.
- 3. The Workmen's Compensation Act, 1923.
- 4. The Minimum Wages Act, 1948.
- 5. The Contract Labour (Regulation & Abolition) Act,1970.
- 6. The Dock Workers' Act, 1948.
- 7. The Indian Arbitration Act, (1940) (in the case of a definite Arbitration Agreement only).
- 4.2 After acceptance of his Tender/Offer and when called Contractor to on to do so by the engineer or his representative, the Execute contractor shall, at his own expense, enter into and Contract execute a Contract Agreement to be prepared by him in Agreement. the form annexed hereto. Until such Contract Agreement is executed, the other documents referred to the definition of the term 'Contract' here-in-before, shall collectively be the Contract.
- 4.3 Several documents forming the contract are to be taken Interpretation of as mutually explanatory of one another. Should there be contract any discrepancy, ambiguity, omission or error in the documents various contract documents, the Engineer shall have the **Engineers**' power to correct the same and his decision shall be final Power and binding on the parties to the Contract.
- 4.4 Two copies of the Drawings referred to in the general All Drawings are and special Conditions of Contract and in the Bill of Trustees' Quantities, shall be furnished by the Engineer to the property. Contractors free of cost for his use on the work, but these shall remain the property of the Trustees and hence, the Contractor shall return them to the Engineer or his Representative on completion of the work, if not torn or mutilated on being regularly used at site.

4.5 The Contractor shall prove and make at his own expense Contractor any working or progress drawings required by him or prepare working necessary for the proper execution of the works and 1 progress shall, when required, furnish copies of the same free of drawings cost to the Engineer for his information and/or approval, without meaning thereby the shifting of Contractor's responsibility on the Engineer in any way whatsoever.

- 4.6 The Contractor shall not directly or indirectly transfer, assign or sublet the Contract or any part thereof without cannot the written permission of the Engineer. Even if such permission be granted, the Contractor shall remain responsible (a) for the acts, defaults and neglect of any sub-contractor, his agents, servants or workmen as fully as if these were the acts, defaults or neglects of the Contractor himself or his agents, servants or workmen, and (b) for his full and entire responsibility of the contract and for active superintendence of the works by him despite being sublet, provided always that the provision of labourers on a "piece rate" basis shall not be deemed to be sub-letting under this clause.
- 4.7 Unless otherwise specified, the Contractor shall be Contractors' deemed to have included in his Tender/Offer all his cost price is inclusive for supplying and providing all constructional plant, temporary work. Materials both for temporary and permanent works, labour including supervision thereof, transporting to and from the site and in and about the work, including loading, unloading, fencing, watching, lighting, payment of fees, taxes and duties to the appropriate authorities and other things of every kind required for the construction, erection, completion and maintenance of the work.
- 4.8 The Contractor shall be solely responsible for the adequacy, stability and safety of all site operations and methods of construction, even if any prior approval thereto has been taken from the Engineer or his Representative. The Contractor shall not be responsible for the correctness of the design or specification of the Temporary and Permanent works formulated by the Engineer; but the Contractor shall be fully responsible for the correct implementation thereof, as also for any design and specification prepared/proposed/used by the Contractor.

4.9 Whenever required by the Engineer or his representative, the Contractor shall submit to him the details of his (a) programme for execution of the work, (b) proposed procedure and methods of work, (c) proposed deployment of plant, equipment, labour, materials and temporary works. The submission to and/or any approval by the Engineer or his Representative to any such programme or particulars shall not relieve the Contractor of any of his obligations under the contract.

> If for any reason the contractor be unable to adhere to his earlier programme, he shall submit his revised programme for completion of work within the stipulated time whenever asked to do so.

- 4.10 Necessary and adequate supervision shall be provided by the Contractor during execution of the works and as long thereafter as the Engineer or his representative shall consider necessary during the maintenance period. The Contractor or his competent and authorised agent or representative shall be constantly at site and instructions given to him by the Engineer or his representative in writing shall be binding upon the Contractor subject to limitation in Clause 2.5 hereof. The Contractor shall inform the Engineer or his representative in writing about such representative/agent of him at site.
- 4.11 The Contractor shall employ in execution of the Contract Contractor only gualified, careful and experienced persons and the Engineer shall be at liberty to direct the Contractor to men stop deployment of any of is staff, workmen or official at Engineer's site and the Contractor shall within 48 hours comply with power such instruction without any demur whenever the remove Engineer shall feel that the deployment of the person concerned will not be conducive to the proper and men timely completion of the work.
- 4.12 The Contractor shall be responsible for the true and proper setting out of the works in relation to reference points/lines/levels given by the Engineer in writing. The checking of any setting-out or of any alignment or level by the Engineer or his Representative shall not in any way relieve the contractor of his responsibility for the correctness thereof and he shall fully provide, protect and preserve all stakes, templates, bench marks, sight rails, pegs, level marks, profile marks and other things used in setting out the works.

- 4.13 From the commencement of the works till issue of the Contractor completion certificate in Form G.C.1, vide Clause 5.12 hereof, the contractor shall take full responsibility for the care thereof. Save for the excepted risks, any damage, loss or injury to the work or any part thereof shall be made good by the Contractor at his own cost as per instruction and to the satisfaction of the engineer, failing which the Engineer or his Representative may cause the same to be made good by any other agency and the expenses incurred and certified by the Engineer, shall be recoverable from the contractor in whatever manner the Engineer shall deem proper. This Clause will not apply to that part of the work, which might have been taken over by the Trustees on partial completion of the work and in such case the Contractor's obligation will be limited to replacement for manufacturing repairs and or construction defects during the Maintenance period (Guarantee Period) as per the directions of the Engineer as also for defects/damages if any caused to the work by the Contractor during such repairs and replacement in the maintenance period.
- 4.14 The Contractor shall at his own cost protect support and take all precautions in regard to the personnel or structure or services or properties belonging to the Trustees or not which may be interfered with or affected or disturbed or endangered and shall indemnify and keep indemnified the Trustees against claim for injury, loss or damage caused by the Contractor in connection with the execution and maintenance of the work to the aforesaid properties, structures and services and/or to any person including the Contractor's workmen. Cost of Insurance Cover, if any, taken by the Contractor shall not be reimbursed by the Trustees, unless otherwise stipulated in the Contract.
- 4.15 The Contractor shall immediately inform the Engineer's Representatives if any fossil, coins, articles of value or antiquity and structures and other remains or things of geological or archaeological importance be discovered at site which shall remain the property of the Trustees and protect them from being damaged by his workmen and arrange for disposal of them at the Trustees' expense as per the instruction of the Engineer's Representative.

- 4.16 The Contractor shall be deemed to have indemnified the Trustees against all claims, demands, actions and proceedings and all costs arising therefrom on account of:
 - (a) Infringement of any patent right, design, trademark or name or other protected right, in connection with the works or temporary work.
 - (b) Payment of all royalties, rent, toll charges, local taxes, other payments or compensation, if any, for getting all materials and equipment required for the work.
 - (c) Unauthorised obstruction or nuisance caused by the contractor in respect of Public or Private or Private road, railway tracks, footpaths, crane tracks, waterways, quays and other properties belonging to the Trustees or any other person.
 - (d) Damage/injury caused to any highway and bridge on account of the movement of Contractor's plants and materials in connection with the work.
 - (e) Pollution of waterway and damage caused to river, lock, sea-wall or other structure related to waterway, in transporting contractor's plants and materials.
 - (f) The Contractor's default in affording all reasonable facilities and accommodation as per the direction of the Engineer or his Representative to the workmen of the Trustees and other agencies employed by or with the permission and/or knowledge of the Trustees on or near the site of work.
- 4.17 Debris and materials, if obtained by demolishing any Dismantled property, building or structure in terms of the Contract materials shall remain the property of the Trustees. Trustees' property

- 4.18 The Contractor's quoted rates shall be deemed to have Contractor's been inclusive of the following : quoted
 - (a) Keeping the site free of unnecessary obstruction and removal from site of constructional plant wreckage, rubbish, surplus earth or temporary works no longer required.
 - (b) Cleaning and removal from site all the surplus materials of every kind to leave the site clean and tidy after completion of the work, without which payment against final bill may be liable to be withheld.
 - (c) Precautionary measures to secure efficient protection of Docks, the River Hooghly and other waterways against pollution of whatever nature during execution and maintenance of the works and to prevent rubbish, refuse and other materials from being thrown into the water by the Contractor's men or those of his agency.
 - (d) Making arrangements for deployment of all labourers and workers, local or otherwise including payment for their wages, transport, accommodation, medical and all other statutory benefits and entry permits, wherever necessary.
 - (e) Making arrangements in or around the site, as per the requirements of Calcutta Municipality Corporation or other local authority or the Engineer or his Representative, for preventing (i) spread of any infectious disease like smallpox, cholera, plague or malaria by taking effective actions for destruction of mice, vermin, mosquitoes, etc. and by rats. maintaining healthy and sanitary condition, (ii) illegal and distribution of Drugs, Narcotics, storage Alcoholic liquor, Arms and Ammunitions, (iii) unlawful, riotous or disorderly conduct of the Contractor's or his Sub-Contractor's workmen, (iv) deployment of workmen of age less than 16 years.
- 4.19 Every direction or notice to be given to the Contractor Notice shall be deemed to have been duly served on or Contrareceived by the Contractor, if the same is posted or sent by hand to the address given in the tender or to the Contractor's Site Office or in case of Trustee's enlisted contractor to the address as appearing in the Trustee's Register or to the Registered Office of the Contractor. The time mentioned in these conditions for doing any act after direction or notice shall be reckoned from the time of such posting or despatch.

- 4.23 All constructional plants, temporary works and materials when brought to the site by the Contractor, shall be deemed to be the property of the Trustees who will have lien on the same until the satisfactory completion of the work and shall only be removed from the site in part or in full with the written permission of the Engineer or his Representative.
- 5.0 COMMENCEMENT, EXECUTION AND COMPLETION OF WORK.
- 5.1 The Contractor shall commence the work within 7 days of the receipt of Engineer's letter informing acceptance of the Contractor's tender/offer by the Trustees or within such preliminary time as mentioned by the Contractor in the Form of Tender or the time accepted by the Trustees. The Contractor shall then proceed with the work with due expedition and without delay, except as may be expressly sanctioned or ordered by the Engineer or his Representatives, time being deemed the essence of the contract on the part of the contractor.
- 5.2 The Contractor shall provide and maintain a suitable Contractor's site office at or near the site to which the Engineer's office Representative send communications may and instructions for use of the Contractor.

- 5.3 Unless specified otherwise in the contract or prior Contractor permission of the Engineer has been taken, the contractor shall not execute the work beyond the Trustees' observed Engineer's working hours by the Representative and on Sundays and Holidays observed in the Trustees' system, except in so far as it becomes essential on account of tidal work or for safety of the work. If the progress of the work lags behind schedule or the work has been endangered by any act or neglect on the part of the contractor, then the Engineer or his Representative shall order and the contractor at his own expense shall work by day and by night and on Sundays and Public Holidays. Any failure of the Engineer or his Representative to pass such an order shall not relieve the contractor from any of his obligations. The Engineer's decision in this regard shall be final binding and conclusive.
- 5.4 Unless stipulated otherwise in the contract, all materials required for the work shall be procured and supplied by the contractor with the approval of the Engineer or his Representative and subject to subsequent testing as may be required by the Engineer or his Representative. The Engineer shall exercise his sole discretion to accept his any such materials.
- 5.5 Unless stipulated otherwise in the contract, all materials, workmanship and method of measurement shall be in accordance with the relevant Codes (Latest Revision) of the Bureau of Indian Standards and the written instructions of the Engineer or his Representative. Where no specific reference is available in the contract, the material and workmanship shall be of the best of their respective kinds to the satisfaction of the Engineer.
- 5.6 Samples shall be prepared and submitted for approval Contractor to of the Engineer or his representative, whenever required submit samples to do so, all at the Contractor's cost. for approval
- 5.7 Unless stipulated otherwise in the contract, the cost of Contractor to any test required by the Engineer or his representative in arrange all testing respect of materials and workmanship deployed on the his at work, shall be borne by the Contractor. own cost.
- 5.8 Regarding the supply of any materials by the Trustees to the contractor in accordance with the contract, the following conditions shall apply;

- (a) The Contractor shall, at his own expense, arrange for transporting the materials from the Trustees' Stores, watching, storing and keeping them in his safe custody, furnishing of statement of consumption thereof in the manner required by the Engineer or his representative, return of surplus and empty container to the Trustees' Stores as per the direction of the Engineer or his Representative.
- (b) Being the custodian of the Trustees' materials, the Contractor shall remain solely responsible for any comsuch materials issued to him and for any loss or loss damage thereof for any reason other than "Excepted dam Risks", the Contractor shall compensate the Trustees' Trust in the manner decided by the Engineer and shall at material from the site without his permission.
- (c)The Trustees' materials will generally be supplied in De stages and in accordance with the rate of progress of work, but, except for grant of suitable extension of completion time of work as decided by the Engineer, on the Contractor shall not be entitled to any other Co compensation, monetary or otherwise, for any delay in the supply of Trustees' materials to him. The Contractor co shall, however, communicate his requirement of such of materials to the Engineer from time to time.
- (d) Unless stipulated otherwise in the contract, the value of the Trustees' materials issued to the contractor shall be recovered from the contractor's bills and/or any of his other dues, progressively according to the consumption thereof on the work and/or in the manner decided by the Engineer or his representative and at the rate/s stipulated in the contract. These rates shall only be considered by the contractor in the preparation of his tender/offer and these will form the basis of escalation/variation, if in future the contractor is required to procure and provide any such material on the written order of the Engineer consequent on the Trustees' failure to effect timely supply thereof.

- 5.9 The Engineer or his Representative shall have the power to inspect any material and work at any time and to order at any time – (i) for removal from the site of any material which in his opinion is not in accordance with the contract or the instruction of the engineer or his representative, (ii) for the substitution of the proper and suitable materials, or (iii) the removal and proper reexecution of any work, which in respect of material and workmanship is not in accordance with the contract or the instructions of the Engineer. The Contractor shall comply with such order at his own expense and within the time specified in the order. If the contractor fails to comply, the Engineer shall be at liberty to dispose any such materials and re-do any work in the manner convenient to the Trustees by engaging any outside agency at the risk and expense of the contractor and after giving him a written prior notice of 7 days.
- 5.10 No work shall be covered up and put out of view by the Contractor to contractor without approval of the Engineer or his Representative and whenever required by him, the contractor shall uncover any part or parts of the work or his make openings in or through the same as may be directed by the Engineer or his representative from time to time and shall reinstate or make good those part of works thus affected to the satisfaction of the Engineer, all of work at the cost of the contractor.

The Trustees shall reimburse such cost as determined by the Engineer, if the initial covering up was with prior written order of the Engineer or his Representative.

5.11 On a written order of the Engineer or his Representative, the contractor shall delay or suspend the progress of the work till such time the written order to resume the execution is received by him. During such suspension the contractor shall protect and secure the work to the satisfaction of the Engineer or his Representative. All extra expenses in giving effect to such order shall be considered by the Trustees, unless such suspension is –

- (a) otherwise provided for in the contract, or
- (b) necessary by reason of some default on the part of the contractor, or
- (c) necessary by reason of climatic conditions on the site, or
- (d) necessary for proper execution of the works or for the safety of the works or any part thereof.

The Engineer shall settle and determine such extra payment and/or Extension of completion time to be allowed to the contractor, as shall, in the opinion of the Engineer, be fair and reasonable.

- 5.11.1 If at any time before or after commencement of the work the Trustees do not require the whole of the work tendered for, the Engineer shall notify the same to the contractor in writing and the contractor shall stop further works in compliance of the same. The Contractor shall not be entitled to any claim for compensation for underived profit or for such premature stoppage of work or on account of curtailment of the originally intended work by reason of alteration made by the Engineer in the original specifications, drawings, desians and instructions.
- 5.12 When the whole of the work has been completed to the satisfaction of the Engineer and has passed any final test prescribed in the contract, the contractor shall, within 21 days of submission of his application to the Engineer, be entitled to receive from him a certificate for completion of work in Form G.C.1, annexed hereto. If any part of the total work having been completed to the satisfaction of the Engineer, be taken over and/or used by the Trustees, the Contractor shall on application be entitled to partial completion certificate in the Form G.C.1 indicating the portion of the work covered by it, so that the Contractor's liability during maintenance period of the contract, if any, shall commence from the date mentioned in such certificate so far as the completed portion of the work is concerned.

- 6.0 **TERMS OF PAYMENT :**
- 6.1 No sum shall be considered as earned by or due to the Contractor in respect of the work till final and satisfactory completion thereof and until a certificate of final completion in Form G.C.2 has been given by the Engineer.

On account payments, if any, made prior to issue of the certificate in Form G.C.2, shall all be treated as mere advance, which shall stand recoverable in full or in part, if the Engineer so decides in the context of Contractor's unfulfilled contract condition, if any.

- 6.2 All payments shall be made to the Contractor only on the basis of measurements of actual work done, as basis of recorded in the Trustees' measurement books and at accepted tendered or at agreed rates, as the case may be, except as otherwise provided in the contract and when the Engineer decides any other rate for change in the scope of work or omission, if any, on the part of the Contractor.
- 6.3 For work of sanctioned tender value more than Rs.50,000/- or having an initially stipulated completion account period of 4 months or more, on account payments may payment be made at the discretion of the Engineer or his Representative at intervals deemed suitable and justified by him. Provided always that subject to execution of work of substantial value in the context of the contract price, the interval of such on account payments shall be decided by the Engineer or his Representative, which shall ordinarily not be less than 1 month in between two payments for on account bill and/or advance.

- Measurement for works done shall be progressively 6.4 taken by the Engineer's Representative and entered in the Trustees' Measurement Book, at intervals deemed suitable and proper by him and/or the Engineer. The Contractor or his duly accredited Representative or Agent shall remain present at the time of such measurement and assist the engineer's Representative in every manner required by him. After the measurements taken have been entered in the Measurement Book, the Contractor or his Agent shall sign the Measurement Book at the end of such Measurements over the Contractor's Rubber Stamp as a token of acceptance of all such measurements, recorded above and prior to such signature. If the Contractor or his Agent fails to participate even after 3 days written notice from the Engineer's Representative, the measurement shall be taken ex-parte by the Engineer's Representative and those shall be accepted by the Contractor.
- 6.5 Based on the quantum of work and the value thereof prepare and computed in the Measurement Book, the Contractor submit his bills shall type out his bill in the proforma approved by the Engineer and submit the same to the Engineer's Representative in quadruplicate, duly signed by him or his accredited Agent over his Rubber Stamp. The Engineer or his Representative may, in his absolute discretion, allow advance payment against such bill to the extent of an amount not exceeding 75% of the "net payable" sum of the said bill, subject to adjustment thereof against the bill at the time of checking and auditing the bill at the Trustees' end. The measurement Book will not be handed over to the Contractor; but he will obtain the abstracts of quantities, amounts and recoveries to type out the bill.
- 6.6 At the discretion of the Engineer or his Representative and only in respect of accepted offers/where estimated amount put to tender would be Rs.2,00,000/- or more, advance payment may be made to the extent of 75% of the value of any material purchased and brought to the site by the Contractor, Provided always that -
 - (i) the materials shall, in the opinion of the Engineer or his Representative, be of imperishable nature,
 - (ii) the value of such materials shall be assessed by the engineer or his Representative at their own discretions,

- (iii) a formal agreement has been drawn up with the contractor, under which the Trustees secure a lien on the contractor's materials,
- (iv) the materials are safe-guarded by the contractor against losses, shortage and misuse due to the contractor postponing the execution of the work or otherwise,
- (v) in the event of storage of such materials within the Trustees' protected areas in the Docks, the contractor shall submit an Indemnity Bond in the proforma and manner acceptable to Trustees' whereby the contractor shall indemnify the Trustees against all financial loss/damage, on account of loss/damage to such materials for whatever reasons,
- (vi) in the event of storage of such materials outside the Trustees' protected areas the Contractor shall submit to the Engineer an irrevocable Bank Guarantee favouring the Trustees and for the same sum as is being advance, in the proforma and manner acceptable to the Trustees. The Guarantee shall be of a Calcutta/Haldia Branch of any Nationalised Bank or a Schedule Commercial Bank, as the case may be, acceptable to the Trustees and shall remain valid till the anticipated period of consumption of such materials in the work. The Bank Guarantee must undertaking bear bv the issuina an Bank guaranteeing automatic payment of the guaranteed sum to the Trustees by the Bank on the date of expiry of the validity of the Guarantee, unless with the prior written approval of the Engineer on behalf of the Trustees, the Bank has extended the validity of the Guarantee.
- (vii)The amount of advance shall be recoverable from the contractor's bills or any other dues, progressively with the consumption of the materials on the basis of quantity consumed. Consequent on full recovery of the advance the Indemnity Bond/Bank Guarantee, vide Sub-clause (v) & (vi) above, shall be returned to the Contractor duly discharged by the Engineer on behalf of the Trustees.

- 6.7 No certificate of the Engineer or his representative shall **Recovery for** protect the Contractor against or prevent the Trustees wrong and over from obtaining repayment from the Contractor, in case payment the Engineer or his representative should overcertify for payment or the Trustees should over-pay the Contractor on any account.
- 6.8 No claim for interest shall be admissible or payable to Interest not the Contractor at any stage and in respect of any money admissible to or balance or Bank Guarantee, which may be due to the Contractor Contractor from the Trustees, owing to dispute or otherwise or for any delay on the part of the Trustees in making interim or final payment or otherwise.
- 7.0 **VARIATION AND ITS VALUATION :**
- 7.1 The Quantities set out in the Bill of Quantities of the tender Quantities in Bill shall be treated as estimated quantities of the work and shall never be deemed as actual or correct quantities of Tender the works to be executed by the contractor in fulfilment of his obligation under the contract.
- 7.2 The Engineer shall have the power to order the Engineer's Contractor in writing to make any variation of the quantity, guality or form of the works or any part thereof the works that may, in his opinion, be necessary and the Contractor upon receipt of such an order shall act as follows :
 - (a) Increase or decrease the quantity of any work included in the contract.
 - (b) Omit any work included in the contract.
 - (c) Change the Character or quality or kind of any work included in the contract.
 - (d) Change the levels, lines, position and dimensions of any part of the work, and
 - (e) Execute extra and additional work of any kind necessary for completion of the works

Provided also that verbal order of variation from the Engineer shall be complied with by the Contractor and the Engineer's subsequent written confirmation of such verbal order shall be deemed to be an order in writing within the meaning of this clause.
- 7.5 (a) The Contractor shall not be entitled to any claim of extra or additional work unless they have been carried out under the written orders of the Engineer.
 - (b) The Engineer shall solely determine the amount (if any) to be added to or deducted from the sum named in the tender in respect of any extra work done or work omitted by his order.
 - (c) All extra, additional or substituted work done or work omitted by order of the Engineer shall be valued on the basis of the rates and prices set out in the contract, if in the opinion of the Engineer, the same shall be applicable. If the contract does not contain any rates or prices directly applicable to the extra, additional or substituted work, then the Engineer may decide the suitable rates on the basis of Schedule of Rates (including surcharge in force at the time of acceptance of tender), if any, adopted by the Trustees with due regard to the accepted contractual percentage, if any thereon. In all other cases the Engineer shall solely determine suitable rates in the manner deemed by him as fair and reasonable, and his decision shall be final, binding and conclusive.
 - (d) If the nature or amount of any omission or addition relative to the nature or amount of the whole of the contract work or to any part thereof shall be such that, in the opinion of the Engineer, the rate of prices contained in the contract for any item of the works or the rate as evaluated under sub-clauses (b) and (c) of this clause, is by reason of such omission or addition rendered unreasonable or in-applicable, the Engineer shall fix such other rate or price as he deems proper and the Engineer's decision shall be final, binding and conclusive.

- 8.0 **DELAY / EXTENSION OF COMPLETION TIME / LIQUIDATED DAMAGE / TERMINATION OF CONTRACT**
- 8.1 Should the quantum of extra or additional work of any Extension of kind or delayed availability of the Trustees' materials to be supplied as per contract or exceptionally adverse climatic conditions and natural phenomenon or strikes, lock-outs, civil commotion or other special circumstances of any kind beyond the control of the Contractor, cause delay in completing the work, the contractor shall apply to the Engineer in writing for suitable extension of completion time within 7 days from the date of occurrence of the reason and the Engineer shall thereupon consider the stated reasons in the manner deemed necessary and shall either reject the application or determine and allow in writing the extension period as he would deem proper for completion of the work, with or without the imposition of "Liquidated Damage" Clause (No.8.3 hereof) on the Contractor and his decision shall be binding on the Contractor. If an extension of completion time is granted by the Engineer, the Clause No.8.3 of the Liquidated damage shall apply from its date of expiry, if the work be not completed within the extended time, unless stated otherwise in the decision communicated by the Engineer, as aforesaid.
- 8.2 (a) If the Contractor fails to complete the work within the stipulated dates or such extension thereof as communicated by the Engineer in writing, the Contractor shall pay as compensation (Liquidated Damage) to the Trustees and not as a penalty, 1/2% (half percent) of the total value of work (contract price) as mentioned in the letter of acceptance of the tender/offer, for every week or part thereof the work remains unfinished. Provided always that the amount of such compensation shall not exceed 10% of the said value of work.

'Liquidated Damage' and other compensation due to Trustees

- (b)Without prejudice to any of their legal rights, the Trustees shall have the power to recover the said amount of compensation/damage in Sub-clause (a) of this clause, from any money due or likely to become due to the Contractor. The payment or deduction of such compensation/damage shall not relieve the Contractor from his obligation to complete the work or from any of his other obligations/liabilities under the contract and in case of the Contractor's failure and at the absolute discretion of the Engineer, the work may be ordered to be completed by some other agency at the risk and expense of the Contractor, after a minimum three days notice in writing has been given to the Contractor by the Engineer or his Representative.
- 8.3 Without being liable for any compensation to the Default of the Contractor, the Trustees may, in their absolute discretion, terminate the contract and enter upon the site and works remedies & and expel the Contractor there from after giving him a minimum 3 days' notice in writing, due to occurrence of any of the following reasons and decision of the Trustees in this respect, as communicated by the Engineer shall be final and conclusive :

Contractors powers/Terminat ion of Contract.

- (i) The Contractor has abandoned the contract.
- (ii) In the opinion of the Engineer, either the progress of work is not satisfactory or the work is not likely to be completed within the agreed period on account of Contractor's lapses.
- (iii) The Contractor has failed to commence the works or has without any lawful excuse under these conditions, has kept the work suspended for at least 15 days despite receiving the Engineer's or his Representative's written notice to proceed with the work.
- (iv) The Contractor has failed to remove materials from site or to dismantle or demolish and replace work for 7 days after receiving from the Engineer or his representative the written notice stating that the said materials or work were condemned and rejected by him under these conditions.

- (v) The Contractor is not executing the works in accordance with the contract or is persistently or flagrantly neglecting to carry out his obligations under the contract.
- (vi) Any bribe, commission, gift or advantage is given, promised or offered by or on behalf of the contractor to any officer, servant or representative of the Trustees or to any person on his or their behalf in relation to the obtaining or to the execution of the contract.
- (vii) The Contractor is adjudged insolvent or enters into composition with his creditors or being a company goes into liquidation either compulsory or voluntary.
- 8.3.1 Upon receipt of the letter of termination of work, which may be issued by the Engineer on behalf of the Trustees, the Contractor shall hand over all the Trustees' tools, plant and materials issued to him at the place to be ascertained from the Engineer, within 7 days of receipt of such letter.
- 8.3.2 In all such cases of Termination of work, the Trustees shall have the power to complete the work through any other agency at the Contractor's risk and expense and the Contractor shall be debited any sum or sums that may be expended in completing the work beyond the amount that would have been due to the Contractor, had he duly completed the whole of the work in accordance with the contract.
- 8.3.3 Upon termination of contract, the Contractor shall be entitled to receipt payment of only 90% of the value of work actually done or materials actually supplied by him and subject to recoveries as per contract, provided the work done and materials conform to specifications at the time of taking over by the Trustees. The payment for work shall be based on measurements of actual work done and priced at approved contract rates or other rates, as decided by the Engineer. The payment for materials supplied shall be at the rates as decided by the Engineer, which shall in no case be more than market rates prevailing at the time of taking over by the Trustees. The Engineer's decision in all such case shall be final, binding and conclusive.
- 8.3.4 The Trustees shall have the power to retain all moneys due to the Contractor until the work is completed by other agency and the Contractor's liabilities to the Trustees are known in all respect.

- 9.0 MAINTENANCE AND REFUND OF SECURITY DEPOSIT
- 9.1 On completion of execution of the work the Contractor Contractor's shall maintain the same for a period, as may be obligation for specified in the form of a Special Condition of the Contract, from the date mentioned in the Initial Completion Certificate in Form G.C.1. Any defect/fault, which may appear in the work during aforesaid maintenance period, arising, in the sole opinion of the Engineer or his representative, from materials or workmanship not in accordance with the contract or the instruction of the Engineer or his representative, shall, upon the written notice of the Engineer or his representative, be amended and made good by the Contractor at his own cost within seven days of the date of such notice, to the satisfaction of the Engineer or his representative, failing which the Engineer or his representative shall have the defects amended and made good through other agency at the Contractor's risk and cost and all expenses, consequent thereon or shall be recoverable from the incidental thereto. Contractor in any manner deemed suitable by the Engineer.
- 9.2 The Contract shall not be considered completed and the Certificate of work shall not be treated as finally accepted by the final completion Trustees, until a Final Completion Certificate in Form G.C.2 annexed hereto shall have been signed and issued by the Engineer to the contractor after all obligations under the Contract including that in the maintenance period, if any, have been fulfilled by the Contractor. Previous entry on the works or taking possession, working or using thereof by the Trustees shall not relieve the Contractor of his obligations under the contract for full and final completion of the work.
- 9.3 On completion of the contract in the manner aforesaid. Refund of the Contractor may apply for the refund of his Security Deposit by submitting o the Engineer (I) The Treasury Receipts granted for the amount of Security held by the Trustees, and (ii) his "No further claim" Certificate in Form G.C.3 annexed hereto (in original), where upon the Engineer shall issue Certificate in Form G.C.2 and within two months of the Engineer's recommendation, the Trustees shall refund the balance due against the Security Deposit to the Contractor, after making deduction therefrom in respect of any sum due to the Trustees from the Contractor.

10.0 INTERPRETATION OF CONTRACT DOCUMENTS, DISPUTES AND ARBITRATION

- 10.1 In all disputes, matters, claims, demands or questions Engineer's arising out of or connected with the interpretation of the decision Contract including the meaning of Specifications, drawings, designs and instructions or as to the quality of workmanship or as to the materials used in the work or the execution of the work whether during the progress of the works or after the completion and whether before or after the determination, abandonment or breach of the contract the decision of the Engineer shall be final and binding on all parties to the contractor.
- 10.2 If, the Contractor be dissatisfied with any such decision Chairman's of the Engineer, he shall within 15 days after receiving award. notice of such decision require that the matter shall be referred to Chairman, who shall thereupon consider and give a decision.
- 10.3 If, however, the Contractor be still dissatisfied with the Arbitration. decision of the Chairman, he shall, within 15 days after receiving notice of such decision require that within 60 days from his written notice, the Chairman shall refer the matter to an Arbitrator of the panel of Arbitrators to be maintained by the Trustees for the purpose and any such reference shall be deemed to be a submission to arbitration within the meaning of Indian Arbitration Act, 1940 or any statutory modification thereof.
- 10.3.1. If the Arbitrator so appointed is unable or unwilling to act or resigns his appointment or vacates his office due to any reason whatsoever, another person from panel shall be appointed as Sole Arbitrator and he shall proceed from the stage at which it was left by his predecessor.
- 10.3.2 The Arbitrator shall be deemed to have entered on reference on the date he issues notice to both the parties fixing the date of first hearing.
- 10.3.3 The time limit within which the Arbitrator shall submit his award shall normally be 4 months as provided in Indian Arbitration Act, 1940 or any amendment thereof. The Arbitrator may, if found necessary, enlarge the time for making and publishing the award, with the consent of the parties.

- 10.3.4 The venue of the arbitration shall be either Calcutta or Haldia as may be fixed by the Arbitrator in his sole discretion. Upon every or any such reference the cost of any incidental to the reference and award respectively shall be in the discretion of the Arbitrator who may determine, the amount thereof or by whom and to whom and in what manner the same shall be borne and paid.
- 10.3.5 The Award of the Arbitrator shall be final and binding on all parties subject to the provisions of the Indian Arbitration Act 1940 or any amendment thereof. The Arbitrator shall give a separate award in respect of each item of disputes and respective claim referred to him by each party and give reason for the award.
- 10.3.6 The Arbitrator shall consider the claims of all the parties to the contract within only the parameters of scope and conditions of the contract in question.
- 10.3.7 Save as otherwise provided in the contract the provisions of the Arbitration Act, 1940 and rules made thereunder, for the time being in force, shall apply to the arbitration proceedings under this Clause.
- 10.4 The Contractor shall not suspend or delay the work and proceed with the work with due diligence in accordance with Engineer's decision. The Engineer also shall not withhold any payment, which, according to him, is due or payable to the Contractor, on the ground that certain disputes have cropped up and are likely to be referred to arbitration.
 - 10.5 Provided always as follows:
 - [a] Nothing of the provisions in paragraphs 10.3 to 10.3.7 hereinabove would apply in the cases of contracts, where tendered amount appearing in the letter of acceptance of the tender / offer is less than Rs.40,00,000/-.
 - [b] The Contractor shall have to raise disputes or differences of any kind whatsoever in relation to the execution of the work to the Engineer within 30 days from the date of occurrence of the cause of dispute and before the preparation of the final bill, giving detailed justifications, in the context of contract conditions.

[c] Contractor's dispute, if any, arising only during the maintenance period, if any, stipulated in the contract, must be submitted to the Engineer, with detailed justifications in the context of contract Conditions, before the issuance of final completion certificate in Form G.C, 2.

No dispute or difference on any matters whatsoever, pertaining to the Contract can be raised by the contractor after submission of certificate in Form G.C. 3 by him.

- [d] Contractor's claim / dispute raised beyond the time limits prescribed in sub-clauses 10.5[b] and 10.5 [c] hereinabove, shall not be entertained by the Engineer and / or by any Arbitrator subsequently.
- [e] The Chairman / Trustees shall have the right to alter the panel of Arbitrators, vide Clause 10.3 hereinabove, on their sole discretion, by adding the names of new Arbitrators and / or by deleting the names of existing Arbitrators, without making any reference to the Contractor.
