You are requested to submit your sealed offer, as described below, for the subject work, considering enclosed Terms & Conditions (**Annexure – 'A'**), Scope of Work & Technical Specification for new 3 Star rating 1.5 TR Single Split type Hi- Wall Air Conditioner (with Remote) (**Annexure – 'B'**), Declaration of the Bidder (**Annexure – 'C'**), Bill of Quantity – Un Priced (**Annexure – 'D'**), Details of Excise Duty, Service Tax & Statutory Leavy (**Annexure – 'E'**) and Bill of Quantity – Price Bid (**Annexure – 'PRICE BID'**), downloading from the website.

The offer is to be submitted in three parts :-

Part- I – Proof of Earnest Money Deposit,

Part- II – Techno- Commercial Bid (Un- Priced) and

Part- III - Price Bid.

a) Part- I:

Proof of Earnest Money Deposit i.e. document in original is to be submitted separately in a sealed envelope super scribing '**Earnest Money**', '**Enquiry no. SDM(P&E)-IV/ 74/ ENQ/ 06 dated 13.06.2017**' and '**Due Date of Opening**'.

b) Part- II:

The Techno- Commercial Bid (Un- Priced) should be submitted in a sealed envelope distinctly super scribing '**TECHNO- COMMERCIAL BID (UN- PRICED)**', '**Enquiry no. SDM(P&E)-IV/ 74/ ENQ/ 06 dated 13.06.2017**' and '**Due Date of Opening**' on the envelope.

The Techno- Commercial Bid should contain :

- i) One set of the **enquiry letter**, along with Terms & Conditions (**Annexure – 'A'**), Scope of Work & Technical Specification for new 3 Star rating 1.5 TR Single Split type Hi- Wall Air Conditioner (with Remote) (**Annexure – 'B'**), Declaration of the Bidder (**Annexure – 'C'**) and Details of Excise Duty, Service Tax & Statutory Levy (**Annexure – 'E'**), duly signed and stamped, on each and every page, as token of acceptance of the same.

- ii) Bill of Quantity – Un - Priced in the format **Annexure- 'D'**, duly signed and stamped, indicating that the quotation has been made exactly as per the “Bill of Quantity” of the enquiry.
- iii) A declaration that the Price Bid does not contain any thing other than Bill of Quantity and Price in the format **Annexure- 'PRICE BID'**.
- iv) All documents & declarations as mentioned in the enquiry.
- v) Dealership Certificate(s), if applicable.

Documents in support of above are to be submitted in the envelope for Techno- Commercial Bid (Un- Priced) [Cover- II].

c) Part- III:

The Price Bid, as per **Bill of Quantity – Price Bid** (strictly in the format of **Annexure – 'PRICE BID'**) of the enquiry should be submitted in duplicate, in a sealed envelope, distinctly super scribing “**PRICE, DO NOT OPEN**” along with the ‘**Enquiry no. SDM(P&E)-IV/ 74/ ENQ/ 06 dated 13.06.2017**’. No extraneous conditions shall be included in the Priced Bill of Quantity.

The bidder would be given a maximum of 15 (fifteen) days time for submission of any document essential or otherwise not submitted along with their techno- commercial bids and also to submit clarification/ confirmation on commercial and technical deviations and withdraw any extraneous conditions which are not in line with HDC, KoPTs terms and conditions in respect of the tender.

The intending bidder(s) should be manufacturer of air conditioners/ authorized sales & service dealers of such manufacturers.

All the sealed envelopes under Part- I, Part- II & Part- III above should be sealed inside a **bigger envelope** and this bigger envelope, super scribed with **Enquiry no. SDM(P&E)-IV/ 74/ ENQ/ 06 dated 13.06.2017, Due Date of Opening and contents of the envelope** is to be submitted at the office of Plant & Equipment Division, Haldia Dock Complex (HDC), Kolkata Port Trust (KoPT), at the 1st Floor of Operational Administrative Building of HDC, KoPT, at Chiranjibpur, Haldia, **within 14:30 hrs. of 28.06.2017.**

The **Techno- Commercial Bid (Un-Priced)** of the offer **will be opened on 28.06.2017, 15:00 hrs. onwards**, at the office of Plant & Equipment Division, HDC, KoPT, at the 1st Floor of Operational Administrative Building of HDC, KoPT, at Chiranjibpur, Haldia. If Earnest Money Deposit is not found submitted/ attached along with the offer, the offer will not be considered and the same shall be liable for rejection.

In case of unscheduled Holiday/ unavoidable situation on the date of opening of the Bid, the same will be opened on the next working day, 15:00 Hrs. onwards. The bidder will also be allowed to deposit their Bid till 14:30 Hrs. on such extended day of opening of the bid.

HOWEVER, THE TENDER WILL NOT BE EXTENDED UNDER ANY SITUATION.

Bidders, whose offers will be found techno- commercially acceptable, shall be considered for opening of the price bids. The date, time & venue of opening of the price bids will be intimated to the techno- commercially qualified bidders subsequently and suitably.

The job will be governed by the following terms & conditions:

1. **THE TENDER WILL NOT BE EXTENDED UNDER ANY SITUATION.**
2. **Earnest Money:**

The offer shall have to be accompanied with Earnest Money Deposit, amounting to a sum of **Rs 3,376.00 (Rupees Three Thousand Three Hundred Seventy Six) only.**

Earnest Money shall have to be deposited by Demand Draft/ Banker's Cheque/ Pay Order, issued from any Nationalized Bank/ Scheduled Bank of India, drawn in favour of "Kolkata Port Trust, Haldia Dock Complex", payable at Haldia. **The original Demand Draft/ Banker's Cheque/ Pay Order shall be kept attached with the offer in a separate sealed envelope (Cover – I), super scribing the Enquiry Number, Banker's Cheque Number/ Bank Draft Number/ Pay Order Number and Amount.**

The tenderer may also deposit the Earnest Money in Cash at the Cash Office of Manager (Finance), Haldia Dock Complex (HDC), Kolkata Port Trust (KoPT) at Jawahar Tower, P.O.: Haldia Township, Dist.: Purba Medinipur, West Bengal, Pin- 721607 and shall obtain the Treasury Receipt of the same. The said Treasury Receipt, as a proof of deposition of Earnest Money shall be kept attached with the offer in a separate sealed envelope (Cover- I), super scribing the Enquiry Number, Treasury Receipt Number and Amount.

If Earnest Money Deposit is not found submitted/ attached along with the offer, the offer will not be considered and the same shall be liable for rejection.

Earnest Money deposited by unsuccessful bidder(s) will be refunded, with out any interest.

Earnest Money deposited by successful bidder (i.e. the contractor) will be refunded with out any interest, after recovery of the amount, towards **security deposit**, from the bill(s) of the contractor.

Earnest Money may be liable for forfeiture at the option of the Trustees, if the Tenderer withdraws his offer within the validity period of the offer and/ or alters/ amends any terms and/ or condition and/ or quoted rate(s), within the validity period of the offer (excepting when option to do the same has been specially granted by Kolkata Port Trust in writing) making in unacceptable to KoPT, and/ or **in case of successful tenderer**, fails to carry out the work or to perform/ observe any of the conditions of the contract.

3. The price(s) should be quoted **on FOR Haldia site basis** and should remain firm. All taxes, duties, freight, transit insurance etc. as applicable should be indicated separately.

Haldia Dock Complex (HDC), Kolkata Port Trust (KoPT) do not enjoy any concession regarding Sales Tax/ VAT and do not provide any 'C' or 'D' Form in this regard. Hence, full amount of VAT or C.S.T. or State Sales Tax, if any, will be applicable and to be charged accordingly. Excise Duty and Service Tax, if applicable, would be paid on production of CENVATABLE Document. Kolkata Port Trust (KoPT) is not a Registered Body Corporate as per Service Tax Law.

4. **Payment Terms:** Payment will be made on the exact quantity, which would be executed by the Contractor. 95 % payment will be made within 30 days, after successful completion of the work, in line with the instant Enquiry, against submission of clear & unambiguous bill, along with certification against supply & delivery and installation, testing & commissioning, as applicable. Balance 5 % payment, which will be retained as **Security Deposit**, will be made, without any interest, after successful completion of the guarantee period.

5. **Completion period:** The contractor would have to complete the total work by supplying, delivering, installing & commissioning of the air conditioners, as stipulated in the enquiry, **within 30 (thirty) days**, from the date of placement of order, on the contractor.
6. **Inspection & Testing:** Physical checking of the air conditioning machines will be carried out at store/ site/ premises, as per technical specification for the same, subject to submission of Manufacturer's Test Certificate, as applicable, for verification. For other materials required for installation, visual inspection will be carried out at site, as applicable. At least 3 (three) days' advance notice is to be given for inspection. After completion of installation, the air conditioning system should be put in to operation for a period of 3 (three) days for checking of overall performance of the same. The contractor will have to provide all facilities for inspection of the materials, at their own risk, cost and arrangement. Inspection & testing of the materials by the representative/ authorized agency of Sr. Dy. Manager (P&E), HDC shall not relieve the contractor, from his obligation, for furnishing equipments in accordance with the specifications.
7. **Guarantee:** The materials supplied and work executed by the Contractor will have to be guaranteed for a period of **12 (twelve) months, from the date of complete execution of the work**. The Contractor shall be responsible for making good, with all possible speed, at their expense, any defect, which may occur before expiry of **12 (twelve) months from the date of complete execution of the work**. The inspection will not relieve the contractor from his liability of guaranteeing against defective materials and full satisfactory performance up to the stipulated Guarantee Period.
8. **Liquidated Damage Clause:** In the event of failure of the contractor to execute the contract within the stipulated dates or such extension(s) thereof, as may be allowed by the Sr. Dy. Manager (P&E) in writing, the contractor will be required to pay as compensation to the Trustees and not as penalty @ **½% for every week or part thereof of the unexecuted portion of work**, provided always the entire amount of compensation to be paid under the provision of this clause shall not exceed 10 % of the total contract value. The Trustees may without prejudice to any other method of recovery, deduct the amount of such damages from any money, which is due or which may become due to the contractor. The payment or deduction of such damages shall not relieve the contractor from his obligation to complete the supply of the materials or from any other of his obligation or liabilities under the contract.
9. **Force Majeure:** In the event of either party being rendered unable by Force Majeure to perform any obligations required to be performed by them under the contract, the relative obligation of the party affected by such Force Majeure shall upon notification to the other party be suspended for the period during which Force Majeure event lasts. The cost and loss sustained by either party shall be borne by respective parties. The terms Force Majeure as employed herein shall mean acts of God, Earthquake, War, Revolt, Riot, Fire, Floods, Sabotage and Hurricanes/Cyclone, Strike excluding that of contractors & suppliers or Sub-contractor's Employees. Upon the occurrence of such case and upon its termination the party alleging that it has been rendered unable as aforesaid, shall notify the other party in writing immediately but not later than 48 (forty-eight) hours of the alleged beginning and ending thereof giving full particulars and satisfactory evidence in support of its claim.
10. **Validity:** The validity of the offer should **not be less than 60 days from the date of opening of the offer (Techno- Commercial Part)**.
11. **Kolkata Port Trust/ Haldia Dock Complex** reserves the right to accept or reject the offer and do not bind themselves to accept the offer or to assign any reason thereof and no damage claim whatsoever will be payable by **Kolkata Port Trust**.
12. **The intending bidder(s) should be manufacturer of air conditioners/ authorized sales & service dealers of such manufacturers.**
13. **The bidder will have to submit photocopies of the following documents as additional documents:**
 - (a) Valid Professional Tax Clearance Certificate/ Up to date Professional Tax Payment Challan, if applicable. Documentary evidence of clearance/ payment challan valid up to 31st March of the last completed accounting year may be submitted by the bidder. However, it would be the responsibility of the contractor to comply with the requirements of the concerned authority during entire tenure of the contract,
 - (b) VAT Registration Certificate and
 - (c) Valid Service Tax Registration Certificate.

14. Dealership certificate, if applicable, photocopy of the same is to be submitted along with the offer.
15. The bidder shall have to give a declaration in the enclosed format [**Annexure- ‘C’**] regarding banning or delisting by any Government or Quasi- Government Agencies or PSUs. If this declaration is not found enclosed along with their offer, the same may be rejected as non-responsive.
16. **Pricing and Evaluation Criteria:**

Prices are to be quoted in Indian Rupees (INR) only for all the items as per Bill of Quantity (BOQ). Rates are to be quoted strictly as per Bill of Quantity inclusive of all charges but excluding taxes, duties etc. Rates of applicable taxes, duties, levies etc. should be indicated separately, in **Annexure- ‘E’**.

During evaluation, the quoted rates against BOQ item sl. no. 1 (a) & 1 (b) including taxes, duties, levies etc. and all other charges, as applicable, shall be considered for evaluation.

Evaluation will be made on the basis of overall lowest offer of the techno- commercially qualified bidder(s) meeting all terms & conditions of the enquiry.

It is not obligatory on the part of the Trustees to accept the lowest tender. **They reserve the right to accept a tender in full or reject a tender without assigning any reason thereof.**

Price quoted against BoQ item sl no. 2 will not be considered for evaluation purpose. However, during installation & commissioning of the 1.5 TR single split type hi- wall air conditioners, if material(s) as per description of BoQ item sl. no. 2 is/ are required, then the contractor will be paid at the quoted rate(s) for actual quantity used during execution.

Price quoted should remain firm during the validity period of the offer, including any/ all extension thereof, agreed by the bidder.

In case, it is found that the **Total Price** (in **Indian Rupees**) [arrived as per the above procedure] is same for two or more bidders and their offers become the lowest offers, the respective bidders will be given chance to submit their fresh Price Bid subject to the condition that the fresh price so quoted must be less than the price quoted earlier by the respective bidders.

17. In the event of part order being placed, the rate(s) against each of the item(s) constituting the order shall be identical to the rate(s) for the corresponding item(s) quoted in the Price Bid. Tender terms & conditions shall also remain unaltered irrespective of whether order is placed in a whole or part of the BoQ. No plea for subsequent withdrawal or amendment of the offer will be entertained.
18. **If terms & conditions of the enquiry have not been accepted by any bidder, offer of the bidder may be liable for rejection.**

SCOPE OF WORK AND TECHNICAL SPECIFICATION for supply, delivery, installation & commissioning of 4 (four) sets of new 3 Star rating 1.5 TR Single Split type Hi- Wall Air Conditioner (with Remote), at 2 (two) nos. 'D' type quarter of Haldia Dock Complex (HDC), Kolkata Port Trust (KoPT), at Haldia Township, Haldia.

Scope of Work of the contractor includes supply, delivery, installation & commissioning of 4 (four) sets of new 3 Star rating 1.5 TR Single Split type Hi- Wall Air Conditioner (with Remote), at 2 (two) nos. 'D' type quarter of HDC, KoPT, at Haldia Township, Haldia. The said air conditioners will be under custody of the contractor till completion of installation & commissioning of the same at the said 'D' type quarters of HDC, KoPT, at Haldia Township, Haldia.

As such, 2 (two) sets of the air conditioner would have to be supplied, installed and commissioned, at the drawing room area (including dinning space), at the ground floor of our 'D' type Bunglow no. 4/ 81 at Haldia Township. Other 2 (two) sets of the air conditioner would have to be supplied, installed and commissioned, at the drawing room area (including dinning space), at the ground floor of our 'D' type Bunglow no. 6/ 14 at Haldia Township.

The work includes required structures for installation of the air conditioners (by supplying 2 nos. bracket for holding the out door unit of each set of air conditioner), necessary masonry work, necessary mending good work, supply & installation of required SPN MCBs etc.

Make/ Brand of Single Split type Hi- wall Air Conditioner: Carrier/ Carrier Midea/ Voltas/ Blue Star/ Hitachi / Videocon/ Samsung / LG / Whirlpool/ Godrej. Model of Single Split type Hi- wall Air conditioner will be **with Remote** for operation.

Minimum guaranteed Energy Efficiency Ratio (W/W) should be rated as **"3 Star"**, as per Star Rating Plan of Bureau of Energy Efficiency, as applicable or equivalent.

In connection with installation of the Air Conditioner at the above mentioned place, the bidders are requested to note the following :

1. The Single Split type Hi- Wall Air Conditioner with Remote, complete with evaporating unit and condensing unit in separate casing, as per manufacturer's design, should be installed properly in conjunction with refrigerant piping, insulation, cabling, drain piping, foundation etc. Separate structure for installation of Indoor and Outdoor Units, whenever necessary, all masonry work such as foundation and fixing of various components of the system, including breaking and making good of holes in structure/ walls for passage of pipes, cables, duct etc. including mending good work, if required, should be done by the contractor. Copper refrigerant pipes and drain pipes will have to be clamped properly on walls/ angles etc.

This includes supply & installation of suitable MCB in MS Box, point wiring including supply of PVC insulated copper wire (of size not less than 2.5 sq. mm.) of 1100 Volts grade, conforming IS: 694, from nearest electrical power source of HDC (i.e. incoming power source of the 'D' type quarter, under the stair case to 1st floor of the building), earthing etc., supply of structures for outdoor & indoor unit and other required materials for installation of air conditioners, as per Scope of Work and Technical Specification of the Enquiry. Point wiring (for power supply to the air conditioner) would have to be executed by supplying and fixing of casing capping of required size & length

It is estimated that running distance in between existing electrical power source of HDC, as described above, up to the indoor unit of the air conditioner to be supplied and installed would be around 17 Mtrs.

For the purpose of earthing, the earth wire of required size, is to be provided in between the new installation of air conditioning unit and existing earth source of the building.

2. SPN MCB (Miniature Circuit Breaker) of 'C' type load characteristics and conforming to relevant BIS specifications of suitable rating for 1.5 TR Single Split type Hi- wall Air Conditioner, as required, for termination of the said cable, to be provided by the contractor.

The contractor should preferably indicate the location of power source, type of power source i.e. single phase/ three phase and rating in Amps. for the aforesaid Single Split type Hi- Wall Air Conditioning system in their offer.

Cooling coil of indoor unit and condenser coil of outdoor unit will have to be of copper only.

3. The bidder should consider installation charges for Air Conditioner, considering required length of copper refrigerant pipe with insulation, power cable & drain pipe, between Outdoor Unit & Indoor Unit for the 1.5 TR Single Split type Hi- wall Air Conditioner.

However, it is requested to arrange to visit the site of proposed installation of the Air Conditioners, before submitting your offer.

4. The work includes charging refrigerant gas and fitment of drain pipe for draining out of condensate drain water, if required, for commissioning of the Air Conditioner.
5. The work includes earthing of the Air Conditioner, as per relevant Indian Standard Specification, up to nearest source for earthing, which will be provided by Haldia Dock Complex. For the purpose of earthing, the earth wire of required size, is to be provided in between the new installation of air conditioning unit and existing earth source of the building.
6. All other items required for installation & commissioning of the 1.5 TR Single Split type Hi- wall Air Conditioners in addition to details provided in the Scope of Work, Bill of Quantity etc. are also to be considered, under the Scope of Work and rates are to be quoted accordingly.
7. **Electricity** and **water**, if required, will be provided **free of cost** for installation & commissioning of the Air Conditioners.
8. Prior to submitting the bid, the bidders may visit site for assessment of the job in total and to get acquainted with the site conditions.
9. All mending good jobs in minor nature will be responsibility of the contractor.
10. The exact place of installation of the Air Conditioners will be shown to the contractor by authorized representative(s) of Plant & Equipment Division, Haldia Dock Complex.
11. During Guarantee Period [12 months from the date of commissioning and handing over of the installation to HDC], quarterly servicing & maintenance, free of cost, is to be carried out and joint certification with HDC- KoPT's representatives in this regard are to be furnished by the contractor. In case of break down of the Air Conditioning system, that should be attended at the earliest, but not beyond 24 hrs. Servicing Center should be equipped accordingly. Address and Phone number of the servicing center should be intimated by the contractor. If required, the contractor may have to work on Sunday/ Holiday and beyond normal working hours, for re- commissioning of the Air Conditioning system. The Guarantee period would be suitably extended for the period for which quarterly service & maintenance as well as breakdown maintenance remain pending / unattended & un-rectified beyond stipulated time, as detailed herein.
