## Terms and Conditions of Quotation

- 1. **Manufacturers or their Authorised Dealers/ Stockist**: Manufacturers or their Authorised Dealers/ Stockist are eligible to quote their offer. In this regard:-
  - Authorised Dealers/ Stockist: Authorised Dealers/ Stockist should submit valid dealership/stockistship Certificate from their Manufacturer.
- 2. **Credential:** Credential for supply and delivery **of CR80 Crane Rail** for a minimum cumulative quantity of 25 M.T. to Govt. Organisations /PSUs /Reputed Private Organisations during last 5 years i.e. from Jan' 2013 to Dec' 2017 should be substantiated by producing order copy(s) along with any one of the following documents:
  - i) Receipted Challan by the Consignee,
  - ii) Certificate of Execution,
  - iii) GRN,
  - iv) Consignment Note.
    - etc. as a proof of supply.
- 3. GST Registration Certificate: Copy of GST Registration Certificate to be submitted.
- 4. Trade Licence: Valid Trade Licence to be submitted.
- 5. Upto date Professional Tax Payment Challan: Copy of Upto date Professional Tax Payment Challan to be submitted.
- 6. Scope of Work: The work comprises of Supply and Delivery of 35.50 M.T. CR80 Crane Rail of 13 M. standard length conforming to IS: 3443 of Latest Revision to Haldia Dock Complex, Kolkata Port Trust. The materials should be supplied as per the BOQ & terms & condition of the Quotation Document.
- 7. Place of delivery: Materials will be delivered at **Dock Zone Store of I&CF Divn.**, at Haldia, Haldia Dock Complex, Purba Medinipur-721607 at party's own cost, risk & arrangement.
- 8. **Delivery Period**: The materials supplied by the supplier should strictly conform to the laid down specification of Quotation /Order. The supply would require to be completed within 45 days from the date of receipt of work order. Maximum 2 part delivery will be allowed.
- 9. Pricing Of Bid: Rate should be quoted F.O.R. Trustees' Store Yard at Haldia i.e. on free delivery basis including unloading and stacking.

Price(s) to be quoted must remain firm till the goods are delivered. No Price Escalation is admissible other than statutory increase in Taxes, Duties etc / imposition of new taxes and duties after last date of submission of Tender.

The quoted prices must include all charges, such as permits, overheads, profit, charges for packing, loading, forwarding, transportation, unloading and stacking at the Stores at Haldia etc.

10. **Inspection**: Inspection of all materials shall be carried out at the depot of the Manufacturer / Supplier by RITES or RDSO/Indian Railway Board approved agency.

Inspection charges payable to RITES/ RDSO/Indian Railway Board approved agency shall be paid by the bidder and shall be included in the quoted rates.

Notwithstanding the inspection and passing of materials by RITES/ RDSO/Indian Railway Board approved agency, any material found at the time of delivery to be defective in quality and not conforming to the specified shape, size and

weight as per the relevant drawing and specification due to any reason whatsoever, shall be liable to rejection and the supplier shall replace the same at his own cost and arrangement at the earliest.

The Supplier shall ensure that no material gets damaged prior to their final acceptance. Notwithstanding the inspection and passing of materials by RITES/ RDSO/Indian Railway Board approved agency, any material found at the time of acceptance to be damaged due to any reason whatsoever, including labour handling during unloading, carrying and stacking, shall be liable to rejection and the supplier shall replace the same at his cost and arrangement at the earliest.

- 11. **Payment**: Payment will be made within 30 days of delivery & acceptance of goods at **H.D.C.**'s Store on submission of clear bill (in triplicate) & other relevant documents (in duplicate). Payment will be made to Bank of the supplier & will be credited to supplier's current account. Bidders must mention their Bank Account no.; Branch & address of Bank & other details.
- 12. Validity: The offers shall remain valid for 60 days from the date of offer.
- 13. Evaluation Criteria: The Overall lowest offer received will be considered for acceptance by the Trustees subject to further negotiations, if felt necessary. The Trustees/Haldia Dock Complex, Kolkata Port Trust are not bound to accept the lowest of any tender and reserved the right to accept in tender in full or in part and / or reject a tender in full or in part without assigning any reason thereof.
- 14. Liquidated Damages: In the event of failure to execute the Contract within the stipulated date or, such extension thereof as may be allowed by HDC Authority, Supplier shall be required to pay, as compensation to the Trustees (Liquidated Damage), and not as penalty, @ 1/2% of the cost of **delayed portion** of supply for every week delay in supply (part of the week being treated as a full week), provided always that the amount of such compensation under the provision of this clause does not exceed **10%** of the contract value of the goods.
