# PROCEDURE OF PAYMENT OF EARNEST MONEY AND BID DOCUMENT FEE <u>THROUGH AXIS BANK GATEWAY</u>

1. The Bidders would be able to access the payment gateway from the Vendor log in page of the MSTC ecommerce site (*www.mstcecommerce.com* $\rightarrow$  *e-Procurement* $\rightarrow$ *Psu* / *Govt depts.*

- 4 i) Micro & Small Enterprises (MSEs) registered with NSIC under Single AGREE Point Registration Scheme (SPRS) are eligible to get the benefits under new Public Procurement policies for MSEs as notified by Govt. of India, Ministry of Micro, Small & Medium Enterprises (MSME) vide Gazette Notification, dated 26.03.2012.

ii) When splitting of tender quantity is not possible purely on technical ground, trustees reserve the right not to negotiate price with MSE if their price is within the band of L1+15% in comparison with L1 price of non-MSE for consideration of award of order for 20% of tender quantity against any item as per new public procurement policy.

- 5 If Micro & Small Enterprises (MSEs) registered with NSIC intends to AGREE participate in the tender, for the items they are not registered with NSIC, then they will have to deposit cost of Tender Document, full amount of Earnest Money as per NIT. Otherwise their offer for those items will not be considered.
- 6 Tenders without requisite Earnest Money are liable to be rejected AGREE except in case of Micro & Small Enterprises (MSEs) registered with NSIC (under single point registration scheme) for items for which the tender is invited.

- 12 The Trustees also reserve the right to obtain revised commercial bid to the extent AGREE and in areas required from the technically acceptable bidders.
- 13 The Trustees are not bound to accept the lowest or any Tender and reserve the AGREE right to accept a tender in full or in part and / or reject a tender in full or in part without assigning any reason thereof.
- 14 The contract shall be governed by all relevant Indian Acts applicable only within AGREE the jurisdiction of the High Court at Kolkata.
- 15 Intending bidders must take into account any cost or expense incurred by them in AGREE connection with the preparation and delivery of their bids or for any other expenses incurred in connection with such bidding.
- 16 Bidders may visit the Office of Sr. Dy. Manager (I&CF) of Haldia Dock Complex at AGREE Chiranjibpur, Haldia prior to submission of their bid. Bidder shall get himself thoroughly familiarized with the site conditions, existing road facilities for carrying materials etc. before submission of the tender. He may contact the Sr. Dy. Manager of M.M. Division or his authorized representative at his office at Jawahar Tower in this regard. Non compliance of the same will in no way relieve the successful bidder of any of his obligations in performing the work in accordance with this Bid Document within the quoted price.

# 17 **VALIDITY**:

No Lorry shall be permitted into the protected area during night-time. Detention of Lorries, if any, will be on Supplier's account.

## 26 **INSPECTION** :

**i)** Inspection of the Switches and CMS Crossings as per the specification laid down in the BOQ shall be carried out by RITES / RDSO at the depot of the suppliers or as directed by RITES/RDSO.

ii) RITES/RDSO should conform that :

**a)** Parts, fittings & fixtures used for fabrication by the supplier are manufactured by approved RDSO manufacturers wherever applicable. Necessary certificates/lists may be provided.

**b)** The Rails used for fabrication are T-12 (1st quality) Rails and have been procured from SAIL. Necessary documents regarding the procurement of T-12 Rails from SAIL should be enclosed.

**iii)** Inspection charges payable to RITES/RDSO shall be paid by the Supplier(s) and shall be included in the quoted rates. No supply shall be accepted without satisfactory Inspection certificate.

**iv)** Not withstanding the inspection and passing of materials by RITES/RDSO, any material found at the time of delivery to be defective in quality and not conforming to the specified shape, size and weight as per the relevant drawing and specification due to any reason whatsoever, shall be liable to rejection and the supplier shall replace the same at his cost and arrangement at the earliest.

**vi)** The supplier shall ensure that no materials get damaged prior to their final acceptance. Notwithstanding the inspection and passing of materials by RITES/RDSO, any materials found at the time of acceptance to be damaged due to any reason whatsoever, including labour handling during unloading carrying and stacking, shall be liable to rejection and the supplier shall replace the same at his cost and arrangement at the earliest.

## 27 **GUARANTEE CERTIFICATE :**

The materials, with all accessories and attachments, shall have to be guaranteed by the supplier against the manufacturing defects or, poor performance for a period of 12 months from the date of commissioning or, 18 months from the date of acceptance whichever is earlier. If any defect whatsoever develops during the Guarantee Period, the defective materials will have to be replaced/rectified, as the case may be, by the Bidder at their own cost. Delay in honoring the guarantee would cause the guarantee period to be extended for similar period.

### 28 **INSPECTION REPORT**:

The successful bidder will be required to submit inspection report alongwith the supplies.

### 29 **BIS LICENCE** :

### 30 TRANSIT RISK :

# 31 **DOCK PERMITS**:

The successful Bidder shall have to obtain permits for entry of their vehicles and workers into the Trustees' Stores for unloading and stacking of the material. Upon occurrence of such cause and upon its termination, the party alleging that it has been rendered unable as aforesaid, shall notify the other party in writing immediately but not later 7 (seven) days after the alleged beginning thereof, giving full particulars and satisfactory evidence in support of its claim.

#### 37 **JURISDICTION OF COURT**:

The contract shall be governed by all relevant Indian Acts applicable within the jurisdiction of High Court at Kolkata.

#### 38 WORKMEN COMPENSATION :

The successful bidder(s) must cover his employees / workers, who will be engaged for delivery, unloading & stacking job at HDC's site, under workmen compensation act, fatal accident act and personal injuries insurance act for protection against any injury / accident and shall have to bear all the consequences and cost as applicable as per relevant acts.
