The intending bidders should have successfully completed repairs/ construction of vessels / navigational aids involving steel renewal during the last 7 (seven) years ending on 28.2.2018 and the experience should be either of the following:

(a). Three completed works each costing not less than 40% of the estimated value i.e. Rs.67.20 Lakh.

or

(b). Two completed works each costing not less than 50% of the estimated value i.e. Rs.84 Lakh.

or

- (c). One completed work costing not less than 80% of the estimated value i.e. Rs.134.40 Lakh.
- 2. The Average Annual Financial Turnover of the bidding firm should be at least 30% of the estimated value of the work in the preceding three years ending 31.03.2017 i.e. Rs.50.40 Lakh.
- 3. The bidder must have own/hired yard / slipway in or around Kolkata, suitable for carrying out construction of navigational buoys.

1.0 INSTRUCTIONS TO THE BIDDERS.

- 1.1 Mere downloading of tender document will not mean that a particular Bidder will be automatically considered qualified and their bid will be entertained. Such qualifications will be reviewed at the time of evaluation of bids.
- 1.2 In case there is an unscheduled Holiday / Bundh / Strike on the prescribed date of pre-bid meeting or last date of submission of the tender, the next working date will be treated as the scheduled prescribed date for the same.

Parties downloading the tender paper should ensure submission of Original Demand Draft/Banker's Cheque/Pay Order payable to 'Kolkata Port Trust' for an amount of 2950/- including GST being the tender fee, failing which the tender will not be considered.

- 1.5 Kolkata Port Trust reserves the right to reject all the tenders or to accept any tender in whole or in part without assigning any reason whatsoever.
- 1.6 Further amendments, if any, would also appear in the same website.
- 1.7 Bidders are advised to submit quotations online based upon Technical Specification, terms and conditions, Scope of Work contained in the Bid Document and General Conditions of Contract and not to stipulate any deviation. Should it, however, become unavoidable, deviations should be suggested during off-line pre bid meeting. KoPT reserves the right to accept or reject the suggested deviations. - 1.8 The information being provided in this Tender Document does not relieve the Bidders from carrying out the works to suit the specified needs. The Bidders may inspect the light float at their own cost and risk and use any and every other method to ensure the adequacy of their offer.
- 1.9 Bid Document shall remain the property of Kolkata Port Trust. One Bid Document to be retained by the bidder.

- 1.10 KOLKATA PORT TRUST will not be responsible for any costs or expenses incurred by the Bidder in connection with the preparation and submission of his bid or for any other expenses incurred in connection with such bidding.
- 1.11 The work to be done as described in bid-document. The Bidders who need clarifications on any specific issue shall inform the Engineer in writing well in advance of the date of pre-bid discussion at the address given in clause 1.13 below.
- 1.12 The Bidders shall specially undertake to keep his offer valid for acceptance upto 180 days from the date of opening of Techno-Commercial Bid (Part-I) and to abide by all the conditions laid down in the Bid Document.
- 1.13 If the bidders find any discrepancy or omission in the Bid document or have any doubt as to the meaning or intent of any part thereof, they shall at once inform the Engineer, who may send a written explanation to the queries. Bidders are also requested not to depute any of their personnel or agent to visit Kolkata Port Trust's Offices for making such inquiries. Should Kolkata Port Trust find it necessary to seek any clarification, technical or otherwise, the concerned bidder will be duly contacted by Kolkata Port Trust.
- 1.15 Canvassing in any form by the Bidder or by any other agency acting on behalf of the Bidder after submission of the bid will disqualify the said bidder.
- 1.16 The General Conditions of Contract of Kolkata Port shall be applicable wherever relevant. The GCC may be downloaded from KoPT website, 'Homepage Rule and Regulations Non Service Regulations'.

2.0 INSTRUCTIONS FOR FILLING UP THE BIDS

- 2.1 The bids can only be submitted in the name of the bidder, who has downloaded the bid documents.
- 2.2 The Bid any annotations or accompanying documentation shall be in English language only and in metric system.
- 2.3 Bidders shall sign their proposal and all uploaded documents with the exact name of the firm. The bid shall be duly signed by an authorized executive officer of the bidder's organization.
- 2.4 Each page of the submitted (during signing of agreement) 'Bid document' shall be signed by a duly authorized officer and in case of a Corporation; same shall be sealed with the corporate seal or otherwise appropriately executed under seal.

- 2.5 Bidders shall clearly indicate their legal constitution and the person signing the tender and also shall state his capacity and also the source of his ability to bind the bidder. The power of attorney or authorization or any other document constituting adequate proof of the ability of the signatory to bind the bidder, shall be annexed to the bid. Kolkata Port Trust may reject outright any bid unsupported by adequate proof of the signatory's authority.
- 2.6 The tender shall be completed in all respect as per the checklist and shall be submitted together with requisite information and appendices. It shall be completed and free from ambiguity, change or inter lineation.
- 2.7 Bidders should indicate at the time of quoting against this bid their full postal and fax/E-mail address.
- 2.8 Changes to terms and conditions as enumerated in the bid document will not be valid unless notified by Kolkata Port Trust in writing to the bidder.
- 2.9 Kolkata Port Trust reserves the right to ask any one of the bidders, who have submitted their price quotations to submit a break-up of the submitted prices with adequate justification to establish for each such component. Bidders to confirm in writing in the form of Tender that should Kolkata Port Trust deem it necessary to ask for such a break up of quoted price, they will be duty bound to do so as requested by KoPT, they shall be further duty bound to provide justification to the same, failing which or if their justification of prices are found unacceptable to KoPT, their Tender may be cancelled by Kolkata Port Trust.
- 2.10 Director, Marine Department or his representative may convene meeting with the bidders with prior notice which the bidders will have to attend, failing which, decisions of the Director, Marine Department taken unilaterally will be final and binding on the bidders.
- 2.11 E-mailed/faxed / physical delivery offers will not be considered. Bidders shall prepare their bid themselves. Bids prepared by agents will not be given cognizance.

3.0 MODE OF SUBMISSION OF BID

3.1 Tenders shall be submitted online in two parts i.e. Part-I & Part -II. Part -I should constitute the Technical Bid and terms and conditions of offer and Part-II should constitute only the Price Bid without any deviation and condition.

3.2 Part-I (Techno-Commercial) will contain the following documents (check list of submission of bid):

- b) Photo copy of current Trade License, GST registration documents, if applicable and Audited Balance Sheet for last 3 (three) years (2014-15, 2015-16 & 2016-17) along with Profit & Loss A/c of relevant years.

- c) Photo copy of documents relating to details of Similar Works previously carried out (performance certificate) by the firm with value & period of each work.
- d) Photo copy of documents as proof of having yard / slipway facility.
- e) Photo copy of the Bank Draft/Bankers Cheque/Pay Order payable to "Kolkata Port Trust" of Rs. 2950/- including GST as cost of tender document (Tender Fee).
- f) Photo copy of Bank Draft/Bankers' cheque/Pay order payable to "Kolkata Port Trust" as **Earnest Money Deposit**.
- g) Letter of authority, if any.
- h) Filled up "Form of Tender" as per enclosed proforma.
- i) Photo copy of ESI Registration certificate. In case the firm is not covered under ESI Act or exempted, they should furnish necessary documents along with an affidavit in original affirmed before a 1st Class Judicial Magistrate in a non-judicial stamp paper worth Rs.10/- to that effect as per enclosed KoPT approved format (Annexure-A). In addition that the Tenderer must indemnify KoPT against all damages and accidents occurring to their staff in a non-judicial stamp paper worth Rs.50/- as per enclosed format (Annexure-B).
- j) Certificate/declaration of compliance with Minimum Wages Act.
- k) Photo copy of Current P.F. Statement or in case they are exempted under Provident fund act, they would furnish necessary documents along with an affidavit affirmed before a first class Judicial Magistrate to the effect as per enclosed Proforma (Annexure-C).
- I) Photo copy of PAN card and details of Bank particulars for payments through ECS.
- m) A separate letter addressing to Director, Marine Department, Kolkata Port Trust, confirming that the tenderer has accepted all terms and conditions laid down in the Bid Document.
- n) A undertaking that "The bidder has fully read and understood the entire Tender Document, GCC and Addenda, if any downloaded from under the instant e-tender and no other source, and will comply to the said document, GCC and Addenda." With this, there will be no necessity to upload signed bid document and GCC.

Note: KoPT reserves the right to verify the aforesaid documents and the bidder is bound to bring the original documents at the time of verification by KoPT authority.

3.4 Part -II (Price Bid) shall contain only the 'Price Bid' as per the format without any condition or deviation.

4.0 EARNEST MONEY DEPOSIT:

- 4.1 The bidders shall be required to deposit INR **Rs. 3,36,000**/-(Rupees Three Lakh and Thirty Six Thousand only) as 'Earnest Money Deposit' (EMD) payable to 'Kolkata Port Trust' by Banker's Cheque or Pay Order or Demand Draft, payable at Kolkata physically prior to the scheduled time and date of opening of techno-commercial bid.
- 4.2 Earnest Money of unsuccessful bidders will be refunded within 2 months of opening the Price bid or on finalization / acceptance of tender, whichever is earlier. If Price bid is opened before expiry of validity of Earnest Money Instrument, the same will be refunded to bidders other than the L-I bidder. EMD of L-I bidder will only be encashed. If Price bid cannot be opened for any reason before expiry date of Earnest Money Instrument, the bidder would be requested to extend the validity of the EMD Instrument within the validity period of the offer, failing which the EMD instrument would be encashed. Tender submitted without EMD shall not be considered.
- 4.3 After conclusion of tender process, EMD of successful bidder will be returned without interest after submission of Security Deposit. However, the contractor may be allowed to convert the EMD as a part of Security Deposit. In case the successful bidder fails to accept the contract or fails to submit the Security Deposit, the EMD will be liable for forfeiture.
- 4.4 EXEMPTION: Micro & Small Enterprises (MSEs) registered with NSIC (under single point registration scheme) are exempted from depositing Cost of Tender Document and Earnest Money having valid NSIC Certificate for MSEs along with DIC's (DISTRICK INDUSTRIES CENTRE) Certificate.

5.0 SECURITY DEPOSIT

- 5.1 Successful bidder will submit Security Deposit for a sum equivalent to 10% of the total evaluated value as per price bid of the tender, as accepted by KoPT, in Demand Draft or in the form of Bank Guarantee as per the enclosed format at Annexure-III in favour of 'Kolkata Port Trust' from a National/Scheduled Indian Bank with branch at Kolkata In the event of issuing Bank Guarantee by any branch outside Kolkata, any Kolkata Branch of such Bank shall confirm the same and stand by for all the commitments under the Bank Guarantee. In all cases, any dispute regarding such Bank Guarantee will be adjudicated under the jurisdiction of The Kolkata High Court. In case of Bank Guarantee, the same shall remain valid for 3 months after the final expiry of the guarantee period. The Security Deposit will be released within 60 days after successful completion of the contract period.
- 5.2 The Director, Marine Department shall have the right to ask for the extension of the above Bank Guarantee till such time the Contractual obligations are fulfilled and the Contractor will be duty bound to extend the same.

5.3 After the issuance of 'Letter of Intent', Security Deposit will have to be submitted within 15 working days and formal agreement is to be executed as per format provided in GCC along with a contract document including GCC, tender documents, all addendum, amendments, clarification etc. duly signed and stamped every pages. Work order will be issued immediately after receipt of Security Deposit.

6.0 DUTIES & TAXES.

- (a) The prices quoted shall be including all statutory levies excluding GST, which will be paid extra.
- (b) Supplier/service provided to confirm that the GST amount charged in invoice is declared in its returns and payment of taxes is also made.
- (c) The Supplier/Service Provider agrees to comply with all applicable GST laws, including GST acts rules, regulations, procedures, circulars & instructions thereunder applicable in India from time to time and to ensure that such compliance is done within the time prescribed under such laws. Supplier/Service Provider should ensure accurate transaction details, as required by GST laws, are timely uploaded in GSTN. In case there is any mismatch between the details so uploaded in GSTN by Supplier/Service Provided and details available with Kolkata Port Trust, then payments to retained from due payments till such time Kolkata Port Trust is not sure that accurate tax amount is finally reflected in the GSTN to KoPT's Account and is finally available to Kolkata Port Trust in terms of GST laws and that the credit of GST so taken by Kolkata Port Trust is not required to be reversed at a later date along with applicable interest.
- (d) Kolkata Port Trust has the right to recover monetary loss including interest and penalty suffered by it due to any non-compliance of tax laws by the supplier/service provider. Any loss of input tax credit to Kolkata Port Trust for the fault of supplier shall be recovered by Kolkata Port Trust by way of adjustment in the consideration payable.
- (e) Supplementary invoices/Debit note/credit note for price revisions to enable Kolkata Port Trust to claim tax benefit on the same shall be issued by you for a particular year before September of the succeeding Financial Year.
- (f) The purchase order/work order shall be void, if at any point of time you are found to a black listed dealer as per GSTN rating system and further no payment shall be entertained.
- (g) All bidders to note for execution of work following steps are required to be taken so that KoPT can avail the Input Tax Credit, wherever applicable.
 - i. Spare parts which is to be procured from OEM/authorized dealers the contractor will ensure invoices are drawn in the name of the contractor however it should be marked account Kolkata Port Trust with ship name and address of the vessel as per applicable Acts & rules of GST. KoPT would provide GST registration number for availing Input tax credit.
 - ii. As far as possible all other materials to be procured from first/2nd stage dealer and maintained the above formalities to the extent possible so that KoPT can avail the Input tax Credit but it shall not be mandatory.
 - iii. The party should ensure that GST invoice raised on KoPT tallies with online data available for input tax credit & as per GST rules.

7.0 PRICING OF BID.

- 7.1 **General:** The Bid shall be quoted in and as per format of Price Bid.
- 7.2 **Currency of Quotations:** The bidder shall indicate the prices in Indian Rupees only. The bidder shall not quote in any other currency other than Indian Rupees.
- 7.3 **Validity of Price Bid:** The Part-II (Price Bid) shall be valid for acceptance for a minimum period of 180 (one hundred eighty) days from the date of opening of Part-I (Technical & Commercial aspects) of the Bid.

8.0 Interpretation of Terms

In the Contract and specifications the following words and expressions shall have the meanings as follows:

9.0 SPECIAL CONDITIONS OF CONTRACT

9.1 The Director, Marine Department from time to time may authorise any person or persons in writing, a copy of which is to be forwarded to the contractor, to be meant by him to exercise such powers, authorities and discretions on his

behalf under this contract as he may think fit and proper and the contractor shall recognise, honour and give effect to such authorities in all respect.

9.2 The buoys are to be manufactured under the supervision of IRS.

9.3 EXHIBITED DRAWINGS.

The contractors are required to carry out the jobs as per the drawings supplied to them by KoPT.

9.4 REJECTION AND REPLACEMENTS.

All materials and workmanship used and employed in carrying out the contract shall be to the entire satisfaction of the Director, Marine Department or his representative. Any portion or portions of the material for any of the work done under this contract which may be considered by the Director, Marine Department or his representative to be defective or unsatisfactory or not in accordance with the said specification and plan and the requirements of the buoys and which they shall reject shall be forthwith replaced / substituted and /or reconstructed with fresh materials as the case may be in a manner satisfactory to the Director, Marine Department or his representative and stated by Director, Marine Department or his representative in writing and at the sole risk and expense of the Contractor.

9.5 INSPECTION AND TESTING DURING PROGRESS OF WORK.

The work is to be executed under supervision of IRS Surveyor. Moreover, the authorised representative of the Trustees shall have the authority to inspect the work at any stage of progress. Trustees' representative will be present, if deemed necessary, during any tests, trials or inspection. The Contractor should give prior notice for such inspection. The Contractor shall afford the representative, all facilities for examining, inspecting and testing the materials and workmanship used or intended to be used or employed during the progress of the construction of buoy and on the completion thereof and shall also supply free of charge such apparatus, materials, tools or labour as may be required from time to time for the purpose of such examinations, inspections and testings.

9.6 TIME OF COMPLETION.

The construction of all the navigational buoys shall be completed to the entire satisfaction of the KoPT representatives within 11 months from the date of issue of the work order. The contractor is required to supply first two buoys within two months from the date of work order and thereafter two buoys every month.

9.7 DELIVERY AND TRIAL.

On satisfactory completion of construction as applicable, at the Builder's yard/workshop, the buoys are to be delivered to Kolkata Dock System as

directed by the Engineer or his representative, with all fittings and ready in all respects for use. The contractor is required to give 3 day's notice prior to delivery of each buoy.

9.8 GUARANTEE PERIOD.

In the event of any defect being discovered in any part of the buoy or the fittings thereto, caused by defective design, workmanship or materials or by non- execution of or incomplete and / or erroneous execution of any section of the work under this contract which is not attributable to reasonable wear and tear of the equipment during a period of 12 calendar months from the date of delivery of each buoy, the Contractors at their own cost shall rectify/ supply to Superintendent, Dredger & Despatch Service, Kolkata Port Trust at Kolkata Dock System, in the soonest time practicable, new parts to replace any that may be proved to have been so defective. The cost of removing any such defective parts and renewal of whole equipment of part of the buoy where applicable and such parts or fittings/replacement parts shall be borne by the contractor. Any delay in carrying out the repairs/replacements according to the opinion of the Superintendent, Dredger & Despatch Service would be compensated by the Contractor by extending their guarantee period. In the event of failure of the builders to execute the guarantee repairs to the satisfaction of the Superintendent, Dredger & Despatch Service in reasonable time, the Superintendent, Dredger & Despatch Service shall be at liberty to have the said guarantee repairs completed and recover the cost from any sum due to the Contractor or from the Security Deposit or in any other manner deemed appropriate by the Trustees.

9.9 DAMAGES FOR DELAY IN EXECUTION OF THE CONTRACT.

In the event of any buoy not being completed and delivered in accordance with time schedule as specified in the contract, the Engineer shall deduct liquidated damages as specified in the GCC.

9.10 TERMS OF PAYMENT:

Payment will be made within 30 days of submission of correct bills once in a month against the numbers of the buoys actually supplied and accepted by KoPT.

9.11 INTERPRETATION OF CONTRACT AND ARBITRATION.

This contract will be governed by Indian Law. In case of any dispute or differences arising in relation to the contract (before, during or after completion or abandonment of work or during the extended period thereafter), the same may be referred to the arbitration as per provision as laid down in Arbitration Conciliation Act, 1996.

9.12 TRUSTEES OR REPRESENTATIVES NOT TO BE PERSONALLY LIABLE.

Nothing in this contract shall be deemed to or shall impose any personal liability on any of the Trustees or their Representatives.

9.13 NOTICES.

Any notice or other document of any description under this contract may be given or sent to the Contractor by leaving the same or sending the same to them by post / fax at their works or last known place of business.

9.14 MODE OF REFUND OF SECURITY DEPOSIT.

- (i) The Security Deposit shall be refunded to the Contractor, after deduction of any sum due to the Trustees, on completion of guarantee period of 12 months.
- (ii) Security Deposit may be liable to forfeiture at the discretion of the Trustees, if the contractor fails to carry out the work or to perform / observe any of the conditions of the contract. The Trustees shall also be at liberty to deduct any of their dues from the Security Deposit or from any sum due or become due to the contractor under any other contract.

9.15 PRICE ESCALATION.

No escalation on the contract price will be allowed.

9.16 EVALUATION CRITERIA.

Evaluation will be made on the minimum rate quoted excluding GST for each buoy subject to the fulfilment of necessary tender conditions.

9.17 TERMINATION OF CONTRACT.

Without being liable for any compensation to the Contractor, the Trustees may in their absolute discretion, terminate the contract after giving him a minimum 7 (Seven) days' notice in writing, due to occurrence of any of the following reasons and decision of the Trustees in this respect, as communicated by the Engineer shall be final and conclusive.

- i) The Contractor has abandoned the contract.
- ii) In the opinion of the Engineer, either the progress of work is not satisfactory or the work is not likely to be completed within the agreed period on account of Contractor's lapses.
- iii) The Contractor has failed to commence the work or has without any lawful excuse under this conditions, has kept the work suspended for at least 15 days despite receiving the Engineer's or his representative's written notice to proceed with the work.
- iv) The Contractor is not executing the work in accordance with the contract or is persistently or flagrantly neglecting to carry out his obligations under the contract or repeatedly failing in tests and trials.
- v) Any bribe, commission, gift or advantage is given, promised or offered by or on behalf of the Contractor to any Officer, Servant or representatives of

- the Trustees' or to any person on his on their behalf in relation to the obtaining or to the execution of the contract.
- vi) The Contractor is adjudged insolvent or enters into composition with his creditors or been a company goes into liquidation either compulsorily or voluntarily.

10.0 TECHNICAL SPECIFICATION.

10.1 **Scope of work**:

The work under this contract consists of construction and delivery of twenty navigational buoys as per the drawings / plans. The specification of the buoys would be as follows:-

- a) Materials IS 2062 Grade Steel or equivalent steel having same physical properties and chemical composition as IS 2062 Grade-B.
- b) Construction All welded.
- c) Buoys Plate Thickness As per Drawing.
- d) Tower Construction As per Drawing.
- e) Day marks As per drawing of day marks (E'ly and W'ly).
- f) Deck fittings Lifting eyes and manholes / hatch cover as per Drawing.

NOTE: Mooring eyes is to be strong enough to withstand mooring loads and is to be welded to the hull. Kent ledges are to be fitted properly as shown in the Diagram. Manhole cover is to be tested for minimum 2 Kg / Cm² pressure.

10.2 Material and Workmanship:

The fabrication of the 'buoy' in its entirety along with all fittings etc. is to be carried out with best quality materials conforming to BIS/ISO and with highest degree of workmanship to the entire satisfaction of KoPT Representatives. The cost of all tests and analysis is to be borne by the contractor. The Trustees' representatives will have the full authority to adapt any means they think advisable to satisfy themselves as to the quality of the materials and methods of construction.

All steel material to be of I.S. 2062 Grade 'B' with proper test certificates. In the event there is no supporting test certificate, the contractor would be required to send random sample pieces to MMD / IRS authorised test houses for testing at the contractor's expenses.

10.3 Welding:

All welding work is to be carried out as per recommendations of IRS surveyor.

10.4 Rectification of defects:

The contractor shall be bound to rectify the defects in materials and workmanship detected at any stage of inspection and even after final inspection. Such rectification shall have to be done in a manner required by

KoPT Representatives at no extra cost to the Trustees. No extension of completion time will be granted on account of such rectification work.

10.5 Scantlings:

Scantling to be as per drawings.

10.6 Painting schedule:

All paints should conform to their latest respective Standard Specification and shall be obtained from reputed manufacturer e.g. Sigma, Jotun, International paint.

External Surface: All external plates to be blasted with copper slag cleaned thoroughly and all other steel surfaces to be chipped / scrapped / wire brushed wherever necessary to make the surface free from dust, grease etc. and should be dry at the time of painting. Blasting should be done to achieve SA 2.5. After the aforesaid surface preparation, buoys are to be painted externally, with airless spray under the supervision of paint manufacturer's authorised representative who is required to issue certificate accordingly, as mentioned hereunder:
