In case the firm is not covered under ESI Act, or exempted, they would furnish necessary documents along with an affidavit in original affirmed before a first Class Judicial Magistrate in a non judicial stamp paper worth Rs 10/- to that effect as per enclosed KoPT approved format In addition to that the bidder must indemnify KoPT against all damages and accident occurring to their labour in a non-judicial stamp paper worth Rs. 50/- as per enclosed format.

KoPT or an individual representing KoPT cannot be held responsible for loss or damage caused to the mechanised boat or loss of lives or injury to contractor's workmen engaged for the purpose of transporting Pilots while actually performing duties or otherwise. It is contractor's responsibility to have its boat and persons on board adequately indemnified by an insurance company of repute.

7.1.12 A declaration that the bidder has not been debarred/blacklisted by any Govt. /Semi Govt. /PSU Organisation.

7.1.13 Details of supervision and Liaison set up planned to be used for supervision and co-ordination of the work.

7.1.14 Photo copy of Pan Card and details of ECS like (i) Name of the Bank (ii) address (iii) Account No., IFS Code, RTGS No. etc. to be submitted.

7.1.15 Letter of authority, if any.

- 8.3 Kolkata Port Trust will not be responsible for any cost or expenses incurred by the bidder in connection with the preparation and submission of his / her bid or for any other expenses in connection with such bidding.

## 10. Duties and Taxes :

- 10.1 Suppliers / service provider to confirm that the GST amount charged in invoice is declared in the return and payment of taxes is also made.
- 10.2 The Supplier / Service Provider agrees to comply with all applicable GST laws, including GST acts, rules, regulations, procedures, circulars & instructions thereunder applicable in India from time to time and to ensure that such compliance is done within the time prescribed under such laws. Supplier / Service Provider should ensure accurate transaction details, as required by GST laws, are timely uploaded in GSTN. - 10.3 Kolkata Port Trust has the right to recover monetary loss including interest and penalty suffered by it due to any non-compliance of tax laws by the Supplier / Service Provider. Any loss of input tax credit to Kolkata Port Trust for the fault of suppliers shall be recovered by Kolkata Port Trust by way of adjustment in the consideration payable.
- 10.4 Supplementary invoices / Debit note / Credit note for price revisions to enable Kolkata Port Trust to claim tax benefit on the same shall be issued by you for a particular year before September of the succeeding Financial Year.
- 10.5 The purchase order / work order shall be void, if at any point of time you are found to be a black listed dealer as per GSTN rating system and further no payment shall be entertained.
- 10.6 Any new statutory levies, taxes, duties, cess etc. imposed by the Central / State / Local Authorities by way of fresh notification subsequent to the issue of purchase order, but within the stipulated delivery period, shall be recovered separately.

***N.B : The information being provided in the Tender document does not relieve the Bidders from carrying out the works to suit the specified needs. The Bidder shall inspect the site and may conduct trials at their own cost and risk and use any and every other method to ensure the adequacy of their offer.***

## **11. EARNEST MONEY DEPOSIT:**

- 11.1 An amount of Rs.10,000/- (Rupees ten thousand only) shall be submitted as Earnest Money Deposit by Demand Draft / Banker's Cheque / Pay Order, payable to "Kolkata Port Trust".

- 14.1 Wooden mechanized boat is to be stationed at Shore Based Pilot Station, Sagar Island and to be used for the transportation of pilots and other services of the Trustees and shall be available for use at any time of the day and night. Non-availability of the boat will adversely affect the shipping of Kolkata Port for which the contractor will be held responsible.
- 14.2 The mechanized boat must be appropriately registered and fit for the above operations.
- 14.3 The contractor shall supply appropriate/experienced crew for operation and maintenance of the mechanized boat. Minimum manning of three heads to be provided during any operation.
- 14.4 Supply of fuel, lubricants and all consumables shall be entirely the responsibility of the contractor and cost should be included in the price bid.
- 14.5 The mechanized boat shall be made available at the jetty complex of the Shore Based Pilot Station at Sagar and will work under the orders of Commander Pilot Station.
- 14.6 The mechanized boat should be capable of carrying 6 Pilots, with sitting arrangements. The draft of the boat shall be such that it can ply in shallow water.
- 14.7 The baggage of the Pilots has to be carried by the persons manning the boat.
- 14.8 At least one of the persons manning the mechanized boat should be available at all times at the jetty complex/ Pilot Station building complex for receiving orders for Pilot's boating schedules from Commander Pilot Station.
- 14.9 The daily log of usage will have to be maintained in duplicate by the contractor. As and when the boat is in use, the pilots/officers using the same shall sign the log indicating the period of usage. This log should be countersigned by the Commander at the Pilot Station.
- 14.10 Bill will be submitted once in a month duly certified by the Commander Sagar Pilot Station, for payment as per actual period of deployment of the boat, on monthly basis, to the Harbour Master (River) at his Kolkata Office. PAN and details of bank account number to be mentioned for ECS.
- 14.11 The mechanized boat shall be available at all times for use. In case of non-availability for any reason, whatsoever, the Contractor shall be liable to provide replacement of boat forthwith. However, if the Contractor fails to provide suitable boat to carry out the order, a penalty @ double the daily hire charge

- plus GST shall be deducted for each day from his bill, besides non-payment of the daily hire charge for the said period.
- 14.12 The successful bidder must submit a local police verification certificate for those persons who will be deployed for carrying out the duties.
- 14.13 The Contractor should comply with all the contract labour laws, as applicable.
- 14.14 There is no provision for payment of any escalation on the price under this contract.
- 14.15 The Contractor shall be deemed to have indemnified the Trustees against all claims, demands, actions and proceedings and all costs arising there from or account of failure on their part or non-supply of boat with requisite items on any day during contract period.
- 14.16 The information being provided in the Tender document does not relieve the successful bidder from carrying out the works to suit the specified needs. The bidder shall inspect the site and use any and every other methods to ensure adequacy of their offer.
- 14.17 No claim for interest shall be admissible to the contractor at any stage and in respect of any money or balance which may be due to the contractor from the Trustees, owing to dispute or otherwise or for any delay on the part of Trustees in making interim or final payment or otherwise.
- 14.18 Default of the Contractor: Without being liable for any compensation to the contractor the Trustees may in their absolute discretion, terminate the contract and expel the contractor there from after giving him a notice in writing due to occurrence of any of the following reasons as communicated by the Commander, Sagar Pilot Station shall be final and conclusive:
- (a) The Contractor has abandoned the contract.
  - (b) In the opinion of the Commander, Shore Based Station, either the work is not satisfactory or the work is not likely to be complied with in the agreed period of time on account of contractor's lapse.
  - (c) The contractor is not executing the work in accordance with the contract or is persistently or flagrantly neglecting to carry out his obligations under the contract.

- 14.21 The Trustees for the port of Kolkata do not bind themselves to accept the lowest or any offer/Tender or part thereof and reserve the right to accept or not to accept any or all of the tenders either in whole or in part without assigning any reason whatsoever.
- 14.22 The validity of the offer will be ninety days from the date of opening of the price bid.
- 14.23 All taxes and duties are to be included in the bills of quotation. KoPT is not liable to pay any tax or duty whatsoever.
- 14.24 As KoPT is not a Registered Body Corporate, it is not liable to pay service tax under “Reverse Charge Mechanism” as per Service Tax Law. The service provider is liable to recover service tax as applicable.

- 15.4 “THE ENGINEER” - The expression “The Engineer” means the Harbour Master (RIVER), for the purpose of this contract only.
- 15.5 “THE ENGINEER'S REPRESENTATIVE”: The expression “The Representative” means any officer or person from time to time deputed by the

Trustees or Harbour Master (RIVER) to act on their behalf for the purpose of this contract.

- 15.6 “DAY” - means duration of 24 hrs. commencing at 00.00 hours midnight till 2400 hours and includes Sundays and Holidays.
16. **Payment:** Payment shall be made to the contractor within 45 days of submission of relevant bills. Payment will be made only through ECS for which the Contractor must furnish the relevant bank details immediately after signing the contract.
17. **Termination of contract :** KoPT, at his sole discretion may terminate the contract after serving proper notice, if the performance of the contractor during the operation is not found satisfactory. The decision of KoPT about the performance will be final.
