The composite value of execution of providing Consultancy and PMC Services of one successfully completed assignment from each of the above categories [Clause 2 (a), (b) and (c)] for the aforesaid works during last 7 (seven) years ending last day of month previous to one in which applications are invited should not be less than Rs. 3.25 Cr. The bidder should submit the work completion certificates as proof. It is to be noted that only one successfully completed assignment shall be considered from each of the above categories [Clause 2 (a), (b) and (c)] to calculate the composite value amount.
- 4. The Bidder should have accreditation from Quality Council of India (QCI) / National Accreditation Board for Education and Training (NABET) for undertaking Environmental Impact Assessment and Environmental Management Plan Consultant for Category 'A' Projects.
