Tender under "One Cover Bid", comprising of two parts i.e. (i) Techno-Commercial Bid and (ii) Price Bid are invited from experienced, bonafide and competent owners/ suppliers/ firms for engagement of one Wooden Mechanised Boat for transportation of pilots and KoPT officials between Sagar Pilot Station and Pilot Launch for a period of six months from October 2019 to 31st March 2020.

2. Pre-Qualification Criteria.

- 2.1. The firm must have experience of having successfully completed *similar work during the last 7 years up to 31.6.2019 which should be in the following manner:
 - a) Three similar completed works, each costing not less than the amount equal to 40% of the estimated value i.e. Rs.2.04 lakhs

Or

- b) Two similar completed works, each costing not less than the amount equal to 50% of the estimated value i.e. Rs. 2.55 lakhs

 Or
- c) One similar completed work, costing not less than the amount equal to 80% of the estimated value i.e. Rs. 4.08 lakhs
- d) The average Annual Financial turnover of the intending bidder during the last 3 years should be at least 30% (Rs. 1.53 lakhs) of the estimated amount put to tender.
- e) Claims for fulfilling the above criteria must be adequately supported by appropriate documents like work order, performance certificate from Clients, Company's Annual Reports, Audited Balance Sheet and Profit and loss account for last 3 Years (i.e. 2016-17, 2017-18 & 2018-19), Master Roll, Current P.F. statement, E.S.I. Registration or documents specified here in. The firm should also submit documents/statements in support of compliance of Minimum Wages Act.
 - * The similar work shall include supply of boats/launches with manning for transportation in waterway. Work experience, as a subcontractor shall not be considered as the requisite qualification.

3. OTHER INSTRUCTIONS

- 3.1 Online application should be uploaded within the specified date and time of submission after which no application will be accepted. Kolkata Port Trust will not be responsible in any way for any delay.
- 3.2 Mere issuance of tender documents will not mean that a particular Bidder will be automatically considered qualified and their bid will be entertained. Such qualification will be reviewed at the time of evaluation of bids.
- 3.3 In case there is an unscheduled Holiday / Bandh / Strike on prescribed last date of submission, the next working date will be treated as the scheduled prescribed day for the same.
- 3.4 The **KoPT** tender paper be downloaded from website can and Central Public Procurement Portal www.kolkataporttrust.gov.in http.//eprocure.gov.in . - 3.5 While evaluating tenders, regard would be paid to National Defence and Security consideration.

4. MODE OF SUBMISSION OF BID

The tenders are to be submitted under one cover comprising with two following parts:-

Part-I should constitute the Technical Bid and terms and conditions of offer and **Part-II** should constitute only the Price Bid without any deviation and condition.

4.1 Part-I (Techno-Commercial) will contain the following documents:-

- 4.1.4 Performance Certificate of similar previous works carried out.
- 4.1.5 The bidder should furnish the details of ESI Registration. In case the firm is not covered under ESI Act, or exempted, they would furnish necessary documents along with an affidavit in original affirmed before a first Class Judicial Magistrate in a non judicial stamp paper worth Rs 10/- to that effect as per enclosed KoPT approved format In addition to that the bidder must indemnify KoPT against all damages and accident occurring to their labour in a non-judicial stamp paper worth Rs. 50/- as per enclosed format.
- 4.1.6 Original Bank Draft/Banker's Cheque/ Pay Order payable to "Kolkata Port Trust" for Earnest Money deposit of Rs. 10,200/- and Cost of tender document of Rs.590/- in a separate cover super scribed as "Earnest Money Deposit & Cost of Tender Document".
- 4.1.7 Tender document duly stamped and signed on each page.
- 4.1.8 The particulars of the boats that the bidder intend to utilize for this purpose along with the relevant certificate from the appropriate authority.
- 4.1.9 A separate letter addressing to Harbour Master (River), confirming that the bidder has accepted all terms and conditions laid down in the Bid document should be enclosed.
- 4.1.10 A declaration that the Mechanised Wooden Boat is free from all encumbrances and lien.

- 4.1.11 The Bidder must indemnify KoPT against all damages and accidents in a non-judicial stamp paper worth Rs.50/- as per enclosed format (Annexure- H). KoPT or an individual representing KoPT cannot be held responsible for loss or damage caused to the mechanised boat or loss of lives or injury to contractor's workmen engaged for the purpose of transporting Pilots while actually performing duties or otherwise. It is contractor's responsibility to have its boat and persons on board adequately indemnified by an insurance company of repute.
- 4.1.12 A declaration that the bidder has not been debarred/blacklisted by any Govt. /Semi Govt. /PSU Organisation.
- 4.1.13 Details of supervision and Liaison set up planned to be used for supervision and co-ordination of the work.
- 4.1.14 Photo copy of Pan Card and details of ECS like (i) Name of the Bank (ii) address (iii) Account No., IFS Code, RTGS No. etc. to be submitted.
- 4.1.15 Letter of authority, if any.
- 4.1.16 Filled up "Form of Tender" as per enclosed proforma.
- 4.1.17 Any additional information /deviation furnished by the Bidder.

5.1 Bidders are advised to submit quotation based upon Technical specification, terms and conditions, Scope of Work contained in the Bid documents and General

- 5.2 Tenders not accompanied with EMD in Original Bank Draft / Bankers Cheque / Pay order are liable for rejection.
- 5.3 Kolkata Port Trust will not be responsible for any cost or expenses incurred by the bidder in connection with the preparation and submission of his / her bid or for any other expenses in connection with such bidding.
- 5.4 The work is to be done as described in Bid-document. The bidder who needs clarification on any specific issue shall inform the Engineer of the contract in writing well in advance of the date of pre-bid discussion at the address given in the next clause.

- 5.6 The bidders may please note that the Kolkata Port Trust will not entertain any correspondence or queries on the status of the offers received against this Bid. Bidders are also requested not to depute any of their personnel or agents to visit the Kolkata Port Trust's offices for making such inquiries. Should Kolkata Port Trust find it necessary to seek any clarification, technical or otherwise, the concerned bidder will be duly contacted by Kolkata Port Trust.
- 5.7 Canvassing in any form by the bidder or by any other agency acting on behalf of the Bidder after submission of the bid will disqualify the said bidders. Kolkata Port Trust may reject, accept or defer any bid without assigning any reason whatsoever.

- 5.8 **Signing of the Contract :** On placement of work order to the successful bidder, the bidder shall arrange for mobilisation of his men and equipments on immediate basis. The successful bidder will have to make arrangements for signing a formal agreement with Kolkata Port Trust on a non-judicial Stamp paper of Rs. 50/- as per enclosed format (Annexture F) within seven days on placement of work order.
- 5.9 The General Conditions of Contract of KoPT shall be applicable wherever relevant.

7. **Duties and Taxes**:

- 7.1 Suppliers / service provider to confirm that the GST amount charged in invoice is declared in the return and payment of taxes is also made.
- 7.2 The Supplier / Service Provider agrees to comply with all applicable GST laws, including GST acts, rules, regulations, procedures, circulars & instructions thereunder applicable in India from time to time and to ensure that such compliance is done within the time prescribed under such laws. Supplier / Service Provider should ensure accurate transaction details, as required by GST laws, are timely uploaded in GSTN. In case there is any mismatch between the details so uploaded in GSTN by Supplier / Service Provider and details available with Kolkata Port Trust, then payments to Supplier / Service Provider to the extent of GST relating to the invoices/s under mismatch may be retained from due payments till such time Kolkata Port Trust is not sure that accurate tax amount is

finally reflected in the GSTN to KoPT's Account and is finally available to Kolkata Port Trust in terms of GST laws and that the credit of GST so taken by Kolkata Port Trust is not required to be reversed at a later date along with applicable interest.

- 7.3 Kolkata Port Trust has the right to recover monetary loss including interest and penalty suffered by it due to any non-compliance of tax laws by the Supplier / Service Provider. Any loss of input tax credit to Kolkata Port Trust for the fault of suppliers shall be recovered by Kolkata Port Trust by way of adjustment in the consideration payable.
- 7.4 Supplementary invoices / Debit note / Credit note for price revisions to enable Kolkata Port Trust to claim tax benefit on the same shall be issued by you for a particular year before September of the succeeding Financial Year.
- 7.5 The purchase order / work order shall be void, if at any point of time you are found be to a black listed dealer as per GSTN rating system and further no payment shall be entertained.
- 7.6 Any new statutory levis, taxes, duties, cess etc. imposed by the Central / State / Local Authorities by way of fresh notification subsequent to the issue of purchaser order, but within the stipulated delivery period, shall be recovered separately.
- N.B: The information being provided in the Tender document does not relieve the Bidders from carrying out the works to suit the specified needs. The Bidder shall inspect the site and may conduct trials at their own cost and risk and use any and every other method to ensure the adequacy of their offer.

8. EARNEST MONEY DEPOSIT:

- 8.1 An amount of Rs.10,200/- shall be submitted as Earnest Money Deposit by Demand Draft / Banker's Cheque / Pay Order, payable to "Kolkata Port Trust".
- 8.2 Earnest money will be accepted only by Demand Draft / Banker's Cheque / Pay Order. Earnest Money of all bidders will be kept in safe custody. Only Earnest Money of L-1 bidder will be en-cashed and Earnest Money instruments of other bidders will be returned after opening of price bids without any interest.
- 8.3 Earnest Money Deposit of successful bidder will be returned without any interest after submission of Security Deposit. - Wooden mechanized boat is to be stationed at Shore Based Pilot Station, Sagar Island and to be used for the transportation of pilots and other services of the Trustees and shall be available for use at any time of the day and night. Non-availability of the boat will adversely affect the shipping of Kolkata Port for which the contractor will be held responsible.
- The mechanized boat must be appropriately registered and fit for the above operations.
- 11.3 The contractor shall supply appropriate/experienced crew for operation and maintenance of the mechanized boat. Minimum manning of three heads to be provided during any operation.
- Supply of fuel, lubricants and all consumables shall be entirely the responsibility of the contractor and cost should be included in the price bid.
- The mechanized boat shall be made available at the jetty complex of the Shore Based Pilot Station at Sagar and will work under the orders of Commander Pilot Station.

- 11.9 The daily log of usage will have to be maintained in duplicate by the contractor. As and when the boat is in use, the pilots/officers using the same shall sign the log indicating the period of usage. This log should be countersigned by the Commander at the Pilot Station.
- 11.10 Bill will be submitted once in a month duly certified by the Commander Sagar Pilot Station, for payment as per actual period of deployment of the boat, on monthly basis, to the Harbour Master (River) at his Kolkata Office. PAN and details of bank account number to be mentioned for ECS.

- 12.4 "THE ENGINEER" The expression "The Engineer "means the Harbour Master (RIVER), for the purpose of this contract only.
- 12.5 "THE ENGINEER'S REPRESENTATIVE": The expression "The Representative" means any officer or person from time to time deputed by the

- Trustees or Harbour Master (RIVER) to act on their behalf for the purpose of this contract
- 12.6 "DAY" means duration of 24 hrs. commencing at 00.00 hours midnight till 2400 hours and includes Sundays and Holidays.
- 13. **Payment:** Payment shall be made to the contractor within 45 days of submission of relevant bills. Payment will be made only through ECS for which the Contractor must furnish the relevant bank details immediately after signing the contract.
- 14. **Termination of contract :** KoPT, at his sole discretion may terminate the contract after serving proper notice, if the performance of the contractor during the operation is not found satisfactory. The decision of KoPT about the performance will be final.
