- 2.0 PLACE OF DELIVERY :-  
Materials shall be delivered by the successful Bidder upto HDC's Central Store, M.M. Divn. of Haldia Dock Complex at Chiranjibpur, Haldia at their own cost, risk and responsibility.
- 3.0 TIME OF COMPLETION OF DELIVERY :-  
Ex stock or latest within 8/10 weeks from the date of receipt of order.
- 4.0 T A X :-  
Bidder(s) should quote their rates clearly indicating percentage (%) details of GST and other Statutory levies as applicable, in their offer.
- 5.0 PAYMENT :-  
Payment would be kept ready in advance against Proforma Invoice to be submitted by the successful Bidder(s) after placement of order. The same would be handed over after satisfactory receipt of the materials at store.

Every tyre supplied by the contractor bearing its name shall be guaranteed to be free from any defect in respect of substandard materials, poor workmanship or faulty design (Normal wear & tear excluded) without limit as to time or mileage. In case of any tyre is found to be defective, it will be intimated immediately to the contractor to arrange for inspection. If after examination, it is found that any article is defective then contractor shall give rebate based on the estimated balance life of the tyre as per formula given below.

$$\text{Compensation} = \frac{B \times C}{A}$$

Where A: Original tread depth of the tyre

B: Remaining tread depth when the tyre fails

C: Cost of tyre per piece

- 7.0 CERTIFICATES :-  
The successful Bidder should submit Warranty Certificate of Manufacturer / Authorized dealer (as applicable) along with supplies.
- 8.0 VALIDITY :-  
The offer shall remain valid upto 90 days from the date of tender opening.
- 9.0 INSPECTION :-  
Inspection of materials will be carried out by authorized representative of P&E division, HDC at Central Garage on the basis of manufacturer's / authorized dealer's Warranty Certificate (as applicable) after the delivery of the materials.
