5. RIGHT TO ACCEPT ANY TENDER AND TO REJECT ANY PART OR ALL TENDERS

Kolkata Port Trust reserves the right to accept or reject any, part or all tenders and the tendering process what so ever at any time prior to award of the contract, without thereby incurring any liability to the affected tenderers or any obligation to inform the affected tenderers the ground for the rejection what so ever.

6. OBLIGATION OF TENDERER

The Tenderer shall distinctly understand:

(a) That they will be strictly required to conform to the GCC & SCC as contained in each of its clauses & the plea of customs prevailing will not in any case be admitted as an excuse on their part for infringing of any of the conditions.

(b) That they shall refrain from sending revised or amended quotations after the closing date & time of the Tender unless asked for.

(c) That acceptance or non acceptance of any of the terms & conditions, stated herein, shall have to be clearly mentioned in the pre-bid meeting. Non acceptance and / or non-compliance of any of the terms & conditions, after those are frozen in the pre-bid meeting shall make such Tenders liable for outright rejection.

7. PRICE ESCALATION.

No escalation on the contract price will be allowed.

8. EVALUATION

Evaluation will be made on the basis of Price of the equipment as specified and the cost of CAMC for 4 years after completion of 1 year free warranty period. The rate should be quoted all inclusive.

9. TIME FOR COMPLETION

Time being taken for supply, delivery, testing and commissioning of the equipment shall be completed in all respect within 30 days from the date of award of contract/work order. Alternatively, specified LD clause for delay in executing the work as per the tender condition shall apply.

Prompt attendance for rectification of the equipment, including spares, consumables replacement as required under the CAMC should be done within 3 days from reporting of the fault.

10. CONDITIONS OF CAMC

CAMC includes supply of all spares, accessories, replacement, travel, transport, accommodation etc of the agency, in totality as per requirement during 4 years after 1 year free warranty period.

The CAMC should be provided for the supplied equipment in totality including supply consumables/spares/replacement/up gradation complying the following:

(a) Maintenance of the equipment in totality for its operation during the guarenteed operational life(1year free warranty plus CAMC for 4 years)

- (b) Guaranteed availability of technical support
- (c) Repair with supply of spare parts and consumables and replacement, if required
- (d) Prompt maintenance viz for attending and rectifying the equipment within 3(three) working days from the reporting of the fault.

11. PAYMENT

The 90% of the payment for the delivery and installation will be paid after satisfactory testing and commissioning of the WiFi AIS Pilot Plugs, on submission of bill in quadruplicate, and remaining 10 % of the bill will be retained as security deposit (the EMD will be considered as a part of this security deposit) and will be paid after satisfactory completion of the contract period i.e. (warranty period of one year and CAMC of four years).

The CAMC payment will be made after expiry of every 6 months of satisfactory performance of the equipment on submission of the bill in quadruplicate, after successful completion of one year free warranty period.

12. PENALTY

Imposition of penalty will be made if the fault is not rectified within 3(three) working days from the reporting of the fault, @ ½% of the total value of CAMC for the year for every day or part thereof, subject to a maximum of 10% of total value of CAMC for the year for each non – restoration of the fault.

13. FOR DELAYED SCHEDULE OF COMPLETION

Failure to complete the work in totality within the stipulated period will attract relevant provisions of liquidated damage clause for delay in supply, delivery, testing and commissioning as laid down in the tender document. In case the work is not completed within the stipulated period, liquidated damage @ $\frac{1}{2}$ % of the value of the contact price per week or part thereof, subject to a maximum of 10% of the contract price will be deducted from the subsequent bills/payments due to the bidder.

14. PERIOD OF VALITITY OF OFFER

Tender shall remain valid for 180 days from the date of opening of price bid. Harbour Master (River) may ask the tenderers to extend the validity of their offer if situation demands so subsequently. A tenderer may refuse the request without forfeiting their earnest money deposit but the tenderer's offer will not be considered. A Declaration should be given by the tenderer as per the format given in Annexure – E.

15. INDEMNITY

The Contractor shall indemnify the KoPT during the various stages of execution of the contract, regarding damages, loss of, or injury to, death of –

- (a) Third Parties
- (b) Contractor's facilities and equipment
- (c) Contractor's personnel (including its Sub-Contractors)
- (d) KoPT's facilities and equipment, including the goods supplied under this contract
- (e) The Contractor shall arrange Insurance cover:
 - i. On personnel workmen's compensation/employer's liability
 - ii. General third party liability.

The KoPT shall not be liable for any claims for damage to property, injury or death of personnel of the Contractor including Workmen, etc.

16. AMENDMENT OF TENDER DOCUMENTS

At any time prior to the deadline for submission of tenders, the Harbour Master (River) may for any reason, whether at his own initiative, or in response to a clarification required by a prospective Tenderer, modify the Tender Documents. The amendment shall be part of the Tender Documents

17. FORFEITURE OF EARNEST MONEY DEPOSIT.

The Earnest Money Deposited shall be forfeited:

(a) If the tenderer withdraws the offer during the period of tender validity specified by the tenderer.

- (b) In the case of a successful tenderer, if the Contractor fails
 - i. to sign the agreement in accordance with tender condition

Or

ii. to furnish the Performance Security Deposit in accordance with tender condition.

Performance certificate of the tenderers in respect of similar works/supply, if any, undertaken at Kolkata Port Trust/ any Port/ (as applicable) or any Govt./ reputed private sector/ public sector organisation during last 2 years. ('Delivery/completion of schedule and 'Quality of work') should be submitted.

Tenderer must submit duly-signed & stamped separate sheet(s) confirming their point-wise unqualified acceptance of all the technical & commercial terms of the tender.

Tenderer must submit the copy of the documents of credential for pre qualification (as per the eligibility criteria of the tender) with the techno commercial bid. The bidder will be required to give **demonstration** of the equipment offered by them at their risk, responsibilities and cost, in the Hooghly River/Dock working environment. KoPT will only endeavour to arrange a suitable vessel as the case may be on a pre-fixed date. No extension/deferment of the date will be entertained. If the performance of the equipment is not satisfactory and found not to comply with the tender specifications and KoPT's requirement, the bid will be rejected. 18. DELAYS IN THE CONTRACTOR'S PERFORMANCE

If the specified delivery schedule is not adhered to or if the items and the services are not satisfactory or are not in accordance with the schedule, the KoPT has right to cancel the order in whole or in part without liability for cancellation charges. In that event KoPT may procure from elsewhere equipments and services which in KoPT's opinion would most meet the same purpose as the equipment for which purchase orders is cancelled and Contractor shall be liable without limitation for the difference between the cost of such substitution and the price set forth in the order for the equipments and services involved

Any delay by the Contractor shall render the Contractor liable, without prejudice to any other terms of order if any, to any or all of the following sanctions, forfeiture of order performance, guarantee, imposition of price reduction for delay in delivery and a termination of the order for default.

19. TERMINATION FOR DEFAULT

The KoPT may, without prejudice to any other remedy for breach of contract, by written notice of default sent to the Contractor terminate the contract in whole or in part –

(a) If the Contractor fails to deliver any or all of the services and equipments within the time period specified in the contract, or any extensions thereof granted by the KoPT

Or

(b) If the Contractor fails to perform any other obligation (s) under the contract and if the Contractor, in either of the above circumstances does not cure its failure within a period as stipulated in the tender (or such longer period as the KoPT may authorize in writing) after receipt of notice of default from the KoPT specifying the nature of the default(s).

In the event of the KoPT terminating the contract in whole or in part, the KoPT may procure or obtain, upon such terms and in such manner as it deems appropriate, services and equipments similar to those undelivered, and the Contractor shall be liable to the KoPT for any excess costs for such similar services and goods. Notwithstanding the above, the Contractor shall continue performance of the contract to the extent not terminated.

20. The General Condition of Contract (GCC) which is available in the KoPT Website for download will form an integral part of the tender document. Wherin -

(a) 'Engineer' means and includes the Harbour Master (River) of the Kolkata Port Trust.

(b) Engineer's representatives' means any person or persons to whom the Harbour Master (River) may delegate his authority in writing.

21. SPECIAL CONDITIONS OF CONTRACT
