

THE CONDITIONS FOR ALLOTMENT OF QUARTERS AT TARATALA LABOUR COLONY:-

1. It has since been decided by the competent authority that the quarters of Kolkata Port Trust at Taratala Complex may be allotted to **Central Government Departments, Central Public Sector Undertakings, Nationalized Banks and Government owned Insurance Companies** on license basis for residential purposes under certain conditions
2. The rate of license fee per units of quarters would be calculated on the highest scale of pay of Class-IV employees [Rs 4,800- Rs 7,330] at the rate of 30% of basic including 50% D A merger plus license fee at the rate of Rs 153.00 per month as per F.R 45(A). Further, in consonance with the latest Land Policy Guidelines issued by the Ministry, an annual escalation at the rate of 2% of monthly fee may be imposed. The proposed License fee at present comes to Rs 3,420.50. The quarters /flats will be allotted on license basis fro a period up to 11 months. However on expiry of the said period, KoPT would reserve the right to issue a fresh license for a further period, as would be mutually agreed upon by the parties.
