
### Trade Circular

Haldia Dock Complex, Kolkata Port Trust vide Trade Circular No. MTO/G/115i/Pt.IV/791 dated 31.03.15 have communicated all concerned granting of handling agency license to 8 firms for rendering shore handling services in respect of dry bulk cargo (except at berth 4A and 12 or any other berths as may be decided by HDC subsequently). The said Trade Circular also mentioned the scope of work of the handling agents so engaged including the ceiling rates applicable for rendering the different shore handling services etc.

2. All concerned may kindly note the following in the matter in addition to what have been mentioned at Trade Circular No. MTO/G/115i/Pt.IV/791 dated 31.03.15:-

- (i) Services like supply of Payloaders, savior nets, grabs, supply of additional labours on-board the vessels are part of on-board services to be done either by the importers / exporters or steamer agents. Those services do not fall under the category of shore handling work in terms of Section-42(1)(b) of the MPT Act and as such are outside the purview of the shore handling work and Trade Notice No. MTO/G/115i/Pt.IV/791 dated 31.03.15.
- (ii) Some other services like photography, dealing railway indents, water sprinkling, etc. are neither under shore handling services nor on-board services which are done as per specific requirement of individual importer / exporter from the overall view of yard management and for fulfilling other requirements of exporters / importers and as such these are outside the purview of the shore handling work and Trade Notice No. MTO/G/115i/Pt.IV/791 dated 31.03.15.

3. The services mentioned at para-2(i) and 2(ii) above may be made by the exporters / importers by separate means as and when required at their individual cost and arrangements from any authorized service providers of HDC, KoPT till such time HDC, KoPT makes arrangements for any of such services.
