CIRCULAR


With a view to eradicate congestion of cargo carrying vehicles outside Empty Gate, it has been decided by the appropriate authority that with effect from September 01, 2016, permit generation counters located at Empty Gate will be shifted to the permit office located at Truck Parking Terminus at City Centre.

In order to maintain smooth flow of traffic, the following arrangement of vehicular movement from Ranichak crossing towards dock shall remain in effect –

- Permits for all import and export cargo/ container carrying vehicles/ equipment destined to enter dock premises and the associated manpower (excluding the cargo/ container carrying vehicles/ equipment operating on Annual permits) will be issued from the permit office located at Truck Parking Terminus at City Centre.
- Parking will not be allowed from Ranichak crossing to General Cargo Berth Empty Gate under any circumstances.
- Police authority/ Port Security/ CISF Personnel will remain posted at Ranichak crossing for controlling entry of vehicles proceeding towards dock.
- It will be the onus of the concerned Clearing & Forwarding Agents to ensure that all the necessary documents for a cargo/ container carrying vehicles/ equipment are ready in all respect before issuing permits to the vehicle/ equipment. Before the vehicle/ equipment leaves the Truck Parking Terminus, the concerned Clearing & Forwarding Agents shall also ensure that all the necessary formalities for entering into dock is complied with so that vehicle/ equipment may enter dock premises without getting detained. Any failure in compliance with the same will be viewed very seriously by port authority.

- Cargo/ container carrying vehicles/ equipment and the associated manpower on account of local industries, however, may approach the permit generation counters at Finger Jetty Gate for obtaining dock permit.
- The above modalities will be monitored on day-to-day basis and if required the same may be amended for interest of the trade.

All concerned are requested to strictly adhere to the above guidelines.
