Trade Circular

Sub: Invitation for application for allotment of Bare land inside DIZ.

Off late, Importers, importing large volume of dry bulk cargo through Haldia Dock, are showing interest to get Bare Lands inside the Dock Interior Zone on long term license basis as it will be beneficial for them to manage their import cargo in a better way. They have proposed that on allotment of plots on long term license basis they will be able to mobilize more cargo through this port.

Accordingly, the competent authority of KoPT/HDC have decided to allot plots on long term license basis to applicants for a period of 11 months, subject to the terms & conditions stated below;

1. The plot will be an undeveloped bareland plot inside the Dock Interior Zone. The plot will have to be developed to make it suitable for storing cargo, at the own cost and responsibility of the licensee within the license period.
2. They are required to commit mobilization of a minimum volume of 5 lakh MT (MGT) during the 11 months License period through import / export or in combination of both through this plot. In case the allotment is done for a period of 6 months, the MGT would be 2 lakhs MT. The above MGT shall be backed by commensurate Bank Guarantee to be calculated on the applicable Wharfage and On board charges applicable for foreign Coal cargo as per the prevailing Scale of Rates, along with applicable rate of GST. In case of failure to mobilise the MGT Quantity, during the period of license, the applicable port charges towards Wharfage and On board handling charges for foreign Coal along with applicable rate of GST, pertaining to the shortfall quantity would be encashed from the Bank Guarantee. How ever, the licensee may opt for making such payment separately and in such cases the Bank Guarantee may not be encashed.
3. Application for allotment the plot must be done by the intending Importers/Exporters within **16:00 hrs on 12.11.2018** clearly indicating the area required for allotment, at the Office of Sr. Deputy Manager (Sh & CH), Operational Building, Chiranjibpur, Haldia Dock Complex, Haldia.
