Trade Circular

Sub. : **Continuation of the Scheme for granting rebate for Vessel as well as Cargo Related Charges for handling Dry Bulk Cargo at HDC.**

This has reference to Trade Circulars No. GM(T)/15/GMT-859 dated 25.10.2019 and No. TO(Sh&CH)/10/ 1116 dated 07.05.2020 wherein various rebates for vessel as well as cargo related charges for foreign dry bulk cargo were introduced on & from 01.11.2019 and were subsequently extended up to 30.09.2020 or implementation of new SOR, whichever is earlier.

Earlier, for the period from 01.11.2019 to 31.03.2020, vessels which were carrying at least 80% of her DWT were considered as fully laden vessels. Since Sandheads operations are now suspended and vessels carrying cargo at least 80% of her DWT are unable to call KoPT, it has been decided by the appropriate authority that vessels arriving straight to KoPT from load port without lightening at any other port will be considered as fully laden vessels for a period of 6 (six) months w.e.f. 01.04.2020 or implementation of new SOR, whichever is earlier,

All concerned are requested to be guided accordingly.
