TRADE CIRCULAR

Sub: Manual unloading/loading of Iron Ore from/on vehicles at Mechanical Plot of HDC, SMPK

I have been directed to inform that henceforth manual unloading of Iron Ore Fines and Pellets at Mechanical plot as well as loading of Iron Ore Fines and Pellets from Mechanical plot onto vehicles for shifting out of Mechanical plot for loading on vessels at MHC/Manual Berths shall not be allowed unless specifically approved by General Manager (Traffic) / Sr. Dy. Manager (Sh&CH) considering any unavoidable circumstances.

If approved, such manual operation of Iron Ore Fines and Pellets at the Mechanical plot to be undertaken with prior intimation to M/s Lokenath Construction Pvt. Ltd. (the authorized Contractor of HDC, SMPK at Berth No. 3) by the concerned Exporter by submitting a copy of the approval letter. The authorized representative of M/s Lokenath Construction Pvt. Ltd., the Exporter, concerned C&F Agent and concerned Shore Handling Agent shall also be present during the manual operation. Utmost care to be taken by the Exporter and concerned Shore Handling Agent for safety of the mechanical plant during the manual operation.

All concerned are requested to be guided accordingly.
