

It has been directed to inform that all employees/workmen working under firms/agencies holding valid License of Syama Prasad Mookerjee Port, Kolkata, in the capacity of Stevedoring and Shore Handling Agencies, C&F Agencies, Steamer Agencies, Ship Chandling firms, Ship Surveyors, Ship Repairing firms, are required to mandatorily submit Antecedent Certificates prior to endorsing Quarterly, Annual and Biennial Permit at the office of Sr. Deputy Manager (Sh&CH), Operational Building, Chiranjibpur, Haldia within 20.05.2024 failing which, Permit Renewal may be kept on hold till such time the Antecedent Certificate is submitted.
