CIRCULAR

Sub:- Removal of import containers from NSD to KPD for de-congesting the dock- reg.

Due to very less number of delivery of import containers during the COVID-19 Lockdown period, the import pendency inside NSD container yard has increased substantially. Because of this, ship operation is getting badly affected and at times the operation is stopped for want of storage space. In order to mitigate the crisis, Port has decided to shift import load containers from vessels working at NSD as well as some import load containers stored at NSD to KPD-I, where storage space for about 400 containers is now available. In order to facilitate this operation, Port has appointed a transporter on short term basis, at a charge through emergency limited tender. Following is the charges fixed for the operation.

The above rates are valid from 08.05.2020 and the shifting operation will commence immediately. Customer's whose containers are shifted to KPD-I are requested to pay the above shifting charges to the contractor at the time of taking delivery of the container. Rail bound containers and CFS nominated containers will not to be shifted to KPD-I due to operational constraints. However it is the responsibility of the Shipping line to declare before vessel arrival regarding the complete list of rail import boxes and complete list of CFS nominated import boxes.

All trade partners are requested to take note of the new arrangement inform your clients accordingly. The above arrangement will be in force during the Lock-down period plus 2 more months.
