Trade Circular

Sub : Operation of In-motion Rail Weigh bridge at KoPT (KDS).

Installation of the aforesaid Weigh bridge is now complete and its operation will commence with immediate effect. The following outward rail-borne traffic shall be weighed prior to dispatch from KDS :

- i) All bulk consignment (like coal, limestone etc).
- ii) Container traffic with loaded containers (excluding Nepal container & rakes loaded from CTKR, & export rakes)

2. The following traffic shall be exempted from weighment :


- i) Bagged consignment (like fertilizer, foodgrain etc.).
- ii) Containers destined for Nepal loaded on CONCOR rakes.
- iii) Empty containers.
- iv) HR Coil and other steel consignments which have been pre-weighed on certified mill- scales prior to getting loaded and bearing marking of Central Excise and / or Customs Department.

3. The following Port charges shall be levied for weighment purpose.

- i) Weighment charge including issuance of weighment certificate : Rs.5.67 Per ton subject to a minimum of Rs. 104.26 for empty wagon and Rs. 208.52 for a loaded wagon.
- ii) Hire of Locomotive for haulage of wagon to the weighbridge for weighment / re-weighment : Rs. 6255.60 per hour or part thereof subject a minimum of Rs. 12511.20.

4. In case of excess weight being found in wagon (s), the same will be adjusted at a convenient rail linked point inside KDS. Punitive charges for load adjustment / re-weighment including detention charges shall be levied at the rates as notified by Railway Board from time-to-time.

5. This issues with the approval of the Competent Authority.
