## TRADE CIRCULAR

Sub: Standard Operating procedure (SOP) for Pre-Gate facility for road bound containers at M&Q Block, Sonai - Allowing entry of export containers ex-CFSs / ICDs directly inside Dock without routing through Pre-Gate facility

The Standard Operating Procedure (SOP) for Pre-Gate facility for road bound containers at M&Q Block, Sonai was issued vide Traffic Manager, SMPK Trade Circular No. Tfc/GZZY-241/SOP/Pre Gate dated 04.02.2022. In connection with the same a notification was issued by Customs vide Public Notice No.68/2021 dated 10.01.2022, followed by their addendum dated 24.02.2022 to the same.

The Pre-Gate facility at M&Q Block, Sonai commenced w.e.f. 01.03.2022.

Due to the addendum dated 30.03.2022 to the SOP of Customs dated 10.01.2022, issued against the Public Notice No. 68/2021, the SOP dated 04.02.2022 of SMPK stands partially modified as, ""all the export load containers which have been stuffed and sealed at CFSs / ICDs and for which LEO has also been obtained, may be allowed to enter NS Docks directly without routing through the Pre-Gate facility.""

In other words, the containers stuffed & sealed at CFSs / ICDs and for which LEOs have been obtained shall fall in the exempted category and would not be required to be routed through Pre-Gate facility.

This exemption shall come into effect from 01.04.2022. The addendum dated 30.03.2022 to the SOP of Customs dated 10.01.2022 to the Public Notice No. 68/2021 in this regard is attached.

## Addendum to the Standard Operating Procedure (SOP) dated 10.01.2022 to the Public Notice No. 68/2021.

Subject:-` Standard Operating Procedure' to be followed at Pre- Gate Facility, Netaji Subhas Docks, Kolkata—reg.

Attention of Exporters, Importers, General Trade, Port Terminal Operators, Shipping Lines/ Shipping Agents, CFSs coming under the Jurisdiction of Custom House, Kolkata and all other stake holders is invited to the Public Notice No. 68/2021 dated 16.09.2021 issued by Port Commissionerate regarding the functioning of the pre-gate facility at M & Q Block, Sonai, and the SOP to the Public Notice No. 68/2021 issued on 10.01.2022 and subsequent addendum dated 24.02.2022 to the SOP.

Now, the partial modification in the SOP dated 10.01.2022 to the P.N. 68/2021 is made as follows:

"All the Export Load Containers which have been stuffed & sealed at CFSs/ICDs and for which LEO has also been obtained, may be allowed to enter N.S. Docks directly without routing through Pre-Gate facility".

This addendum to the Standard Operating Procedure (SOP) dated 10.01.2022 of the Public Notice No. 68/2021 shall come into force with immediate effect.

This issues with the approval of the Principal Commissioner of Customs (Port), Custom House, Kolkata.
