His Lordship Hon'ble Justice Debangsu Basak of the High Court at Calcutta, vide his judgement dated 20.12.2016, inter alia, ordered that the appropriate authority, in seisin of deciding the pay fixation, will issue notices of hearing to the writ petitioners covered by the order dated 06.04.2011 (with reference to W.P. No. 2354 of 1996, W. P. No. 615 of 2000, W. P. No. 2027 of 2000 and W. P. No. 2007 of 2004). Such authority will also afford a reasonable opportunity of hearing to the writ petitioners of W. P. No. 1654 of 2010. In such hearing, the writ petitioners are at liberty to be represented by their authorised representatives. The authorities will decide on the pay fixation in accordance with law after affording an opportunity of hearing to the writ petitioners herein.

2. In compliance with the aforesaid order of the Hon'ble Court, Chairman, Kolkata Port Trust will give hearing to all writ petitioners of the aforesaid five writ petitions, at 1500 hrs. on 30.03.2017, at his office chamber at 15, Strand Road, Kolkata – 700 001.

3. Accordingly, all writ petitioners of the aforesaid five writ petitions are requested to make it convenient to attend the said hearing either in person or through his/her authorised representative.

4. Efforts are being taken to intimate the writ petitioners personally. However, in absence of current postal addresses of all writ petitioners, it may not be possible to contact all of them individually. In view of this, it has been decided to hoist this notice in the website of Kolkata Port Trust for information of all concerned.
