

The instant proceedings No. 1565, 1565/R and 1565/D of 2017 arise out of the application bearing No. Lnd. 3/30/16/958 dated 09.06.2016 filed by Syama Prasad Mookerjee Port, Kolkata (erstwhile Kolkata Port Trust / KoPT), hereinafter referred to as SMP, Kolkata, the applicant herein, under the provisions of the Public Premises (Eviction of Unauthorised Occupants) Act, 1971 (hereinafter referred to as 'the Act') praying for an order of eviction and recovery of rental dues, compensation/mesne profit/ damages etc. along with accrued interest in respect of the public premises as defined under Schedule- 'A' of said application dated 09.06.2016, against M/s Eastern Tube Stores, (hereinafter referred to as the Opposite Party/ O.P.).

The case of SMP, Kolkata against the O.P. is that the O.P. came into occupation of the port property of Godown space and Durwan Goomty on the ground floor of Armeinian Ghat Warehouse (under Plate Nos. A-4/2 and A-4/3), morefully described in the Schedule 'A' of the SMP, Kolkata's application dated 09.06.2016, on a month to month Licence. It is further the case of SMP, Kolkata that the O.P has defaulted in payment of monthly rent and taxes with the accrued interest thereon, has unauthorisedly parted with the possession of the premises to the rank outsiders, has erected unauthorized construction upon the premises and has unauthorisedly encroached upon SMP, Kolkata's land measuring about 28.563 sqm in gross violation of the terms and conditions of the Licence. It is further the case of SMP, Kolkata that the tenancy with the O.P. was determined w.e.f. 31.01.2015 in terms of the Notice to Quit dated 12.12.2014 and the O.P. failed and neglected to vacate/ hand over the possession of the premises after service of the said Notice to Quit. SMP, Kolkata has made out a case that O.P. has no right to occupy the premises after the determination of the licence in question upon service of a quit notice dated 12.12.2014.

This Forum of Law formed its opinion to proceed against O.P. and issued 3 (three) no. of Show Cause Notices upon the O.P., one u/s 4

However, the effort remained futile, as in terms of the Process Server Report dated 21.10.2021 the O.P. has "refused" to receive the Order. Neither the O.P. nor anyone interested in the property made a contact or approached the Forum in connection with the Show Cause Notice issued by this Forum. Then a decision was taken to publish a notice in a widely circulated newspaper for a notice to all concerned about the pendency of the instant proceeding, in order to provide an opportunity to the O.P. to appear before this Forum and to represent their case. 
