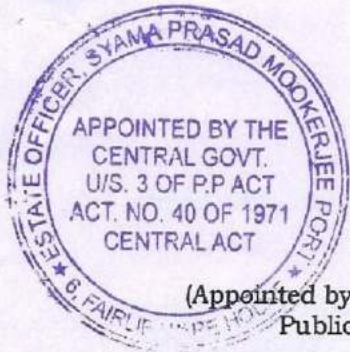

in unauthorized occupation of the Public Premises specified in the Schedule below:

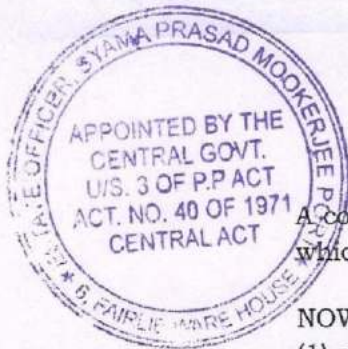
#### REASONS

- 1) That O.P. has failed to appear before this Forum and failed to file reply to the Show Cause Notice/s under the Act inspite of sufficient chances being given.
- 2) That the notice to quit dated 12.12.2014 as served upon the O.P. by the Port Authority is valid, lawful and binding upon the parties and O.P's occupation, and that of any other occupant of the premises, has become unauthorised in view of Section 2(g) of the P.P Act.
- 3) That O.P. has violated the conditions of month to month Licence, as granted by the Port Authority, by way of not making payment of rent and taxes to the Port Authority.
- 4) That O.P. has violated the conditions of tenancy under month to month Licence, as granted by the Port Authority by way of unauthorised construction, unauthorised parting of possession to rank outsiders and encroachment upon SMP, Kolkata's land measuring about 28.563 sqm.
- 5) That O.P./any other person on behalf of O.P. have failed to make out any case in support of its occupation as "authorised occupation", inspite of sufficient chances being given.
- 6) That O.P. or any other person/s asserting any right through O.P. has failed to bear any witness or adduce any evidence in support of its occupation as "authorised occupation", inspite of sufficient chances being provided.
- 7) That O.P. is liable to pay compensation/ mesne profit/ damages for wrongful use and occupation of the Public Premises upto the date of handing over of clear, vacant and unencumbered possession to the Port Authority.

## FINAL ORDER

The instant proceedings No. 1565, 1565/R and 1565/D of 2017 arise out of the application bearing No. Lnd. 3/30/16/958 dated 09.06.2016 filed by **Syama Prasad Mookerjee Port, Kolkata** (erstwhile Kolkata Port Trust / KoPT), hereinafter referred to as **SMP, Kolkata**, the applicant herein, under the provisions of the **Public Premises (Eviction of Unauthorised Occupants) Act, 1971** (hereinafter referred to as 'the Act') praying for an order of eviction and recovery of rental dues, compensation/mesne profit/damages etc. along with accrued interest in respect of the public premises as defined under Schedule- 'A' of said application dated 09.06.2016, against **M/s Eastern Tube Stores**, (hereinafter referred to as the **Opposite Party/ O.P.**).

The case of SMP, Kolkata against the O.P. is that the O.P. came into occupation of the port property of Godown space and Durwan Goomty on the ground floor of Armeinian Ghat Warehouse (under Plate Nos. A-4/2 and A-4/3), morefully described in the Schedule 'A' of the SMP, Kolkata's application dated 09.06.2016, on a month to month Licence. It is further the case of SMP, Kolkata that the O.P. has defaulted in payment of monthly rent and taxes with the accrued interest thereon, has unauthorisedly parted with the possession of the premises to the rank outsiders, has erected unauthorized construction upon the premises and has unauthorisedly encroached upon SMP, Kolkata's land measuring about 28.563 sqm in gross violation of the terms and conditions of the Licence. It is further the case of SMP, Kolkata that the tenancy with the O.P. was determined w.e.f. 31.01.2015 in terms of the Notice to Quit dated 12.12.2014 and the O.P. failed and neglected to vacate/ hand over the possession of the premises after service of the said Notice to Quit. SMP, Kolkata has made out a case that O.P. has no right to occupy the premises after the determination of the licence in question upon service of a quit notice dated 12.12.2014.

This Forum of Law formed its opinion to proceed against O.P. and issued 3 (three) no. of Show Cause Notices upon the O.P., one u/s 4

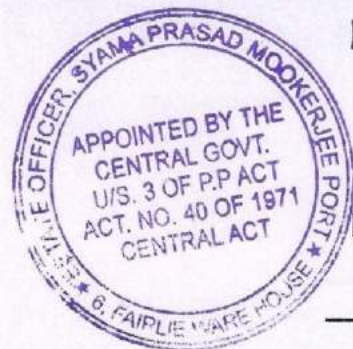

of the Act (for adjudication of the prayer of eviction) and the other two u/s 7 of the Act (for adjudication on the prayer of unpaid rent as well as unpaid compensation dues/ damages/ mesne profit alongwith the accrued interest thereon etc.), all dated 16.05.2017 (vide Order No. 01 dated 15.05.2017) as per the Rules made under the Act.

The said Notices were sent through 'Speed Post' to the recorded addresses of O.P., viz., at '18, Raja Woodmunt Street, Kolkata- 700 001'. However, the notice has been returned undelivered by the Postal Department with the remarks "Moved". Be that as it may, the 'Process Server' attached with this Forum has submitted the Report dated 18.05.2017 stating that the Notices have been served upon the O.P., personally on 18.05.2017. Such Notice was affixed in the property under schedule for a notice to all concerned, as per the mandate of the Act. It appears from the records that thereafter the matter went out of list, perhaps due to superannuation from service of my erstwhile Estate Officer, until 23.09.2021, when the matter was taken up by the undersigned for the first time. Following the principles of natural justice that no one should be condemned unheard ('Audi Alteram Partem'), the Department of the undersigned was directed to serve the Order/s upon the O.P. for their information about the pendency of the proceeding and to provide them with a chance to represent their case. However, the effort remained futile, as in terms of the Process Server Report dated 21.10.2021 the O.P. has "refused" to receive the Order. Neither the O.P. nor anyone interested in the property made a contact or approached the Forum in connection with the Show Cause Notice issued by this Forum. Then a decision was taken to publish a notice in a widely circulated newspaper for a notice to all concerned about the pendency of the instant proceeding, in order to provide an opportunity to the O.P. to appear before this Forum and to represent their case. Such a notice was published in 'The Times of India (Kolkata edition)' on 24.11.2021 fixing the date for the O.P's appearance, filing reply to Show Cause on 13.12.2021, but such effort too went in vain, as none appeared from O.P's side and the efforts remained ineffective. attendance of O.P. could not be procured by this Forum, at any point of time, inspite of the possible efforts being made, even after the publication of a Notice in an English daily and even thereafter, I am inclined to proceed ex-parte against the O.P. I may say that I have nothing to disbelieve the allegations levelled against the O.P. from the documents filed by the Port Authority and I am left with no other alternative but to issue the Order of Eviction against O.P., as prayed for on behalf of SMP, Kolkata, on the following grounds/reasons:-

6) That O.P. or any other person/s asserting any right through O.P. has failed to bear any witness or adduce any evidence in support of its occupation as "authorised occupation", inspite of sufficient chances being provided.

7) That O.P. is liable to pay compensation/ mesne profit/ damages for wrongful use and occupation of the Public Premises upto the date of handing over of clear, vacant and unencumbered possession to the Port Authority.

ACCORDINGLY, I sign the formal order of eviction u/s. 5 of the Act as per Rule made there-under, giving 15 days' time to O.P., and any person/s whoever may be in occupation, to vacate the premises. I make it clear that all person/s, whoever may be in occupation, are liable to be evicted by this order and the Port Authority is entitled to claim damages for unauthorized use and enjoyment of the property against O.P., in accordance with the canons of Law till the date of unencumbered recovery of possession of the same.

SMP, Kolkata is directed to submit a comprehensive status report of the Public Premises in question on inspection of the property after expiry of the 15 days as aforesaid, so that necessary action can be taken for execution of the order of eviction u/s 5 of the Act, as per Rule made under the Act.

It is my considered view that a sum of Rs. 46,61,051.98/- ( Rupees Forty Six Lakhs Sixty One Thousand fifty One and paise Ninety Eight only) for the period from 01.09.1998 upto 31.01.2015 is due and recoverable from O.P. by Port Authority on account of rental dues and O.P. must have to pay the rental dues to SMP, Kolkata on or before 04.03.2022. Such dues shall attract compound interest @ 6.20 % per annum, which is the current rate of interest as per the Interest Act, 1978 (as gathered from the official website of the State Bank of India) from the date of incurrance of liability, till the liquidation of the same, as per the adjustment of payments, if any made so far by O.P., in terms of SMP, Kolkata's books of accounts.

I sign the formal Orders u/s 7 of the Act.

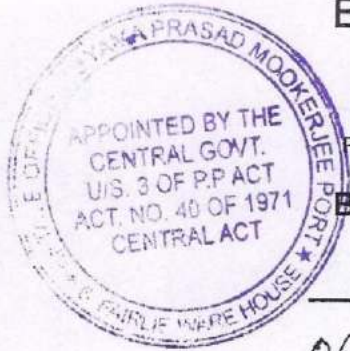


