Matter is taken up on requisitioned from the Department. Perused SMPK's application bearing no. Lnd. 3296/1/IV/2/651 dated 08.03.2022 furnishing the address of the concerned Collectorate for the realisation of the adjudged dues against Ashim Kumar Ganguly, Ashok Kumar Ganguly, Smt. Durga Rani Devi.

It is seen from the records that an application dated 09.03.2022 has been filed by O.P. stating that an amount of Rs. 6,32,049/- can be tendered on behalf of O.P. against the total dues as adjudicated by this Forum vide order dated 10.12.2021. However after carefully evaluating the present situation I am of the opinion that the prayer of O.P. cannot be granted considering the huge outstanding dues payable by O.P.

Hence, I sign the Certificate u/s 14 of the Public Premises (Eviction of Unauthorised Occupants) Act, 1971 today. Department is directed to serve certified copy of this Order as well as the Certificate (in FORM- I) issued under the provisions of Section 14 of the Act upon the Collector being **Learned District Magistrate & District Collector of South 24 Parganas** having office at 12, **Biplabi Kanai Bhattacharya Sarani, New Admn. Building, Certificate Section, 1<sup>st</sup> Floor, Alipore, Kolkata - 700 027** through 'Speed Post/Registered Post'.

Department is also directed to serve certified copy of this Order and a copy of the Certificate (in FORM- I) upon the Estate Manager, SMPK, who is directed to pursue the matter with the said Collectorate for realisation of damages of SMPK amounting to Rs.25,49,313/- for Plate No. D-225/1 and Rs. 25,58,025/- for Plate No. SF-100/80 as adjudicated upon by this Forum of Law in accordance with law vide Order no. 32 dated 10.12.2021 from Ashim Kumar Ganguly, Ashok Kumar Ganguly, Smt.
