

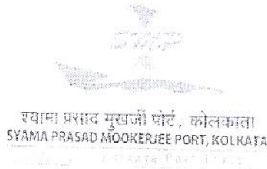

Sub: Waiver for rail borne export load containers.

In terms of the decision taken by the Competent Authority, SMPK, for all KDS bound rail borne export load containers a/c Aluminum Exporters, 50% discount on Local Haulage & 10% discount on Box Rate charges will be given initially for a period of 3 months with effect from 15.09.2022 to 14.12.2022 subject to handling of a minimum of 5 rakes (90 TEUs per rake) per month. The above discount will be further extended for another 3 months i.e, from 15.12.2022 to 14.03.2023 subject to handling of a minimum of 6 rakes (90 TEUs per rake) per month for the extended period of discount.

For the above purpose, a Bank Guarantee (BG) equivalent to discounted amount of Local Haulage Charge and Box Rate for 5/6 rakes (450/540 TEUs, whichever is applicable) shall be required to be submitted to SMPK by the concerned Exporter. This BG will act as Security Deposit against the discounted rates and can be encashed to supplement the charges in case of non-fulfillment of the committed volume by the Exporter. The BG shall have a claim validity period of six months after the date of its expiry.
