- (v) Works as described against SI. Nos. (i) & (ii) shall have to be carried out regularly and works as described against SI. Nos. (iii) and (iv) shall have to be carried out within a notice of 24(Twenty four) hours.

- b) The Contractor shall at all time carry out work in a manner creating least interference to existing occupants / services while consistent with the satisfactory execution of the same.
