- 2. Following conditions mentioned below is also the part of Tender Documents.
- a. Scope of work, clause no. 1(a)(i) mentioned at page-6 of reference NIT to be read as follows:

"Supply, Delivery & installation and 4 years Post Warranty Comprehensive Annual Maintenance Contract (CAMC) of 71 nos. of Industrial Laptops for use of Marine Department of Kolkata Dock System, SMP Kolkata as per the specification mentioned below under the technical specification clause. The laptops will be procured under '<u>Buy</u> <u>Back Option</u>' of 74 nos. of old Dell make laptops having model no. LATITUDE 7275 with windows 8.1 which were procured in August 2016."

b. Scope of work, clause no. 1(b)(i) mentioned at page-6 of reference NIT to be read as follows:

"Supply, Delivery, Testing & Commissioning and 4 years Post Warranty Comprehensive Annual Maintenance Contract (CAMC) of 71 nos. of AIS WiFi Pilot Plug & standalone wired GPS with automatic polarity detector and corrector for interfacing with shipborne AIS Transponder."

c. Following is also the part of payment terms mentioned in clause 32 of NIT at Page-12

Payment Terms for CAMC: CAMC payment will be made by Marine Department of SMP, Kolkata on completion of each year after observing the performance.

- d. The quoted CAMC value in BOQ for all tendered items will also be considered for evaluation.
- e. (i) Price for laptop to be quoted online at Sheet-1 enclosed under Cover-2 (Financial Bid)
 (ii) Price for Wifi Pilot Plug and standalone wired GPS to be quoted online at Sheet-2 enclosed under Cover- 2 (financial Bid).

f. Conditions of CAMC:

(i) <u>AIS WiFi Pilot Plug & standalone wired GPS:</u>

- (a) Maintenance of the equipment in totality for its operation during the guaranteed operational life (min. 1 year warranty plus CAMC for 4 years)
- (b) Guaranteed availability of technical support.
- (c) Repair with supply of spare parts and consumables and replacement, if required.
- (d) Prompt maintenance viz. for attending and rectifying the equipment within 3 (three) working days from the reporting of the fault.
- (e) Imposition of penalty will be made if the fault is not rectified within 3 (three) working days from the reporting of fault, @ ½% of the total value of CAMC for the year for every day or part thereof, subject to a maximum of 10% of total value of CAMC for the year for non-restoration of the fault.

(ii) For item laptops:

(a) The new laptops to be supplied will be covered under min. 1 year on-site warranty period followed by CAMC (on-site) of 4 years.

(b) Any minor defects like RAM/ROM/DVD drive/ key board etc. should be repaired/ replaced within a period of 6-8 hrs, from the time of call logging.

(c) Any major repair like replacement of LED panel, SSD, mother board should be replaced/repaired within 24 hrs. From the time of call logging.

(d) I the firm fails to repair the laptops within the scheduled time period during the contract period, penalty @ Rs. 1000/- per laptop per day or part of a day will be imposed till the time the laptop is repaired. The amount will be deducted from the CAMC charges.
