SEALED TENDERS are invited from bonafide contractors/agencies for the above work in accordance with the schedule of quantities as specified in this tender and in accordance with the special conditions of contract. **The provisions as made in the Trustees' General Conditions of Contract shall prevail in addition to the special conditions of contract attached to the subject tender.**

ANY CLARIFICATION with regard to interpretation or ambiguities discovered or pointed out after the issue of the tender documents but prior to the receipt of tenders as to the meaning, conditions or instructions contained in any of the issued documents, shall be valid only when such a clarification is made by the officer issuing tenders in writing. Any such written clarification or amendment shall be distributed to each intending tenderer who shall acknowledge receipt thereof by signing and returning to the issuing office the prescribed form prepared and distributed with the clarification or amendment.

EARNEST MONEY deposit of Rs **14,400.00 (Rupees fourteen thousand four hundred only)** must accompany each tender. SPECIAL CONDITIONS OF CONTRACT

1. Terms of payment:

- 1.1 Bidder should mention the rate/charge against each equipment in the price bid only i.e schedule of rate and bill of quantities (page reference 14 to 18) which will be valid for a period two years without any escalation
- 1.2 **Price:** The details of Tax elements like Service Tax etc. must be mentioned separately in the price bid. Quoted price should be valid for a period of Two years.
- 1.3 Service tax will be paid extra as applicable
- 1.4 **Payment** for the Annual Maintenance Contract shall be made to the contractor every year in two installments of 50% after expiry of every six months and subject to satisfactory performance by the contractor. The contractor shall obtain certificate from the office of the Medical Superintendent ,Medical Division, Haldia Dock complex, against successful Annual Maintenance and calibration of each equipment and place the same along with bill.
- 1.5 **Payment** regarding replacement of spare parts for all equipments under Non – comprehensive bi – ennial contract , the 100% cost of spare parts will be reimbursed subject to production of original/certified bills/voucher from the manufacturer/suppliers and acceptance of the Hospital authority.
- 1.6 **100% Payment** for Calibration of the equipments shall be made to the contractor within 30 days from the date of submission of valid calibration certificate and subject to acceptance of the Hospital authority and fulfillment of tender clause No.6.1
- 2 **Security Deposit** :
The successful bidder shall have to deposit security amount equivalent to 10% of the total contract value by cash/ draft/bank guarantee. Security Deposit will be released at the end of the contract period. In case Security Deposit is submitted by Bank Guarantee, the Bank Guarantee should be valid for a period of 25(twenty five) months since the contract is for two years.
- 3 **Compensation** :
The Trustees may without prejudice to any other method of recovery, deduct the amount of such damages from any amount which is due or which may become due to the contract. The payment or, deduction of such damages shall not relieve the bidder from his obligations to complete any other liabilities and obligations under the contract.

4. **Termination of Contract:**
- 4.1 If the tenderer fails to carry out the contract as per the agreed terms and conditions and/or fails to attend to the problem in the system within the stipulated period as provided for in the contract without any valid reason acceptable to the Medical Superintendent, Medical Division, Haldia Dock Complex, the latter may cancel the order and his decision in the matter shall be final and binding on the tenderer.
- 4.2 Upon cancellation of the order for the reason indicated at Clause 4.1, the Medical Superintendent, Medical Division, Haldia Dock Complex shall be entitled to get the work done at the risk and expense of the party on whom the order has been placed, through an independent agency and to recover from the party, in addition to any other amount, compensation for damages that the Trustees are entitled to in terms of other relevant Clauses in the contract.
5. **General Conditions of Contract :**
The other terms and conditions of tender will be those as stated in the "General Conditions of Contract" of Kolkata Port Trust.(available at KoPT website www.kolkataporttrust.gov.in / www.haldiadock.gov.in)
6. **TERMS & CONDITIONS FOR BI – ENNIAL MAINTENANCE,REPAIR AND CALIBRATION**
- 6.1 The Annual Maintenance Contract shall be non-comprehensive in nature. This should include routine servicing & maintenance, repairing work for breakdown & calibration of equipments. As regards replacement of spare parts for all the equipments under Annual Maintenance Contract., the cost of spare parts will be reimbursed subject to submission of proper bills from the manufacturers / suppliers / firms duly certified by the tenderer.

- 6.2 Tenderer must mention how many preventive maintenance/check up shall be done annually. At least four (4) preventive maintenance in a year for life saving equipments like Anaesthetic Machine, Ventilator, and Cardiac Monitors will have to be done. In the event the preventive maintenance is not done within the scheduled time i.e, within the month as per the Preventive Maintenance Schedule, then unless extension is given by the Medical Superintendent, proportionate deduction will be made from the AMC charges (half the annual maintenance cost in case of bi-ennial PPM schedule, 1/4th of AMC cost in case of quarterly schedule etc.).
- 6.3 The break-down call must be attended within 48 hours from the time of reporting of breakdown call by FAX/email.
- 6.4 The equipments should be repaired and commissioned on the day of attending the breakdown call or within two days time thereafter. In case of major breakdown/failure, the same may be repaired /replaced within a period of 10 days without imposition any compensation if Medical Superintendent, Port Hospital feels it reasonable and justified, failing which compensation will be imposed as under :-
- In the event of failure to commission the equipment within the stipulated date or ,such extension thereof as may be allowed by the Medical Superintendent in writing, bidder shall be required to pay, as compensation to the trustees (Liquidated Damage) ,and not as penalty @ ½% for each day's delay in commissioning of the equipment (part of a day will be treated as a full day),provided always that the amount of such compensation under the provision of this clause does not exceed 10% of the respective yearly Non Comprehensive Maintenance cost of the equipment. Without prejudice to any of their legal rights, the Trustees will have the power to recover the said amount of compensation/damage from the money due or, likely to become due to the bidder. The payment or, deduction of such damages shall not relieve the bidder from his obligations to complete any other liabilities and obligations under the contract. In case of bidder's failure and at the absolute discretion of the Medical Superintendent, the work may be ordered to be completed by some other agency at the risk and expense of the bidder after a minimum of three days' notice in writing has been given to the bidder by the Medical Superintendent or his representative.

- 6.5 If any equipment is to be repaired at premises other than the Port Hospital, H.D.C. an **"Indemnity Bond"** is to be submitted before taking the equipment elsewhere. The carrying cost and cost of transportation will not be borne by H.D.C. If the equipment is not commissioned within 10 days, the contractor will have to provide a temporary replacement (serving the same purpose) as a standby arrangement till the original equipment is repaired and commissioned. If standby equipment is provided then the penalty clause will be deferred for a period of one month or more at the discretion of Medical Superintendent, else penalty will be imposed as at clause (6.4).
- 6.6 If during the contractual period, any equipment is deleted from the Bi-annual Maintenance Contract by Medical Superintendent for any reason, the Bi-annual Maintenance Contract value should be adjusted proportionately.
- 6.7 The party will have to submit the list of Service Engineers, who will be attending the Preventive services as per schedule and the break-down calls along with their qualifications so as to ascertain whether these personnel are qualified enough to handle these machines / equipments or not. In case of any change of the personnel, the same will have to be intimated in advance to Medical Superintendent, Port Hospital, Haldia Dock Complex. No person other than those enlisted will be allowed to handle the equipments.
- 6.8 The equipments which are meant for calibration as per the Bill of Quantity, will have to be calibrated providing certificates traceable to NPL, NABL at least once a year and stickers indicating the date of calibration, the period up to which it is effective, the asset number of the equipments and the name of the party performing the calibration should be stuck to the equipments every time the calibration is done. The calibration should be valid for a period of one year. The next calibration should be completed before the expiry of previous calibration.
